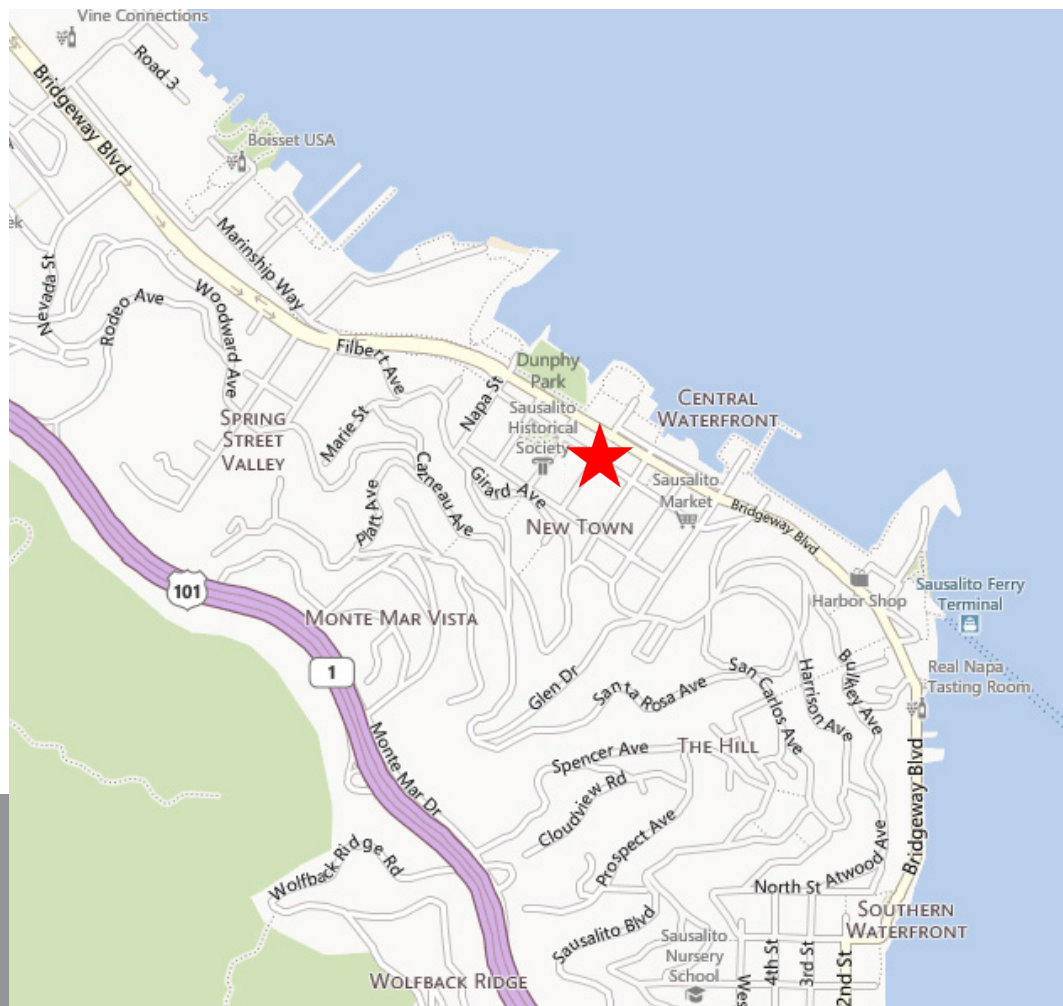
221 Caledonia Street is a few blocks from downtown Sausalito, and is adjacent to many shops and restaurants.

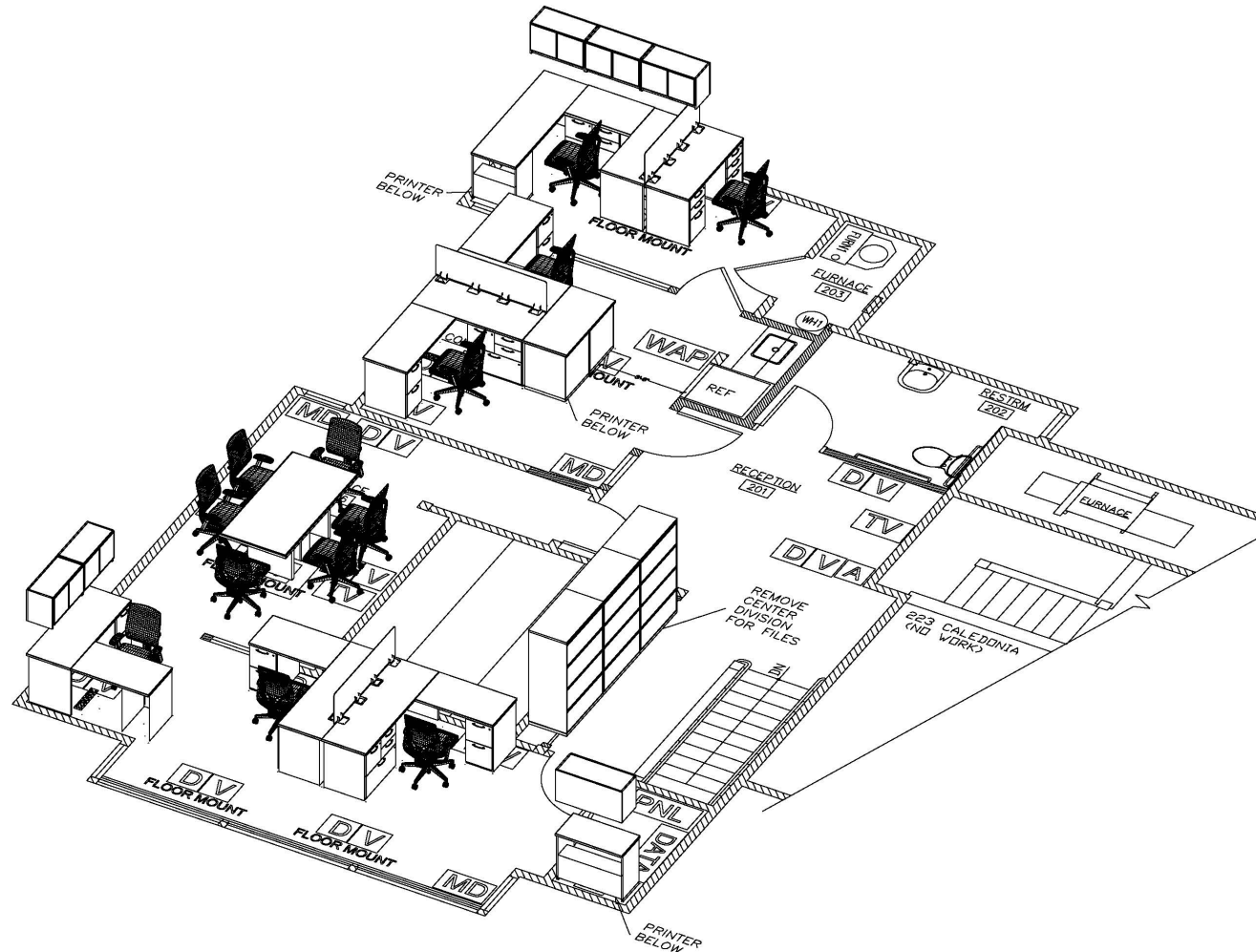
# FLOOR PLAN
