Pursuant to the Declaration monthly Common Facility Fees are adjusted for changes in the Consumer Price index ("CPI") for the twelve-month period ending each May 31st. On May 31, 2023, the CPI represented an increase of 4.0 percent from the prior year. (www.bis.gov) Effective September 1, 2023, the monthly common facility fee shall be the same as last year. Management has decided not to pass the 4.0 percent.
