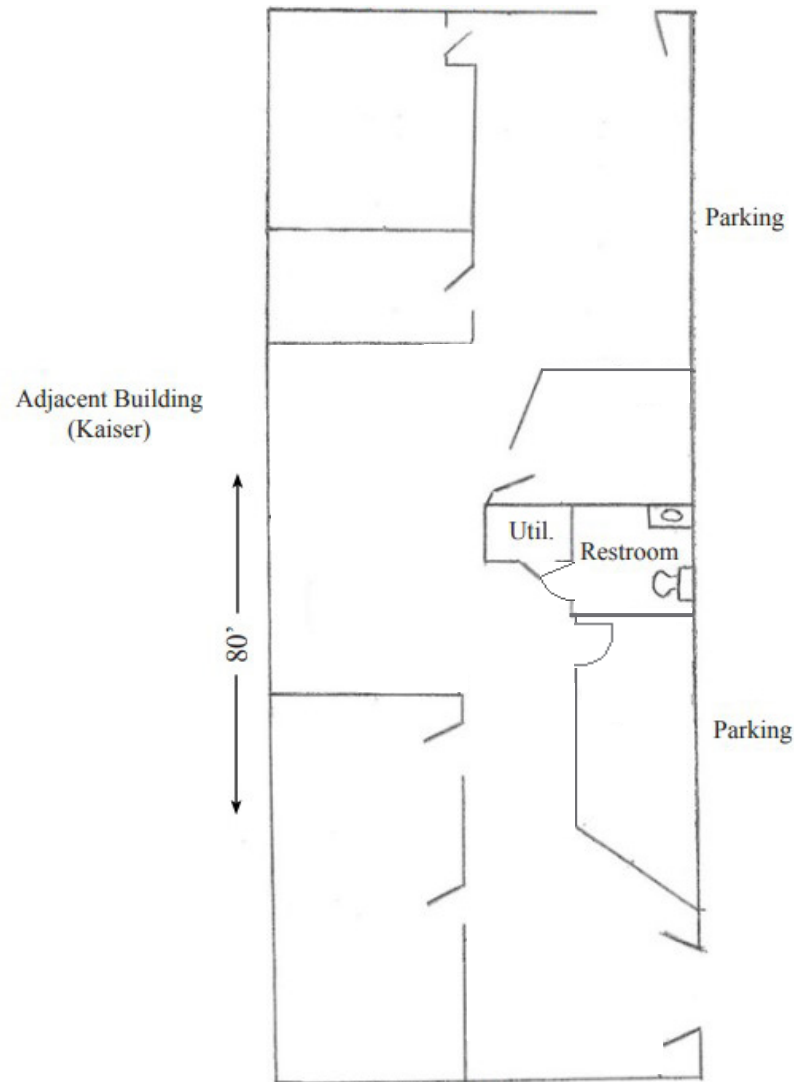
FLOOR PLAN
