Yas Chicken executed a long-term 15 -year NNN lease in 2024 and rent will commence in March of 2025. The lease features 12.5% rent escalations every 5 years and throughout its one (1), ten (10) year renewal option. Yas Chicken will be paying \$149,184 with the next escalation in March 2030. This unique offering presents an excellent opportunity to acquire a stable, completely passive investment for an investor.

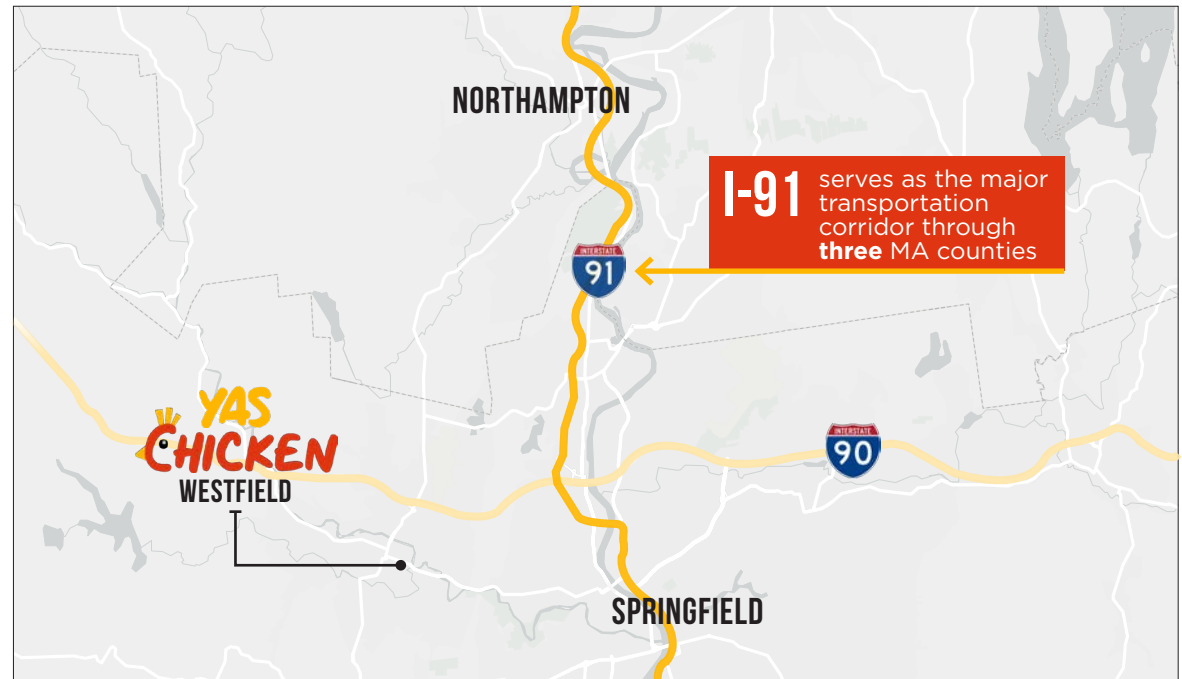
