DeSoto Memorial Hospital

Tampa General Hospital (TGH) manages DeSoto Memorial Hospital in Arcadia, Florida, under a 49-year lease agreement approved in late 2025 . As part of the transition, TGH committed to investing at least \$45 million into the rural hospital to expand services, retain existing employees, and build a helicopter station for rapid patient transfers. The DeSoto Memorial Hospital Board unanimously selected TGH's proposal after evaluating competing offers from AdventHealth and NorthStar Hospitals.

Key details of the operational takeover include:

The Deal: TGH leases the 49-bed facility for \$10 a month with an automatic 49-year renewal option.

Investment: The minimum \$45 million capital commitment is structured so that 50% of the funding will be applied within the first five years of the lease.

Community Focus: TGH aims to bring in medical specialists, improve infrastructure, and allow DeSoto County residents to receive the majority of their care locally without traveling long distances.

Leadership and Staff: TGH has committed to retaining all senior management and employees in good standing.

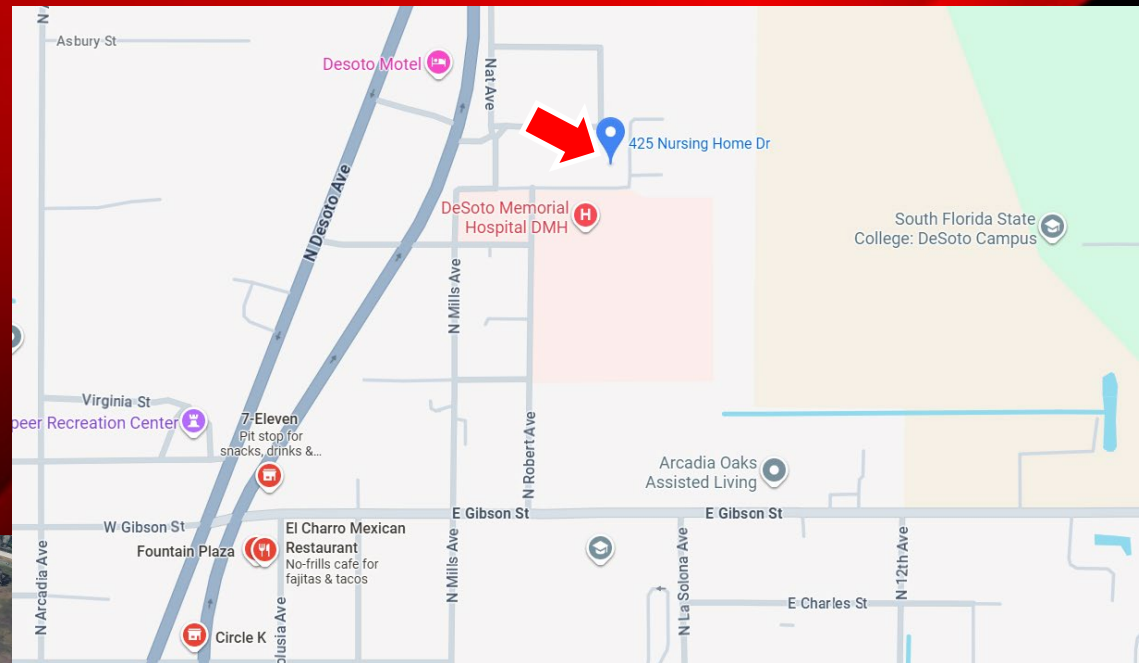
