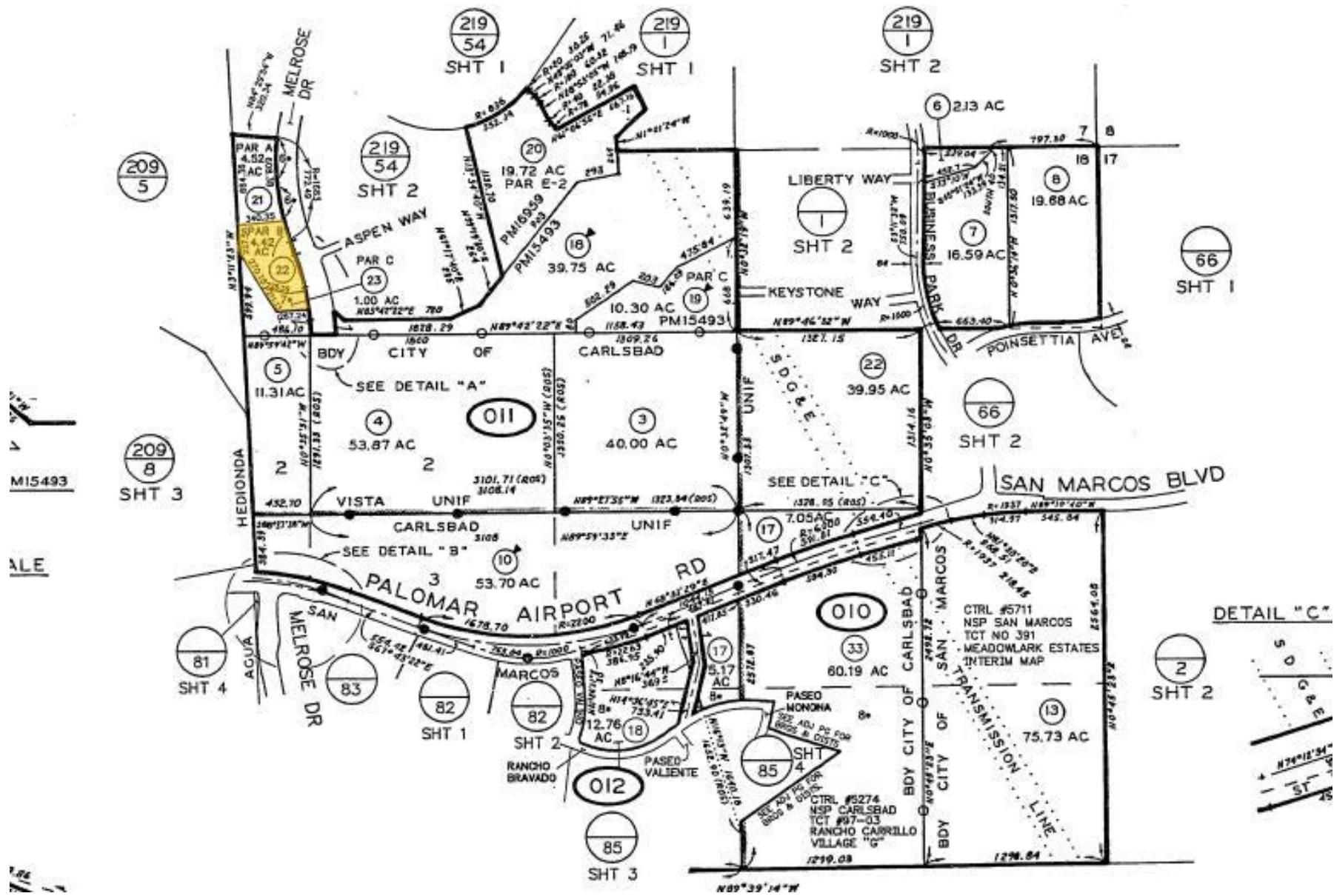

# PLAT MAP

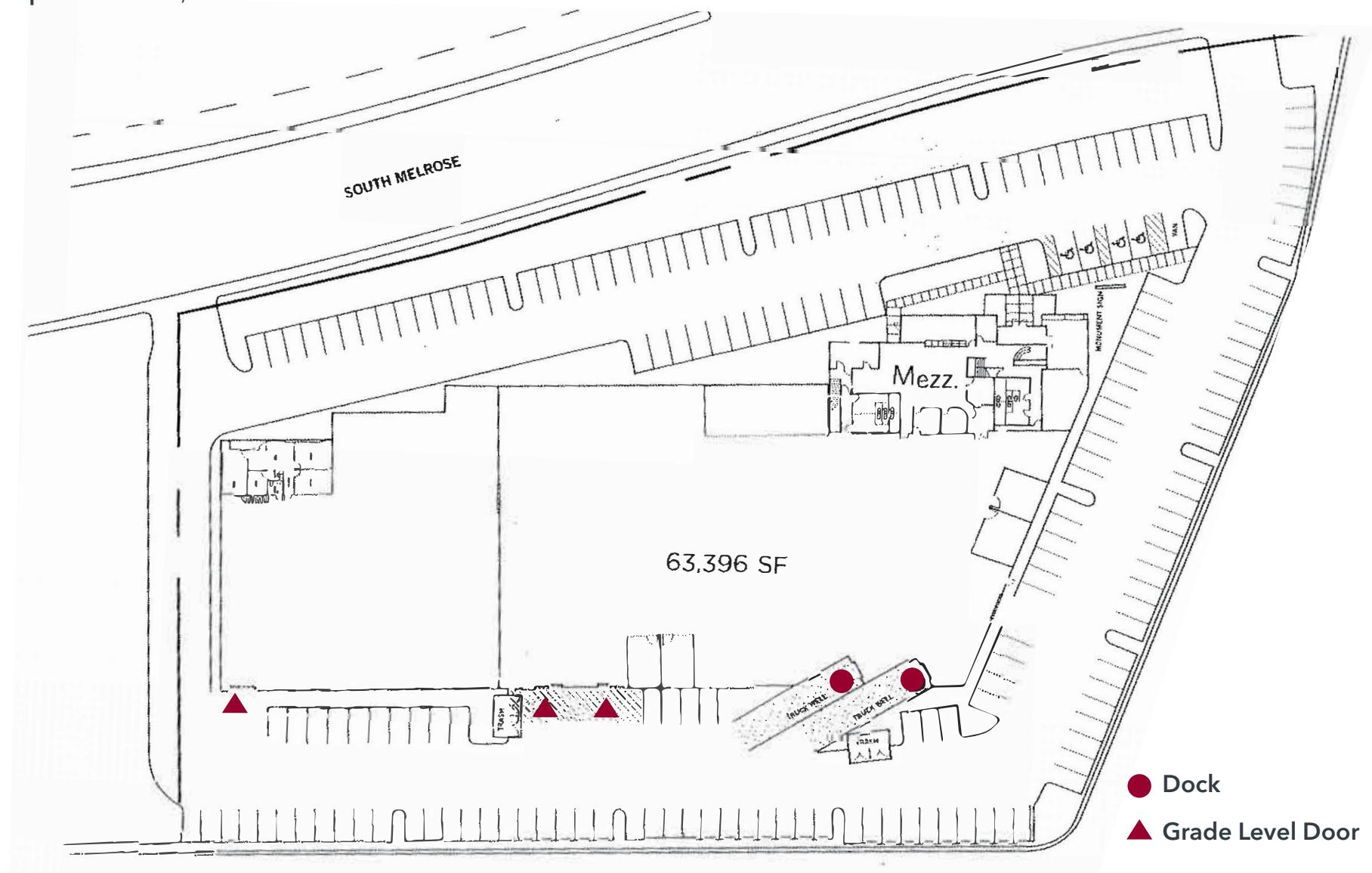

# SITE PLAN

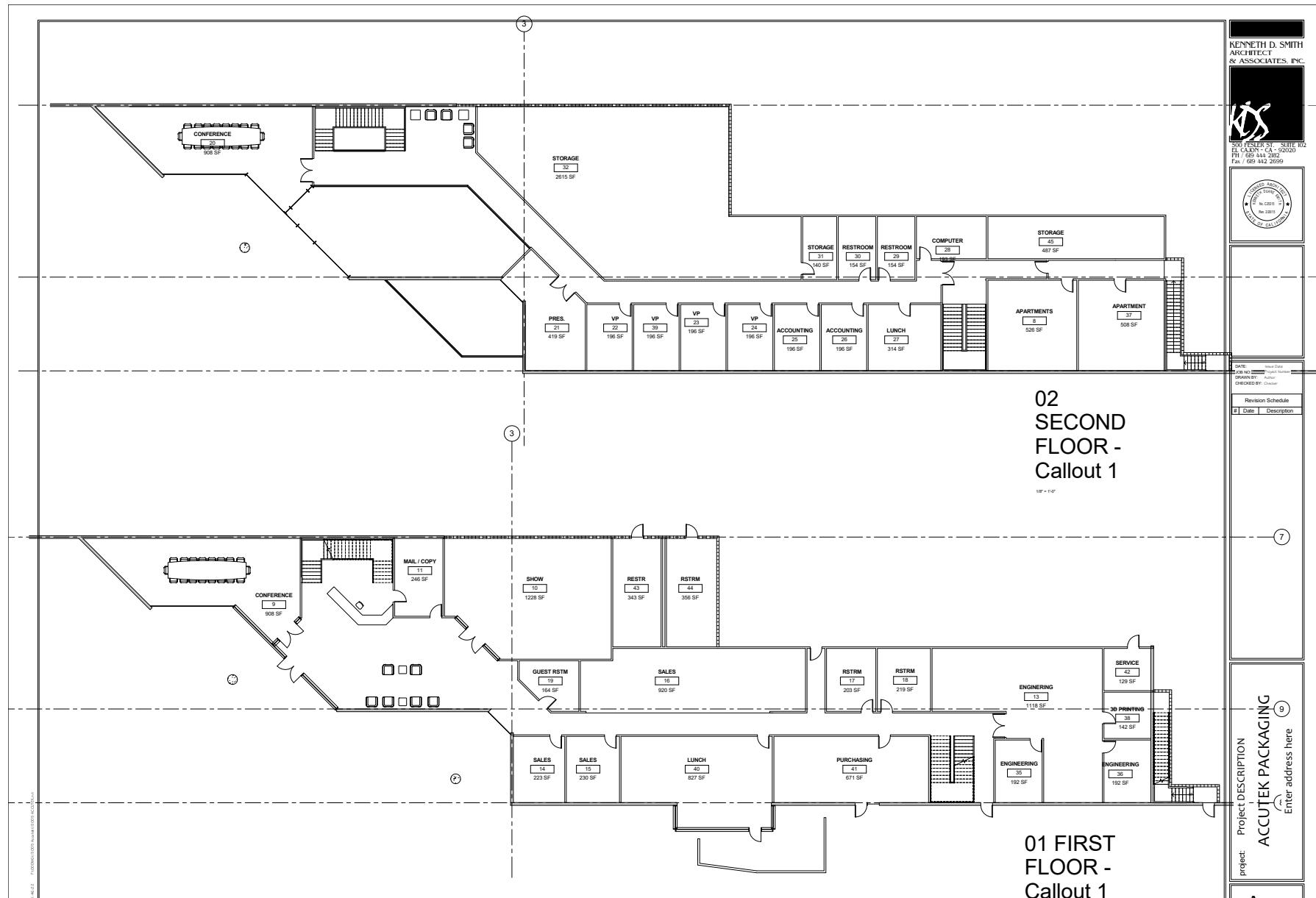

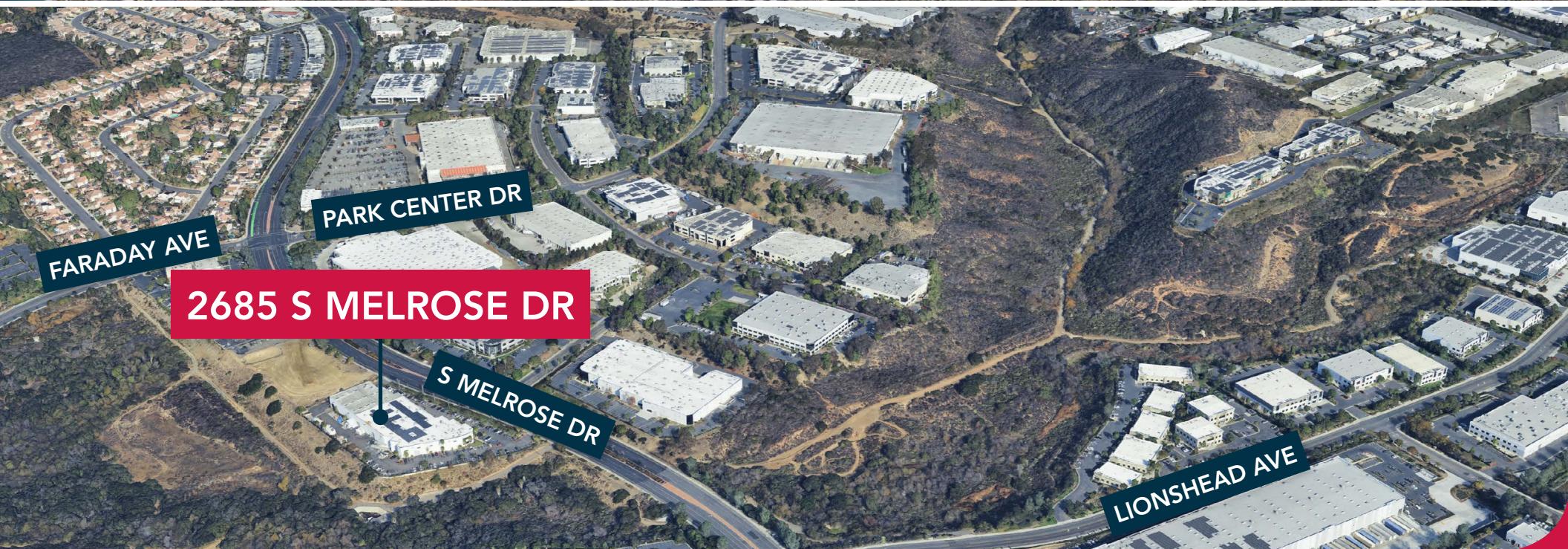
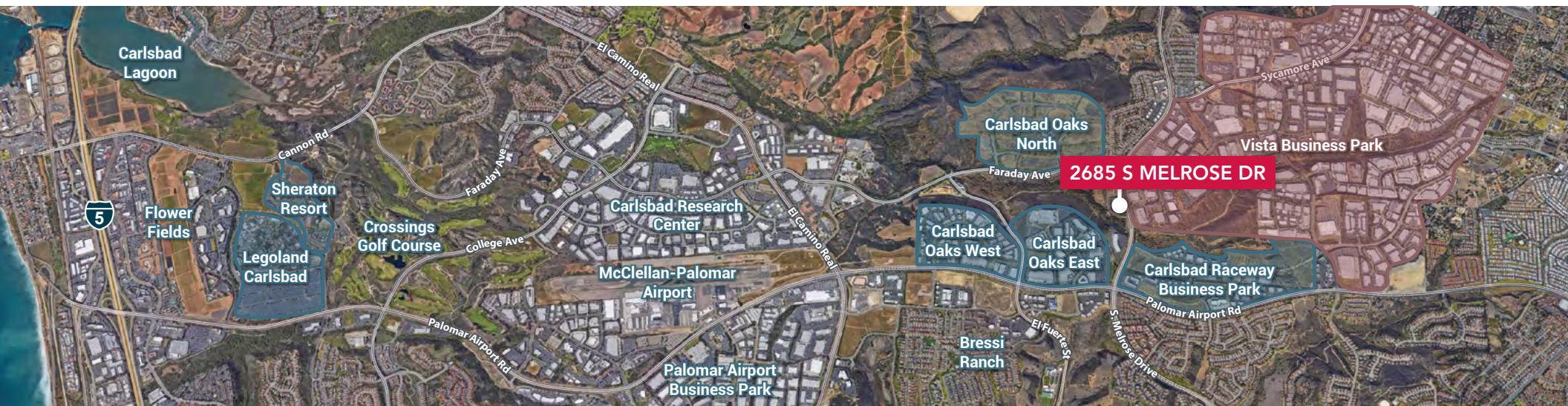
# FLOOR PLAN
