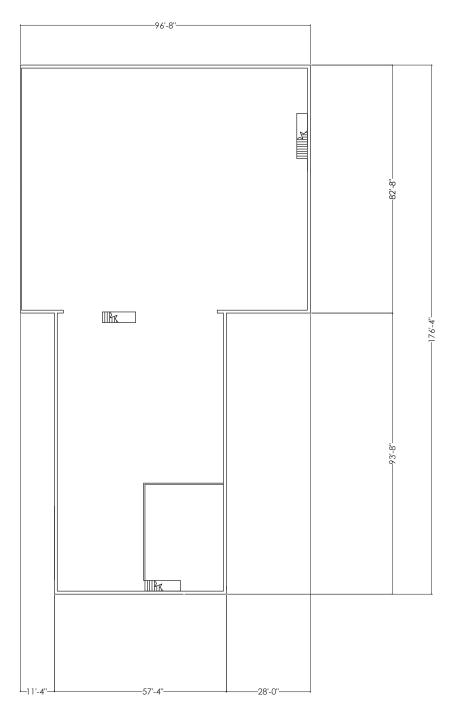

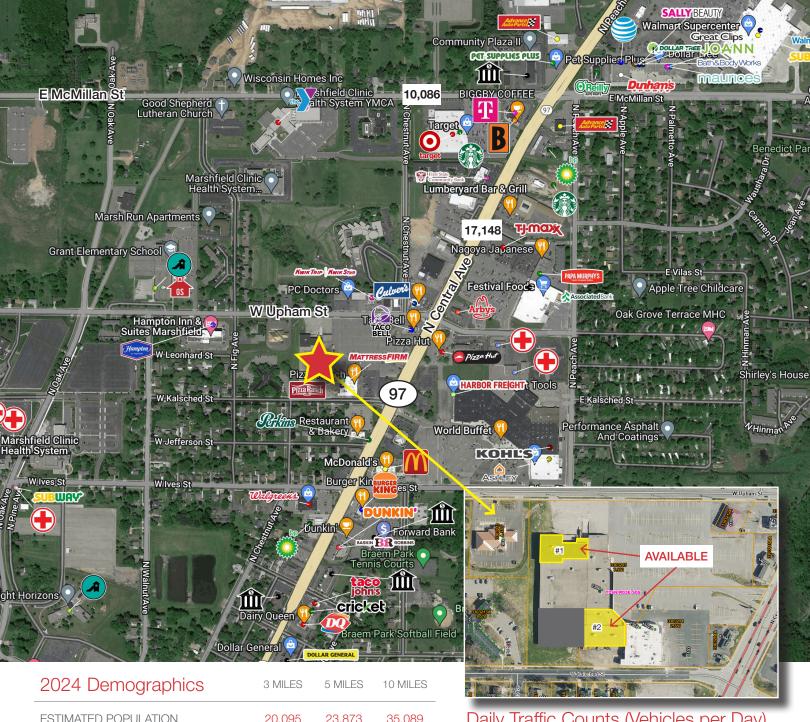
Mezzanine Floor Plan
