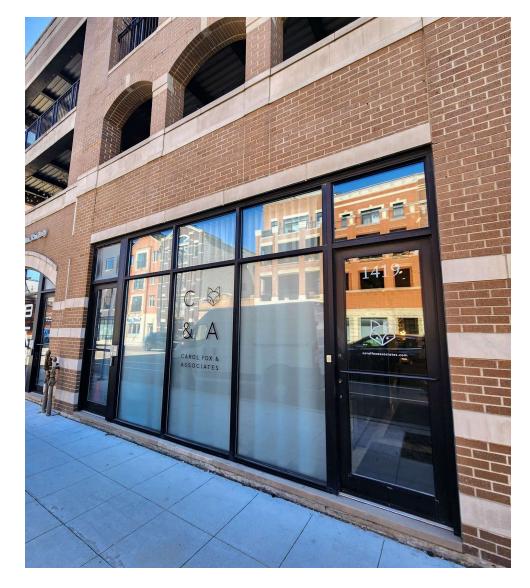

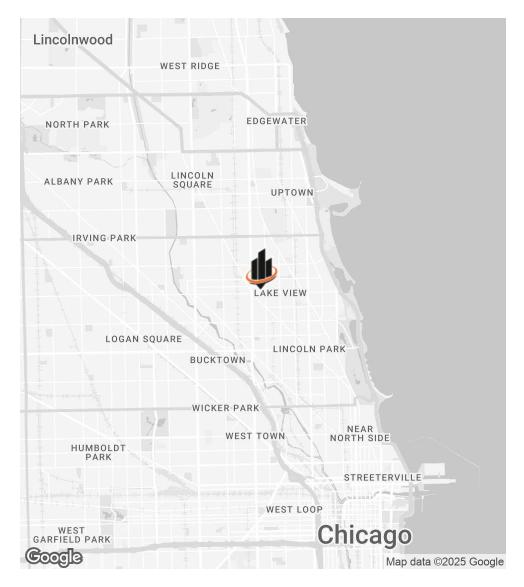

LOCATION OVERVIEW

Lakeview is bordered by Diversey Parkway on the south, Irving Park Road on the north, Ravenswood Avenue on the west, and the shore of Lake Michigan on the east. Lakeview had a population of 97,121 residents in 2024, making it one of the largest of the Chicago community areas by population. Much like Chicago in general, it is comprised of smaller neighborhood enclaves such as East Lakeview, West Lakeview, Sheridan Station Corridor, Northhalsted, Southport Corridor, and Wrigleyville. Located just minutes north of downtown, Lakeview's vibrant streets boast some of Chicago's best culture, shopping, dining, and sporting events. It's known for its Belmont Theater District, numerous outdoor festivals and farmer's markets, as well as concerts and games at Wrigley Field.

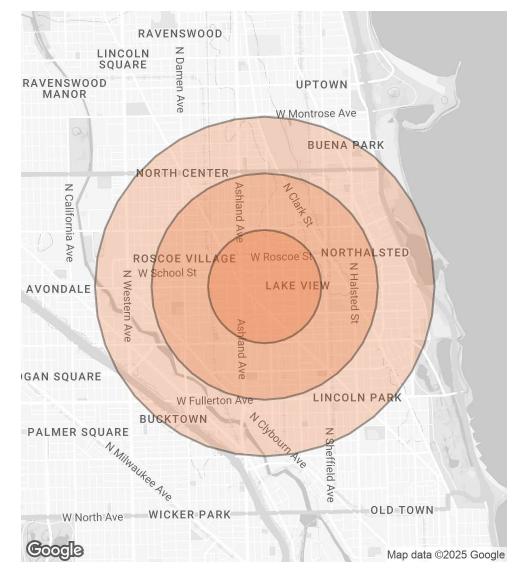
