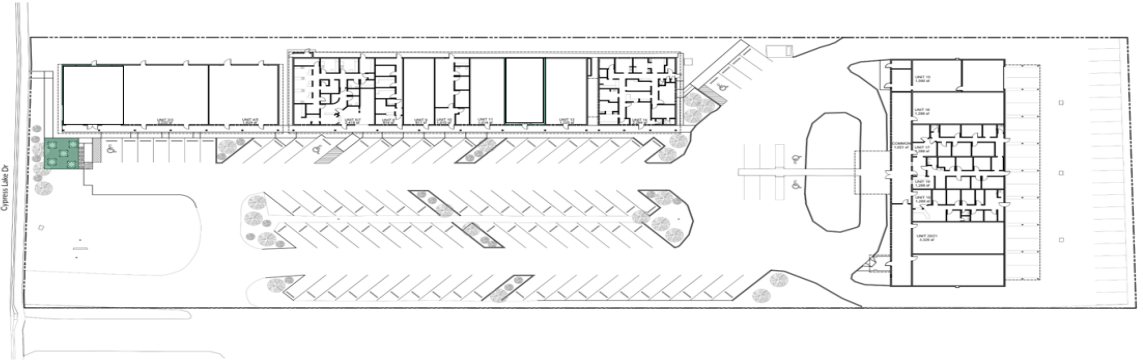

SITE PLAN

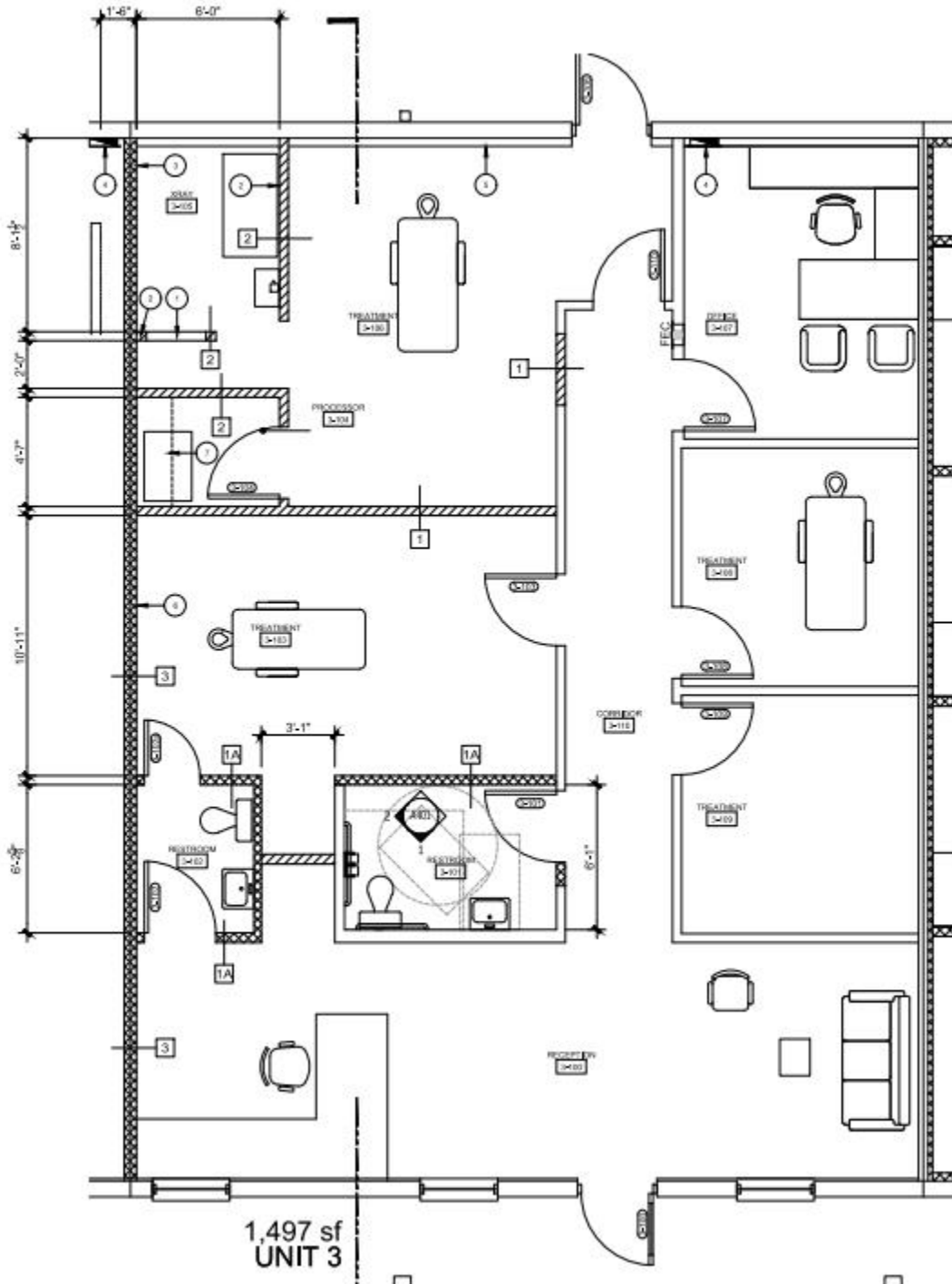
