





NORTHSHORE AMBULATORY SURGERY CENTER

Northshore Ambulatory Surgery Center (NASC) is a state-of-the-art, 5,300-square-foot outpatient surgical facility located adjacent to Northshore Eye Associates' Hammond clinic at 17170 South I-12 Service Road. Completed in 2010, the center was purpose-built to deliver efficient, high-quality surgical care in a modern, patient-focused environment. Designed with sustainability in mind, the facility incorporates non-toxic construction materials and a rainwater harvesting system to reduce environmental impact and support long-term operating efficiency.

NASC is equipped with two fully outfitted operating rooms, a six-bed pre-op and recovery suite, and advanced surgical equipment that supports a broad array of specialties. Licensed as a multispecialty center, NASC serves ophthalmology, orthopedics, ENT, plastic surgery, and pain management patients. The center holds accreditation from the Accreditation Association for Ambulatory Health Care (AAAHC), is a certified Medicare provider, and participates in most managed healthcare plans—underscoring its operational quality and broad payer accessibility.

Its adjacency to the main clinic allows for seamless coordination between diagnostic, consultative, and surgical services, enhancing patient experience and throughput. As a long-standing tenant operating in a specialized, purpose-built facility, Northshore Ambulatory Surgery Center offers excellent tenancy stability, consistent procedural volume, and alignment with long-term trends in outpatient care delivery. HOSPITAL OVERVIEW

NORTH OAKS HEALTH SYSTEM

North Oaks Health System has recently undertaken significant expansion and modernization projects that underscore its growing regional footprint and high patient demand. In late 2023, a groundbreaking was held for a new five-story, 95,000 sq. ft. outpatient clinic tower on the North Oaks Medical Center campus – a nearly \$50 million investment slated to open in 2025. This Clinic Building II will substantially increase capacity for physicians and services, providing 115 exam rooms and 12 clinics under one roof while allowing room for future growth. Key specialties are set to expand into this facility, such as cancer care (with the hematology-oncology clinic moving into an entire floor and infusion therapy expanding to 32 bays) and eye care, which are relocating to accommodate rising patient volumes. North Oaks has also added new care sites and upgrades to meet community needs.

This wave of expansion reflects North Oaks' strategic growth and its role as the region's leading healthcare provider. North Oaks is now the largest health system in the Northshore region of Louisiana, anchored by a 330-bed acute-care hospital (North Oaks Medical Center) that serves a regional population of roughly 500,000 between New Orleans and Baton Rouge.

This sustained growth and investment in cutting-edge facilities and services not only enhance patient care but also reinforce the value of nearby medical office properties like 17170 S I 12 – which stands to benefit from proximity to an expanding referral base and the increased patient traffic generated by a thriving regional medical center.
