Located at the high-visibility corner of 3722 S. Hudson St. and Rainier Ave. S., this rare offering presents a unique opportunity to acquire a historic two-story commercial building with a basement in one of Seattle's most walkable and vibrant urban districts.

Built in 1926 in the Spanish Mission style, the property originally served as Seattle Police Precinct #5 until 1960 and previously housed Columbia City's town hall. For the past three decades, it has been home to Southeast Youth and Family Services, a nonprofit serving the community since the 1970s.

Listed on the historic registry for its architectural integrity and cultural significance, the building features a well-preserved exterior that has remained virtually unchanged for nearly a century. Its character, combined with a prime location in a thriving commercial corridor, makes it an exceptional investment for both owner-users and investors.

Columbia City is celebrated for its strong community identity, rich amenities, and dynamic mix of local businesses—truly a “city within a city.” This is Seattle neighborhood vibrancy at its finest.


