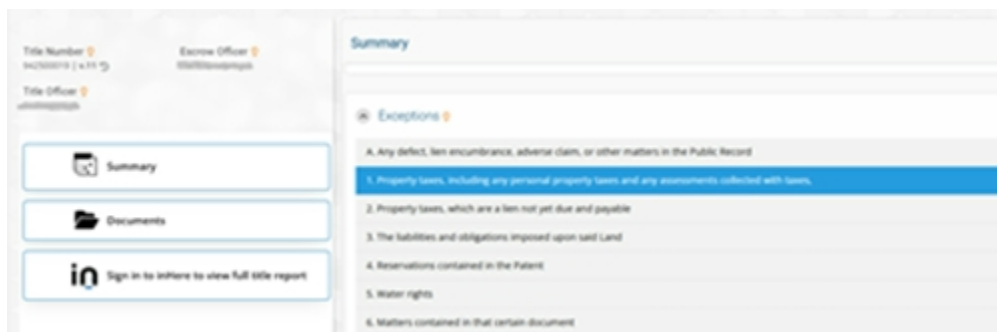

COMMITMENT CONDITIONS**1. DEFINITIONS**

- a. 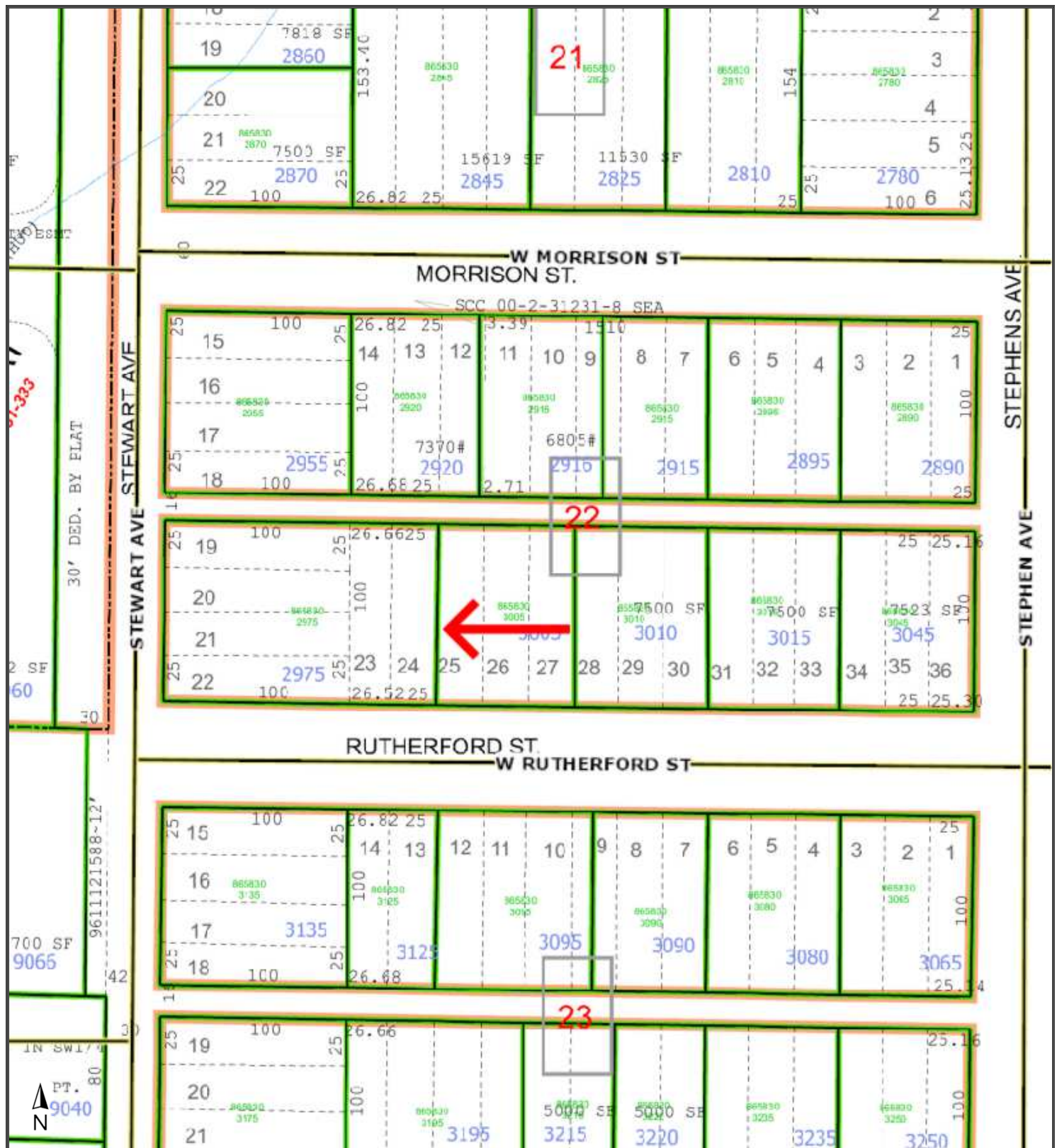
