# SITE PLAN

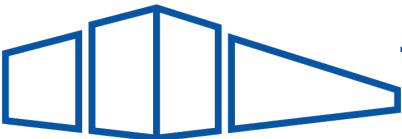
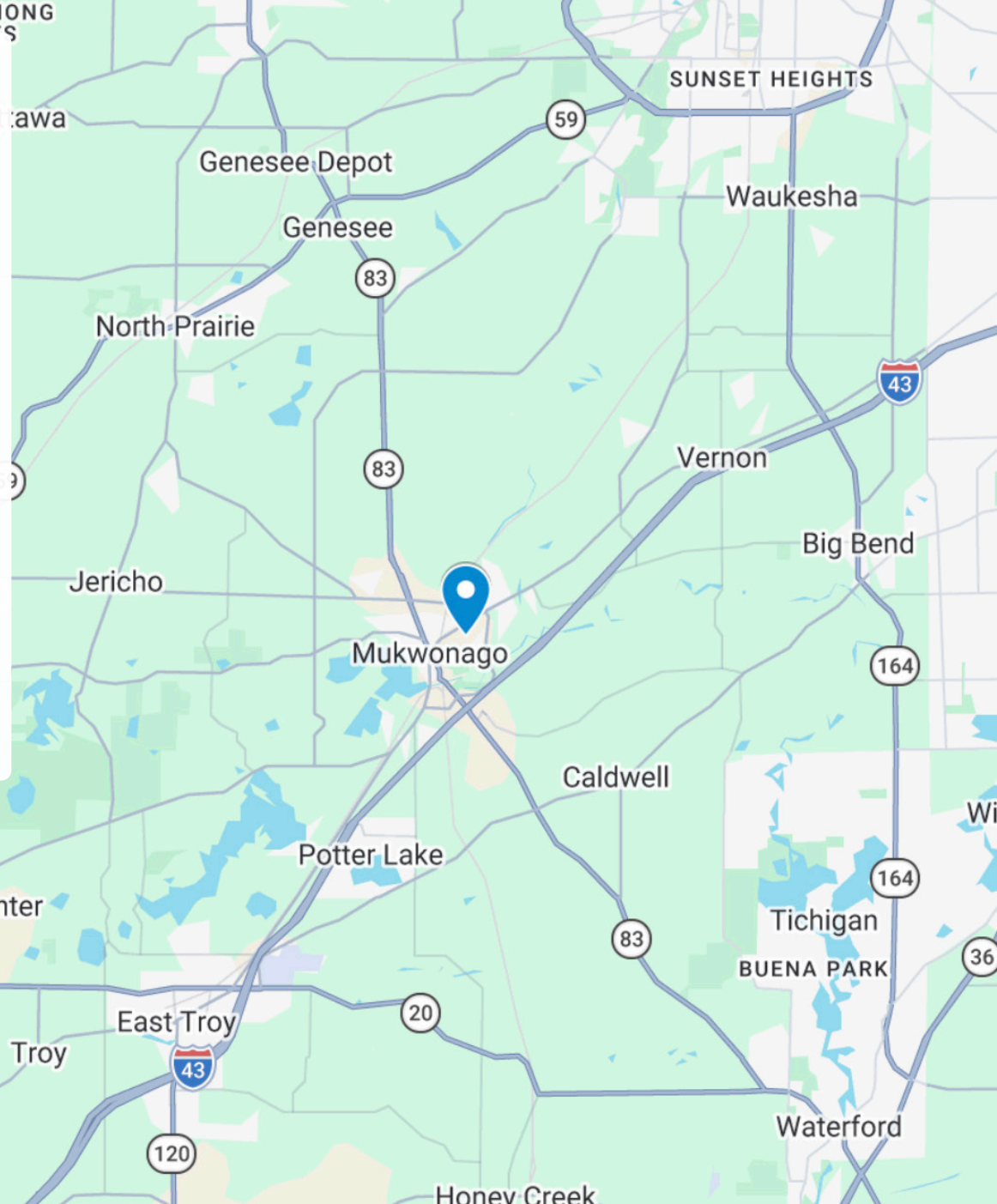
