

Sign B - One (1) set of 3' High Standard Face-lit Channel letters with White Returns, White Trim Cap, and White Faces with Red Vinyl Inlay to read" US Market", one (1) 2'-6" High Star with White Returns, White Trim Cap, and White Faces and 4'-7" High Swoosh with White Returns, White Trim Cap, and White Face with Blue Vinyl Inlay.)




