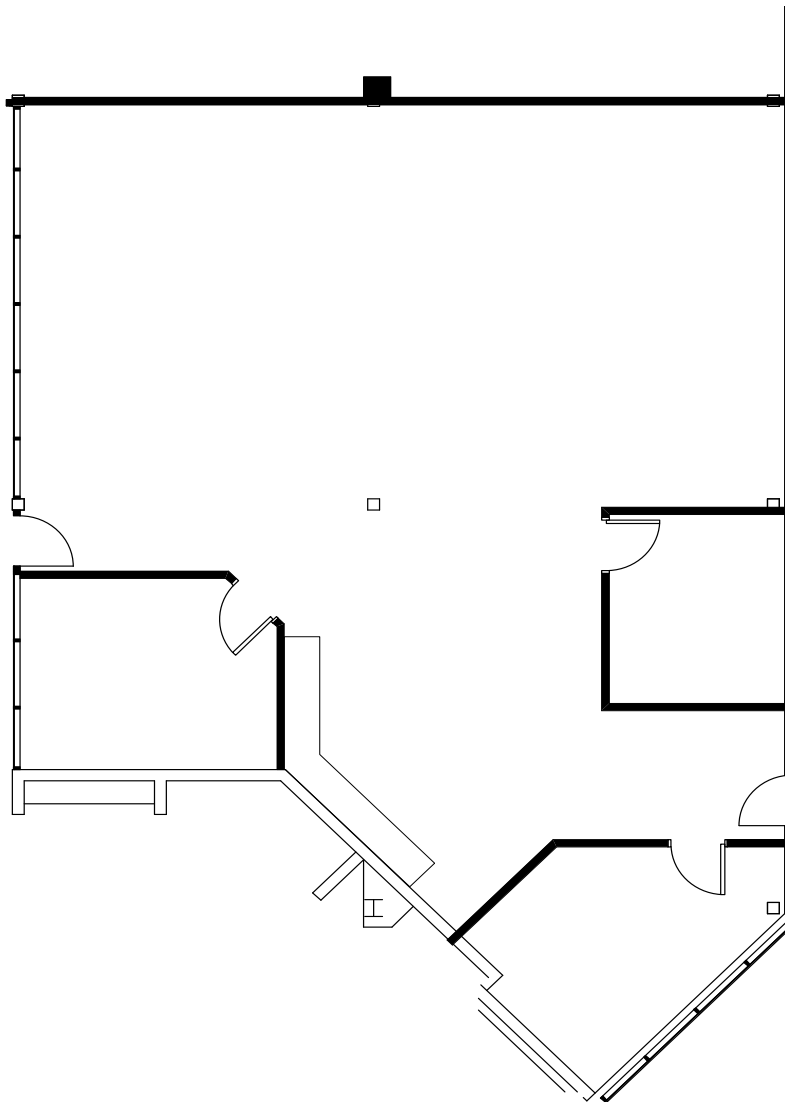

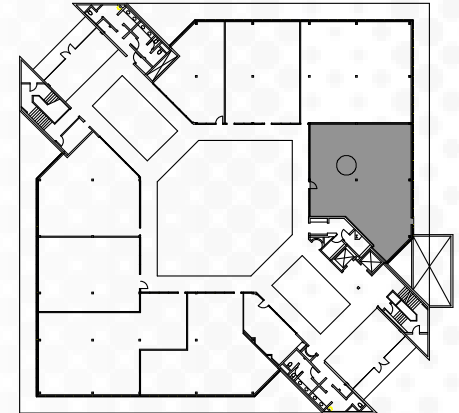


FLOOR PLAN

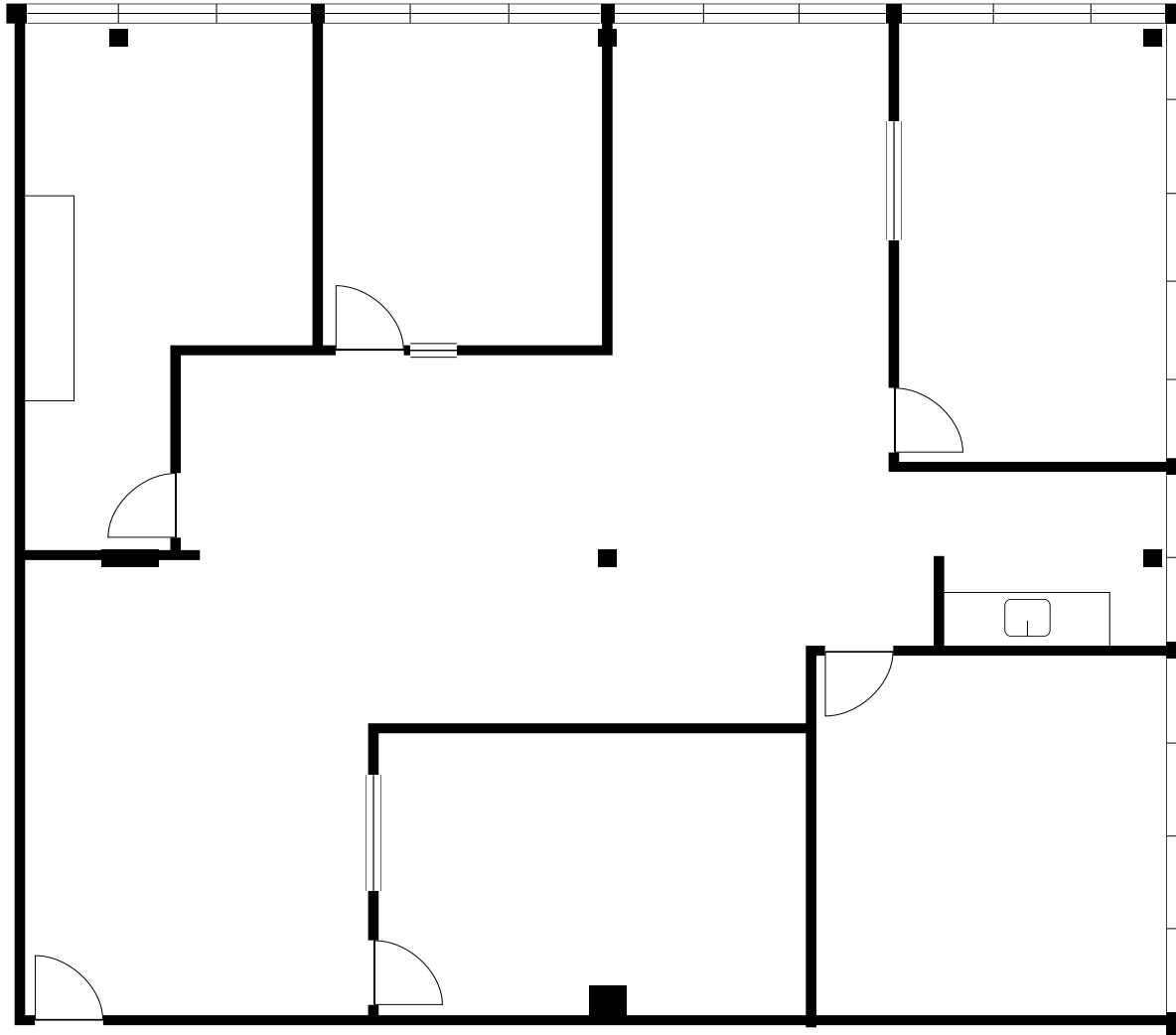

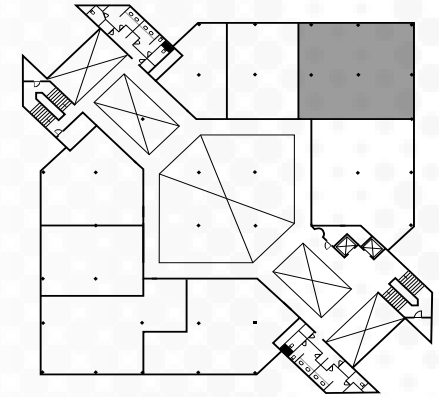


FLOOR PLAN

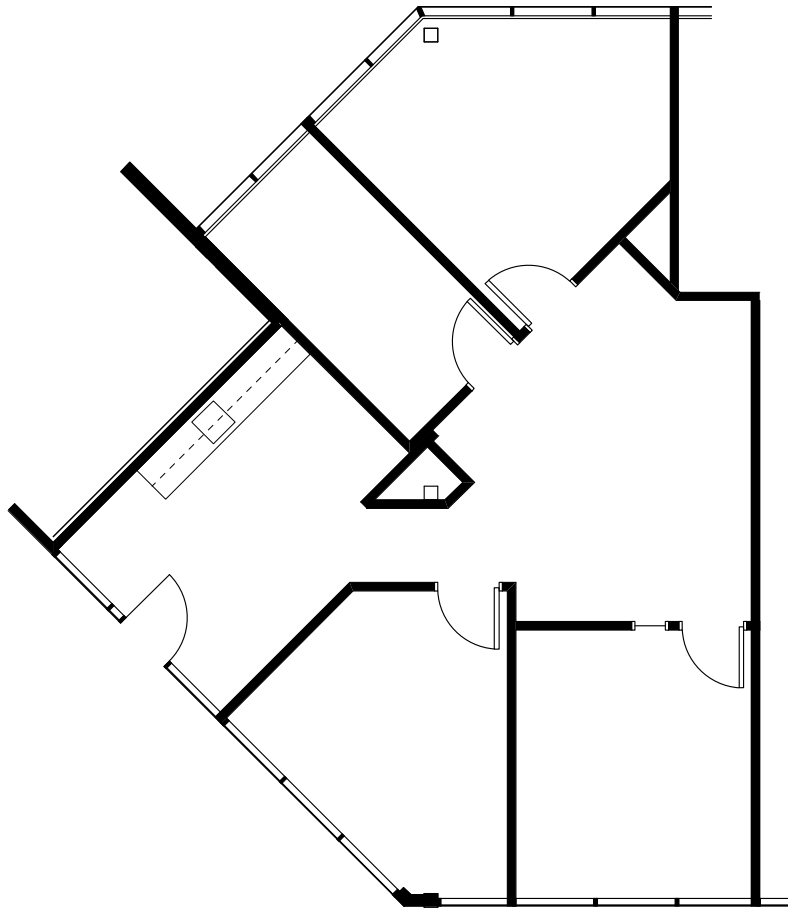

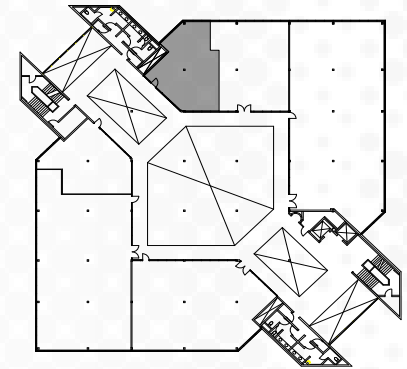


FLOOR PLAN

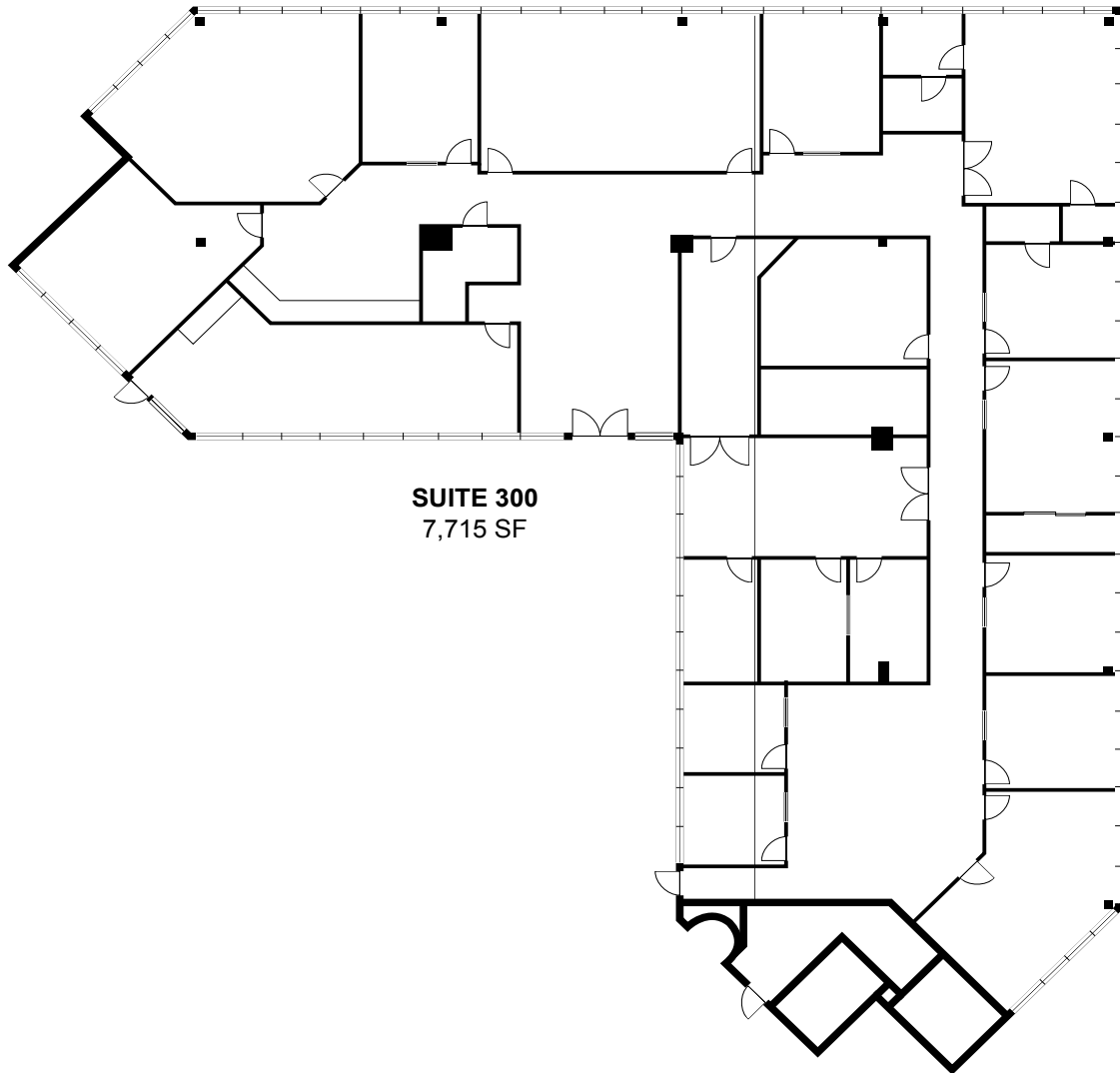

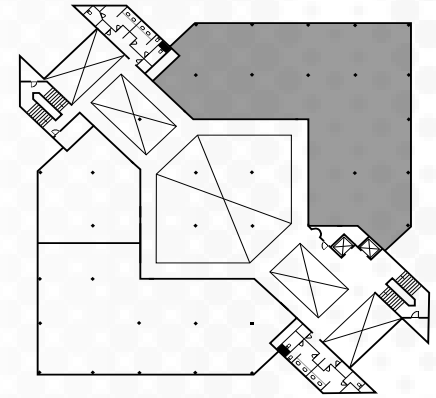


FLOOR PLAN

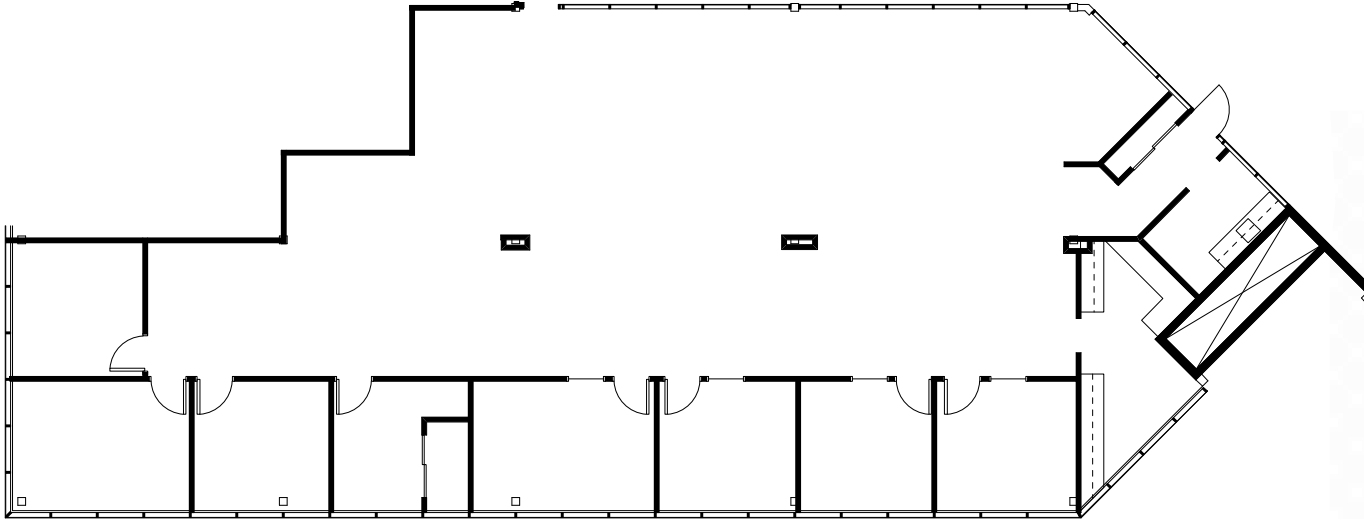

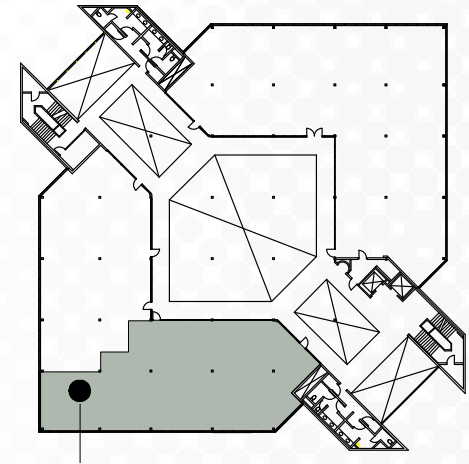


FLOOR PLAN

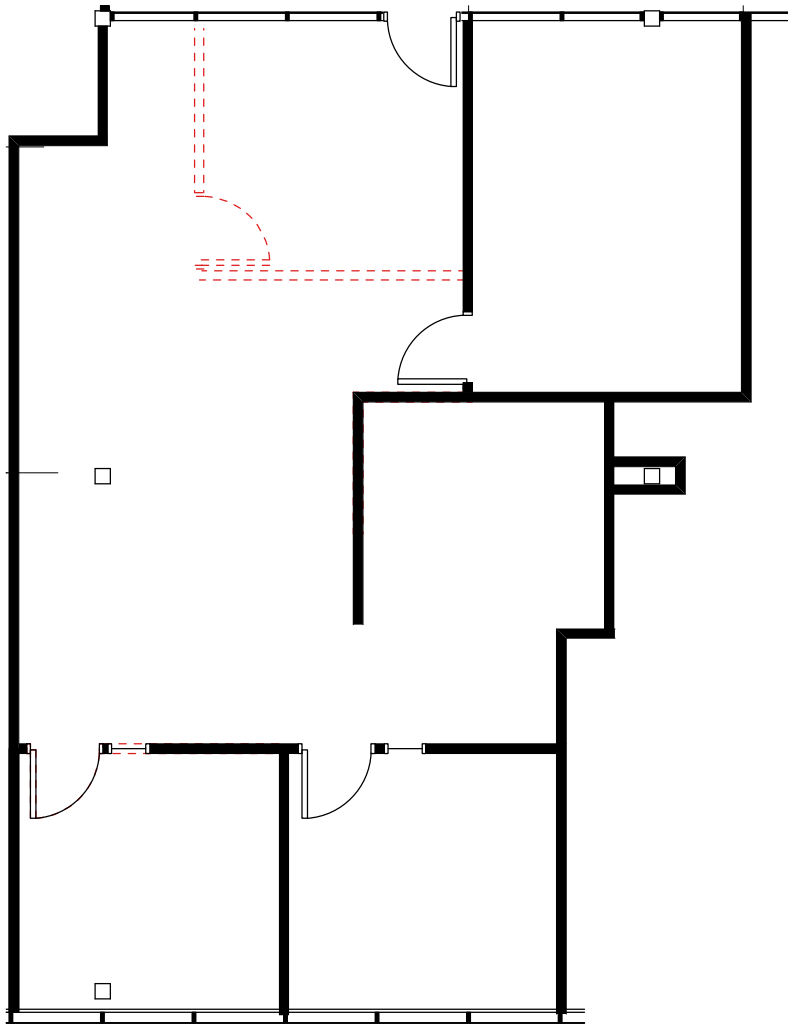

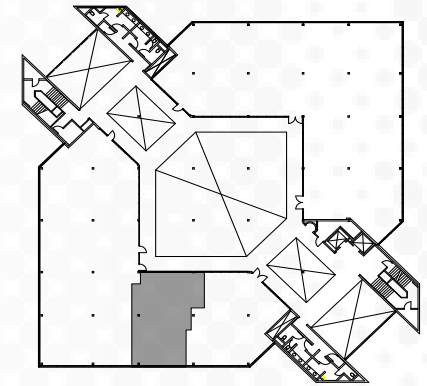


FLOOR PLAN

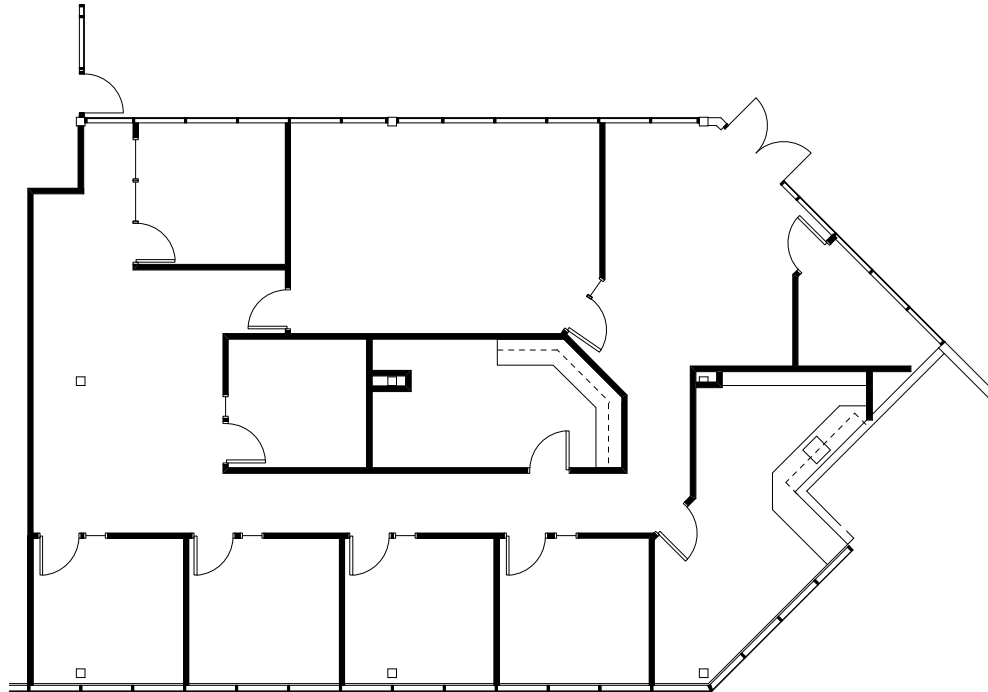

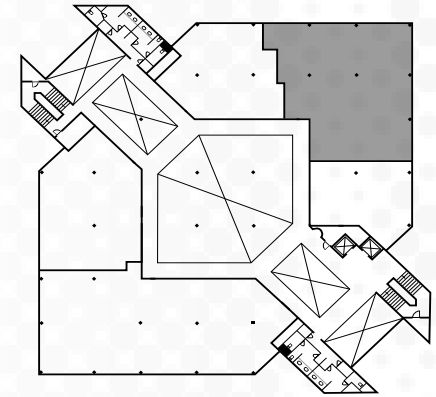


FLOOR PLAN
