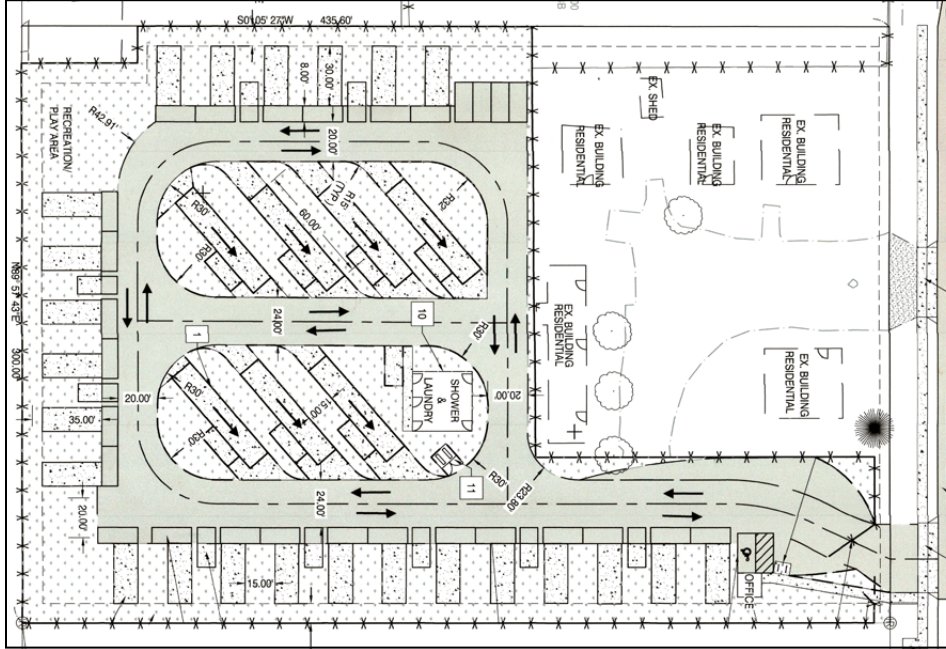

### CONCEPTUAL RV SITE PLAN

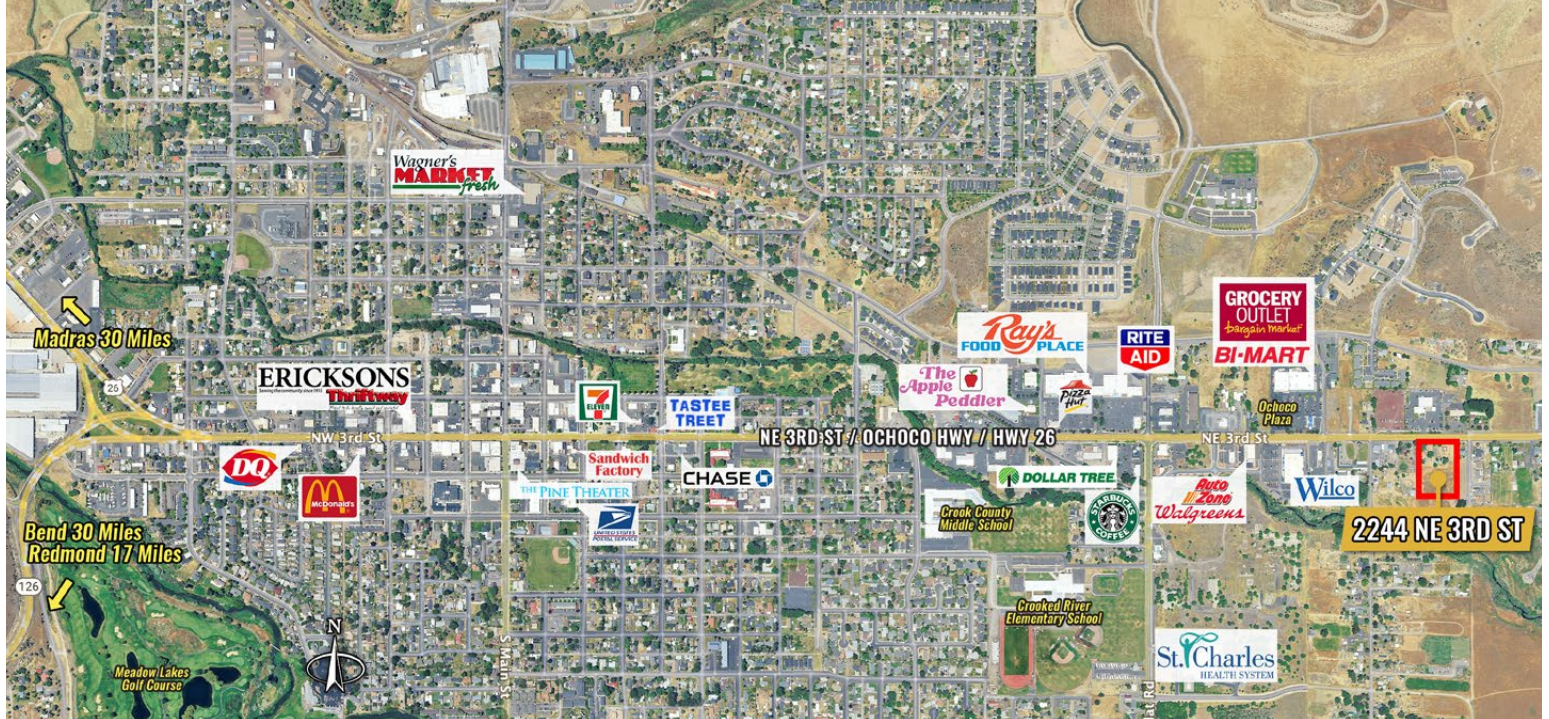

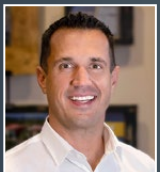
