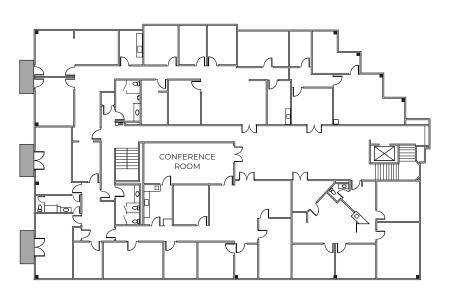


Floor Plan

Second Floor



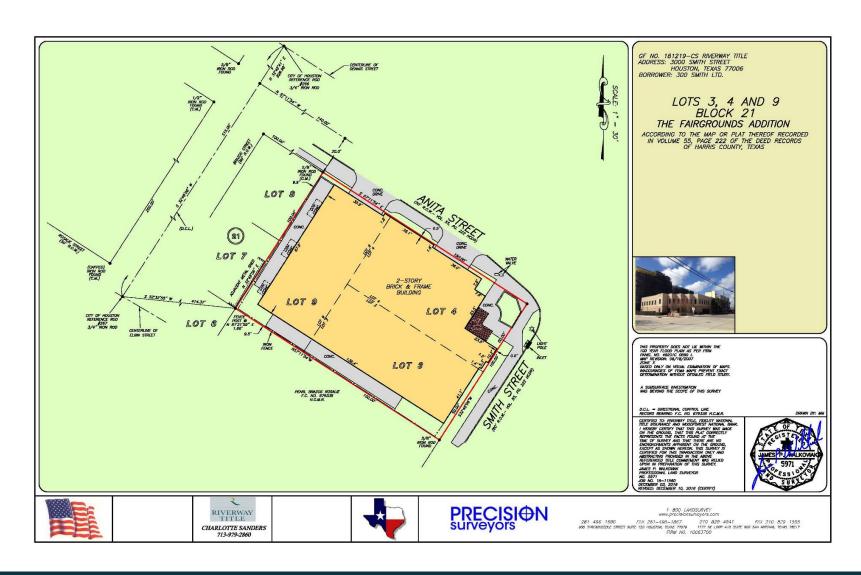

Information About Brokerage Services



Totas fore requires all read estate ficense hobbers to give the following information about brokerage services to prospective huyers, tenonts, sellers and landords.

ITHIS OF MEAL ESTATE DOTHSE HOLDERS:

- A MIXED is reportable for all brukenge activities, including acts performed by sales agents sponsured by the brukes. A SALES ACENT must be sponsored by a broker and works with clients on behalf of the bruker.

- COCET'S IMPRILIES DUTIES REQUIRED BY LAWE (A clear is the person or party that the broken represents):
 Put the interests of the client above all others, including the broken's man interests;
 Inform the client of any material information about the property or transaction received by the broken,
 Answer the client's questions and present any offer to or counter-offer from the client; and
- Treat all parties to a real estate transaction horrestly and fairly.

A LEDROE HOLDER CAN REPRESENT A PARTY IN A BEAL ESTATE TRANSACTION:

AS ASSETT FOR CHARGE (STUTEN/LANDLODG): The broker becomes the property numer's agent through an agreement with the numer, usually in a written folging to sell or property management agreement. An owner's agent must perform the bruker's minimum duties above and must inform the owner of any natural information about the property or transaction brown by the agent, including information disclosed to the agent or subagent by the buyer or buyer's agent. An owner's agent fees are not set by law and are fully

AS AZENT FOR BURENTHAME. The broker becomes the buyer/borant's agent by agreeing to represent the buyer, usually through a writtee representation agreement. A buyer's agent must perform the bruker's minimum dufes above and must inform the buyer of any material information about the property or transaction formum by the agent, including information dischard to the agent by the seller or seller's agent. A buyer/borant's agent fees are not set by bor and are fully negatiable.

AS SURACENT: A ficerse holder acts as a subagest when aiding a buyer in a transaction without an agreement to represent the buyer. A subagest can assist the buyer but does not represent the layer and must place the interests of the owner first.

TO ANDO DESCRIPE, ALL AGRESMENTS BETWEEN YOU AND A BECKER SHEALD BE IN WINDING AND CLEARLY ESTABLISH:

The broker's duties and responsibilies to you, and your obligations under the representation agreement.

Who will pay the broker for services provided to you, when payment will be made and how the payment will be calculated.
