The ground floor has a large processing room equipped for meat/fish processing with direct access to chill space. There are three large freezer rooms and one chill room with direct access to dry storage serviced by multiple roll up doors.

The second floor is accessible by functional freight elevator and contains large freezer storage and large processing room for additional manufacturing and storage.

Along Queen Street is approximately 10,000 square feet of additional dry storage warehouse. Or this space can be leased out for additional rental income. Possibilities are endless.


