
PROPERTY DESCRIPTION


The zoning is C2 which allows for a variety of uses. Additionally, it is located in an opportunity zone allowing for additional tax incentives and savings.





2024 Household Income




2024 Population by Race






2024 Household Occupancy - 1 Mile Radius
