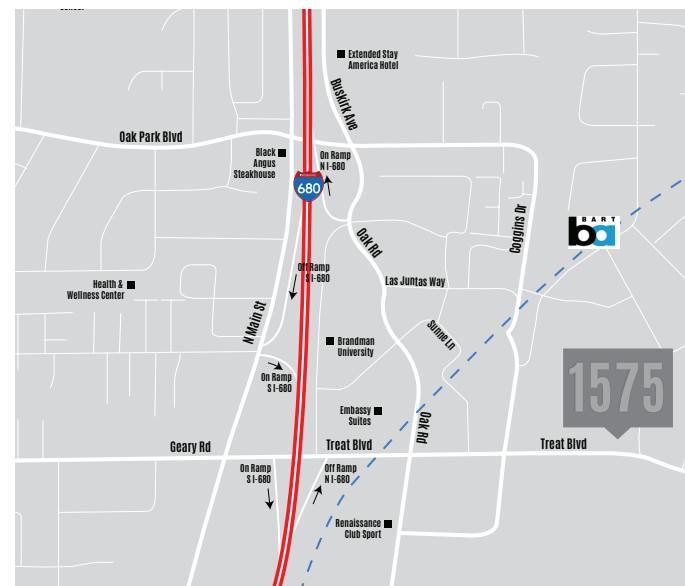

LOCATION MAP



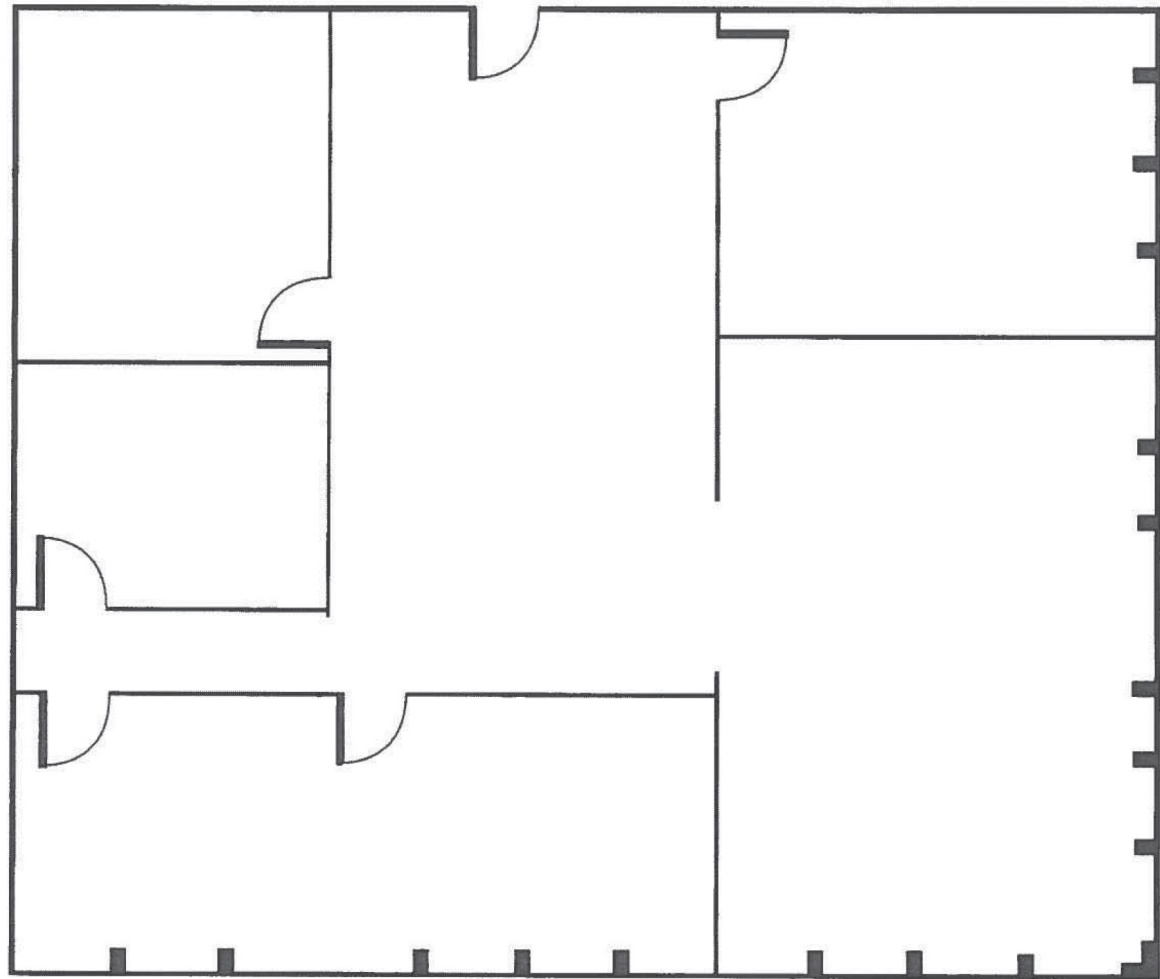
