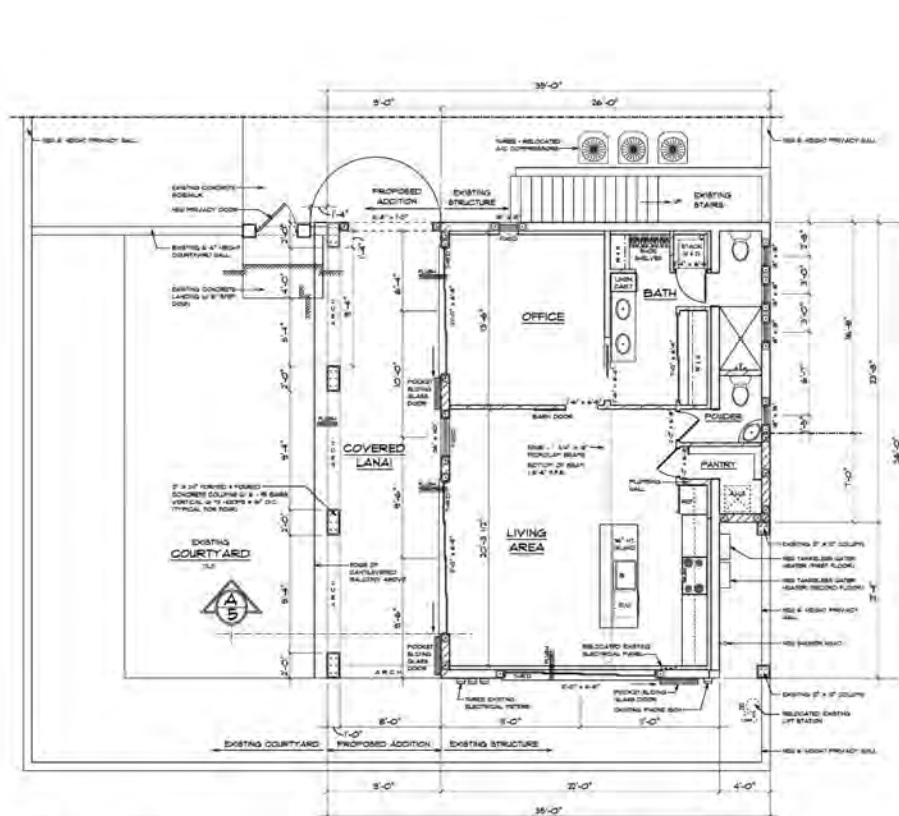

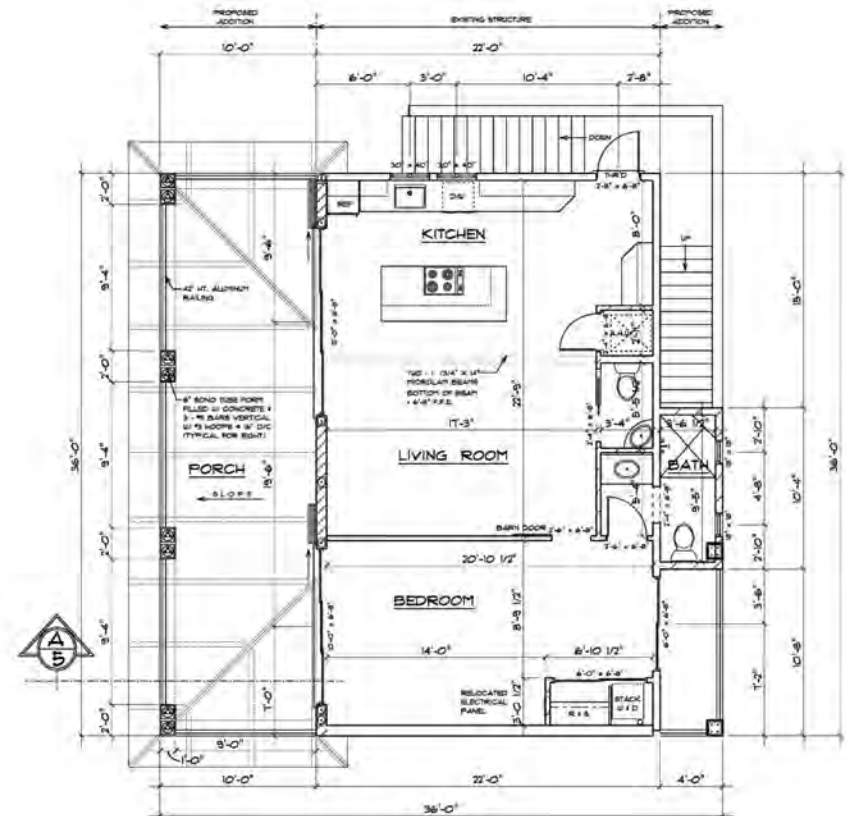

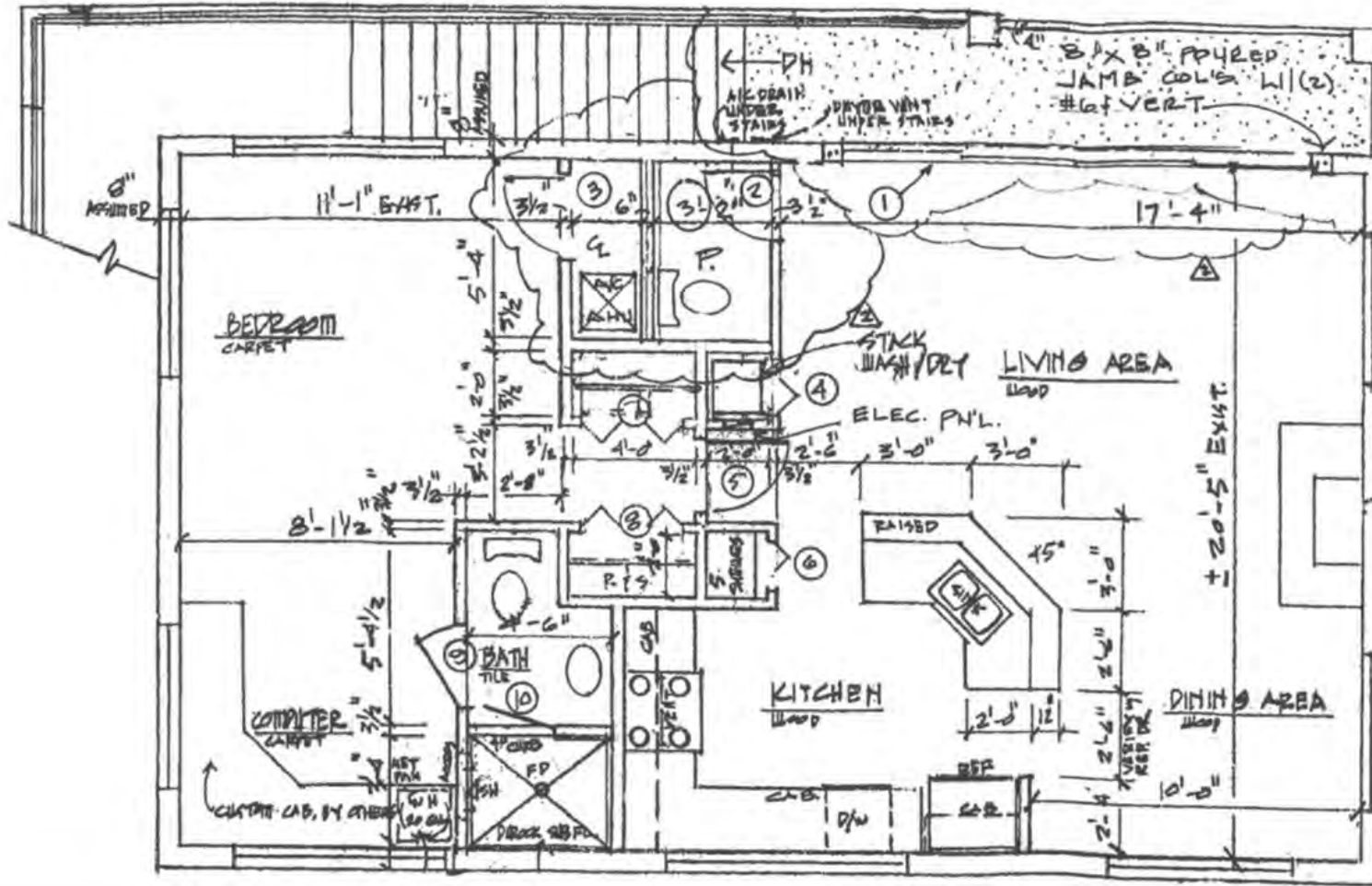


SECOND FLOOR PLAN

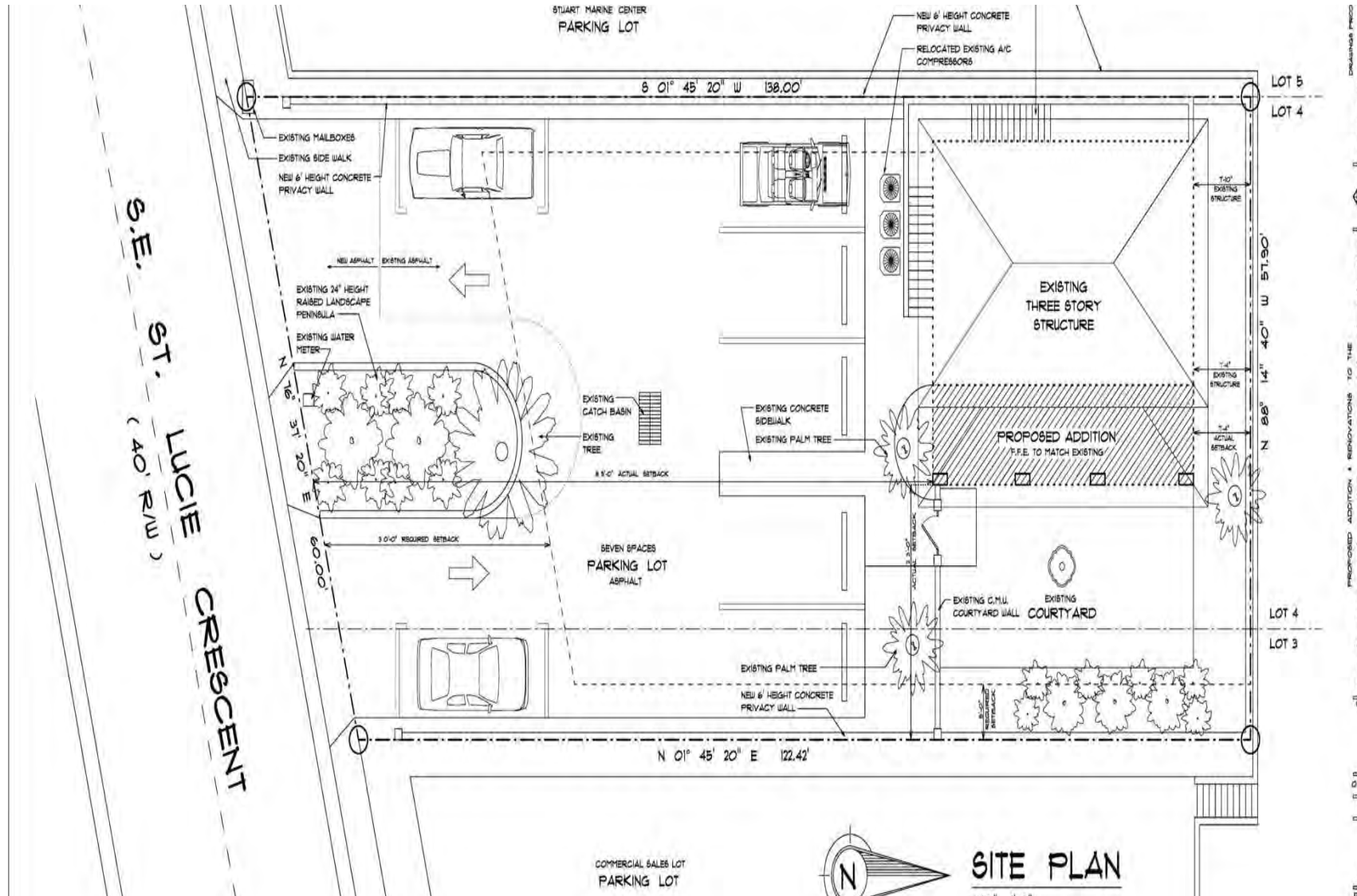


THIRD FLOOR PLAN

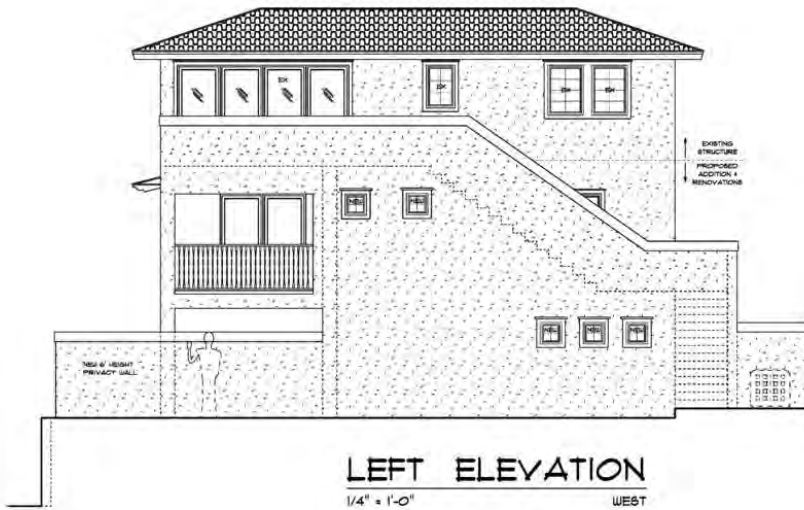
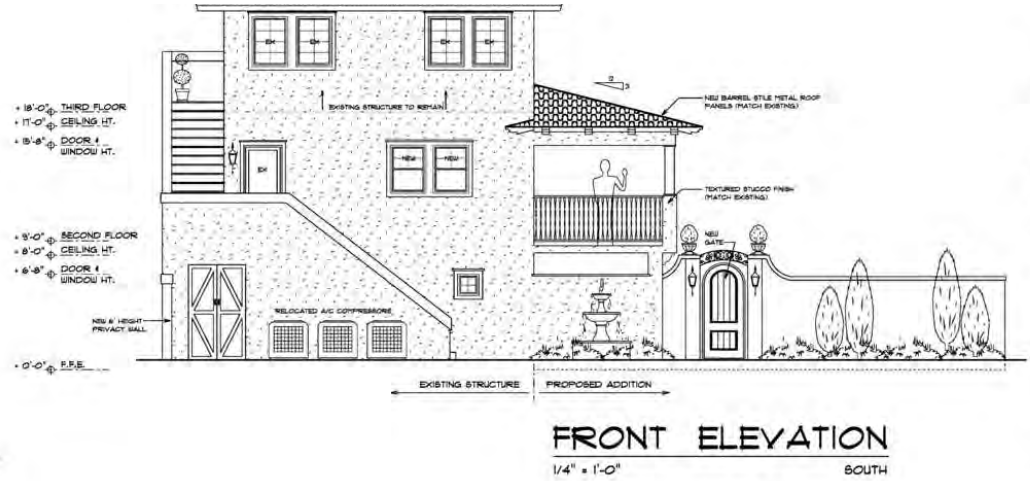

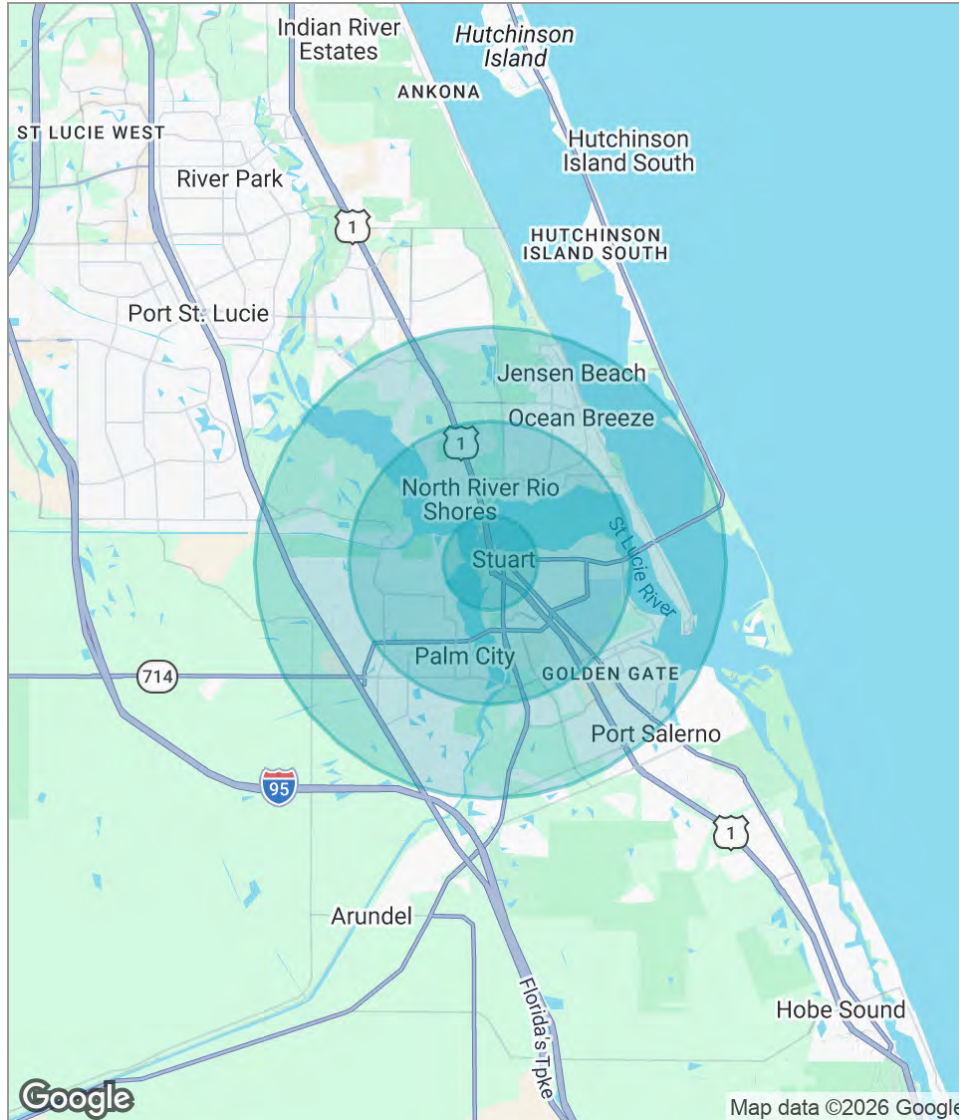
