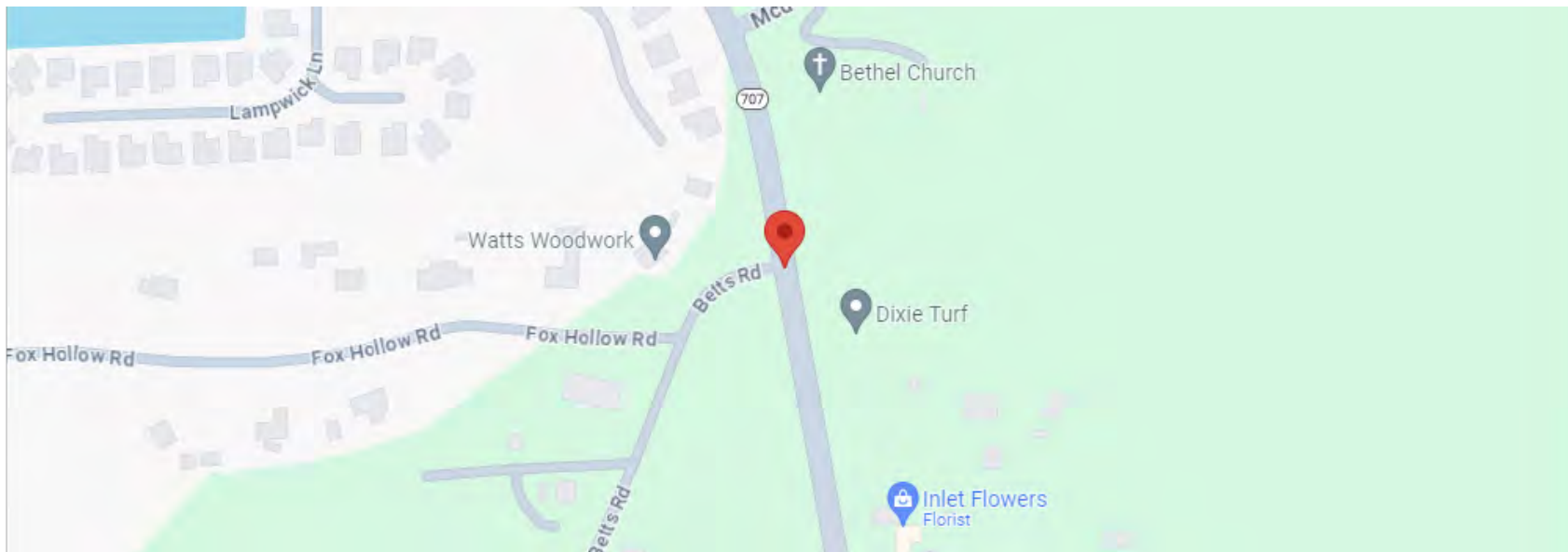

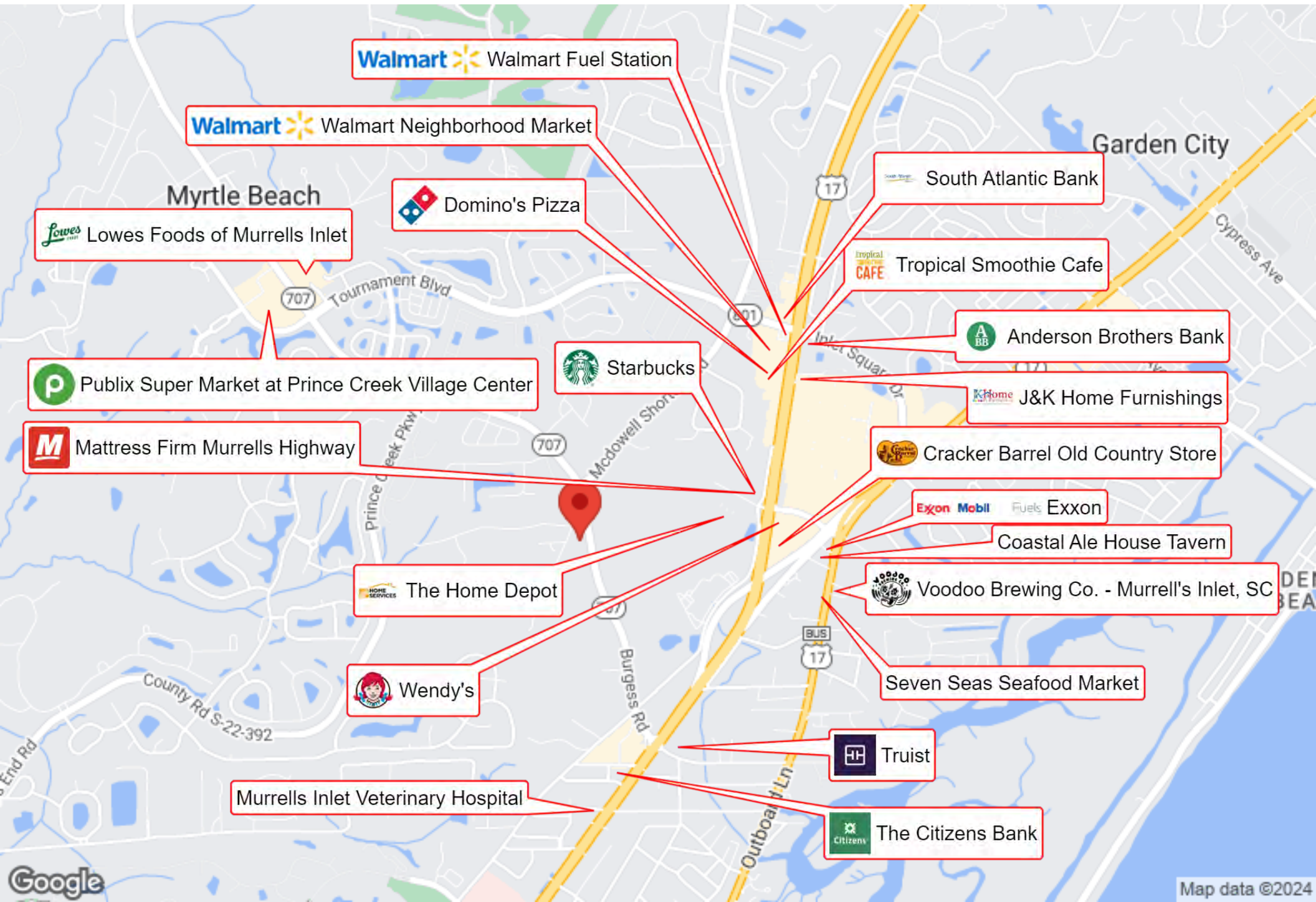

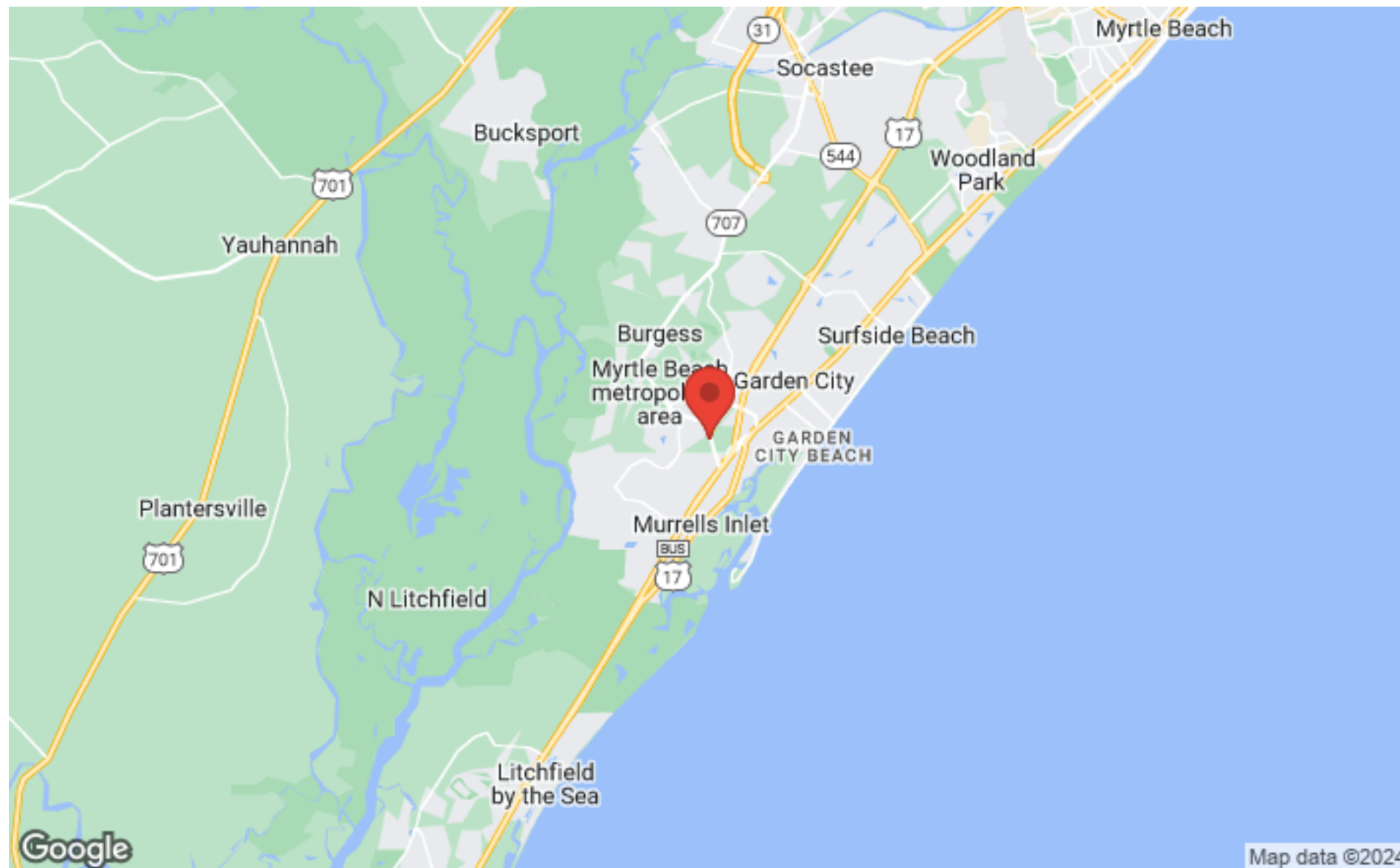
BUSINESS MAP

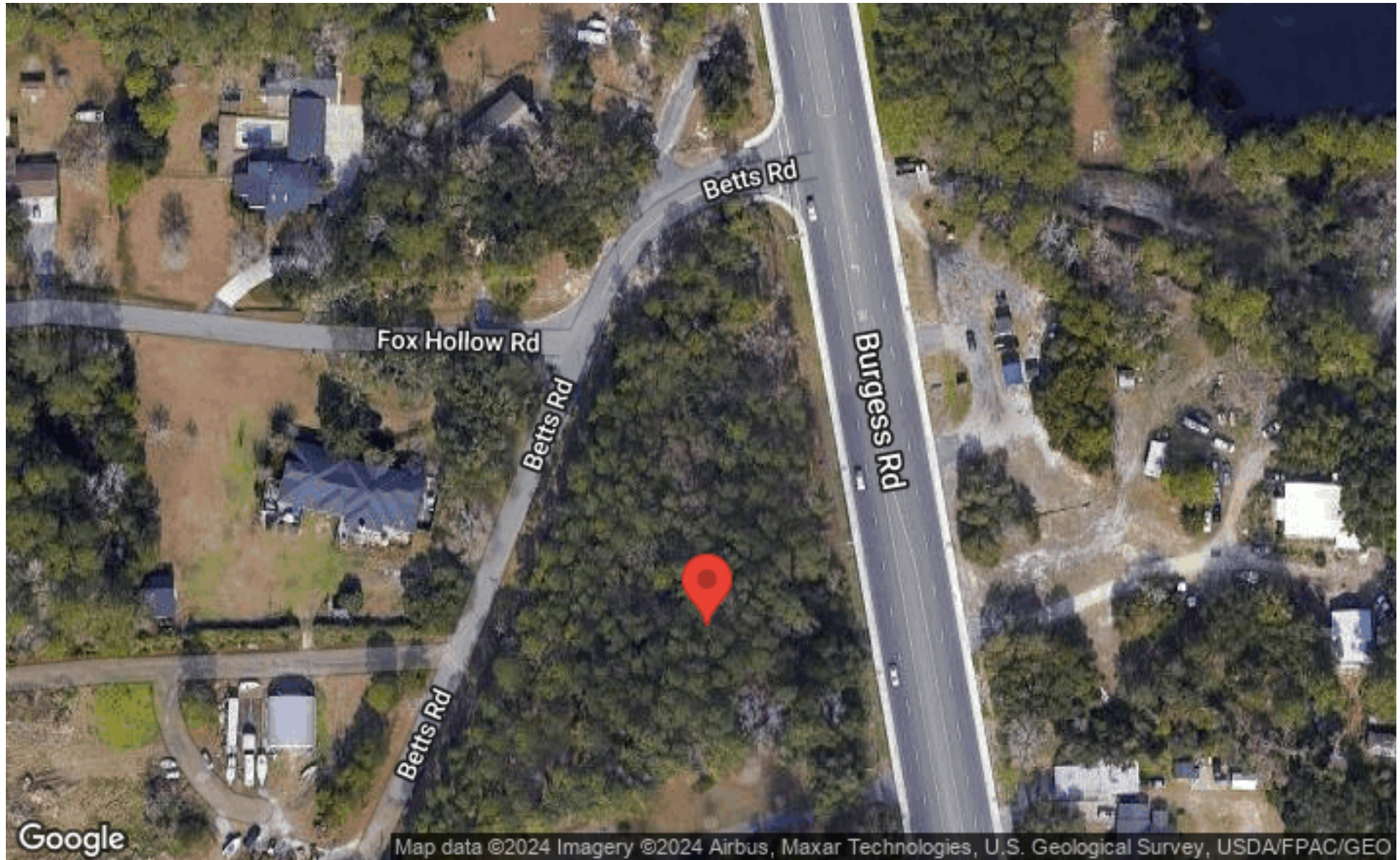

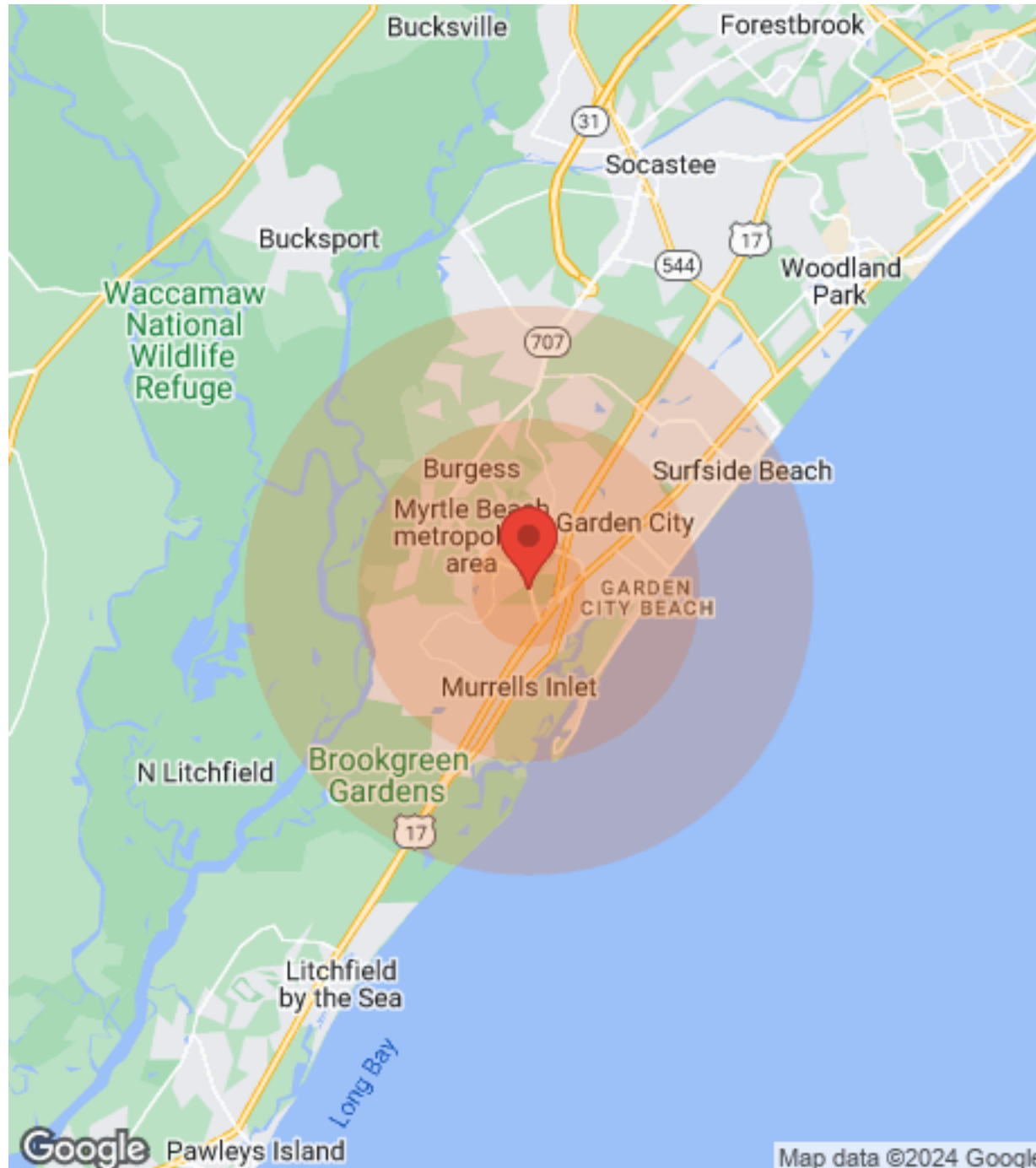
