Section 501 C - Commercial District

Section 501.1 C District - General Requirements

A. Purpose

This district is established to provide commercial uses for local and area residents as well as permitting totally designed commercial centers or parks with strictly limited access to roads and street design standards.

Section 501.2 <u>C District - Use Regulations</u>

Within the C - Commercial District a building may be erected, altered, or used, and any lot or premises may be used when in conformance with the conditions of this Ordinance and the specific use, area and design regulations of this district for any of the following uses, and no other, provided the Use Regulations, Article VII of this Ordinance, have also been met, and provided the Overlay District regulations have been met.
