



# Lima, OH

#### LOCATION

Lima is the county seat of Allen County, and the principal city of all surrounding counties including Van Wert, Putnam, Hancock, Hardin, Auglaize, and Mercer Counties.\* Likewise, it is the principal city of the Lima Ohio MSA (metropolitan statistical area), which is included in the Lima / Van Wert / Wapakoneta CSA (combined statistical area).\*

Lima is located in northwest Ohio along Interstate-75 and State Route 309, approximately 72 mi north of Dayton, 78 mi southwest of Toledo, and 63 mi southeast of Fort Wayne.\*

#### INDUSTRIES

Healthcare is a key industry in Allen County, where it is ~40% larger than the national average, and enjoys 266% job growth in Professional, Scientific, and Technical Services industries.<sup>†</sup> Further, healthcare is an even larger industry per capita in Lima, with Mercy Health St. Rita's Medical Center and Lima Memorial Health Systems both being dominant employers. These two hospitals serve a 10-county area of northwest and central west Ohio.\*

In fact, Mercy Health recently announced the development of a \$15 million Graduate Medical Education Center, which is a 48,000 SF facility and designed to recruit physicians and medical students to the area.<sup>‡</sup>

Lima is home to Procter & Gamble, PPG Coating Services (formerly MetoKote), Range Kleen, and Lima Refinery. Lima also includes locations of notable companies including Ford Motor Company and SumiRiko (formerly DTR Industries).<sup>†</sup> In fact, Allen County in general has a 100% larger manufacturing industry than the national average.<sup>†</sup>

#### SCHOOLS, SAFETY, & TRIMA

Lima includes Ohio State University (OSU) regional campus and is home to University of Northwestern Ohio.\* Lima enjoys being a very low crime area.<sup>§</sup> The television series Glee is set in a fictional High School in Lima Ohio.\*
