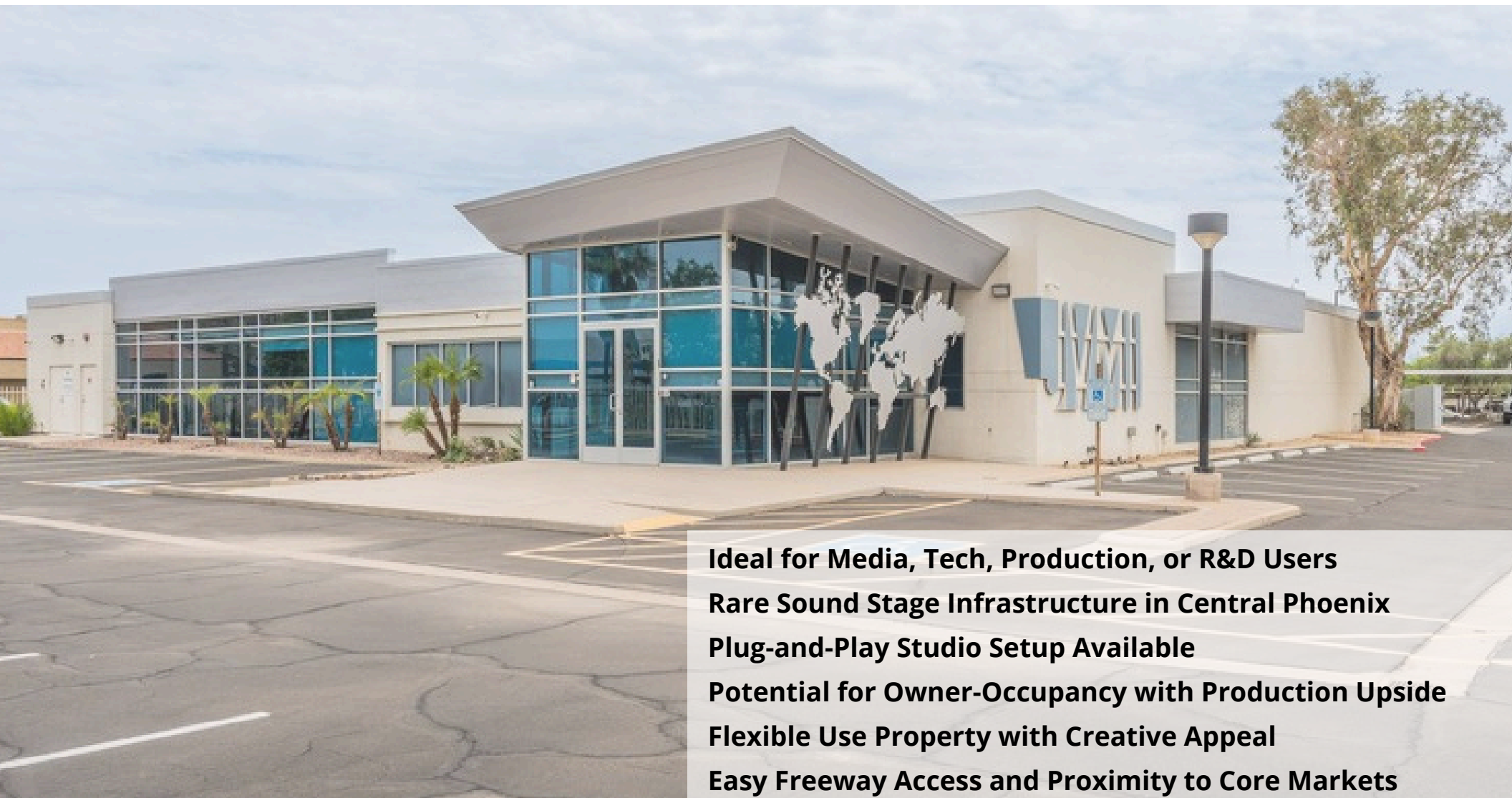

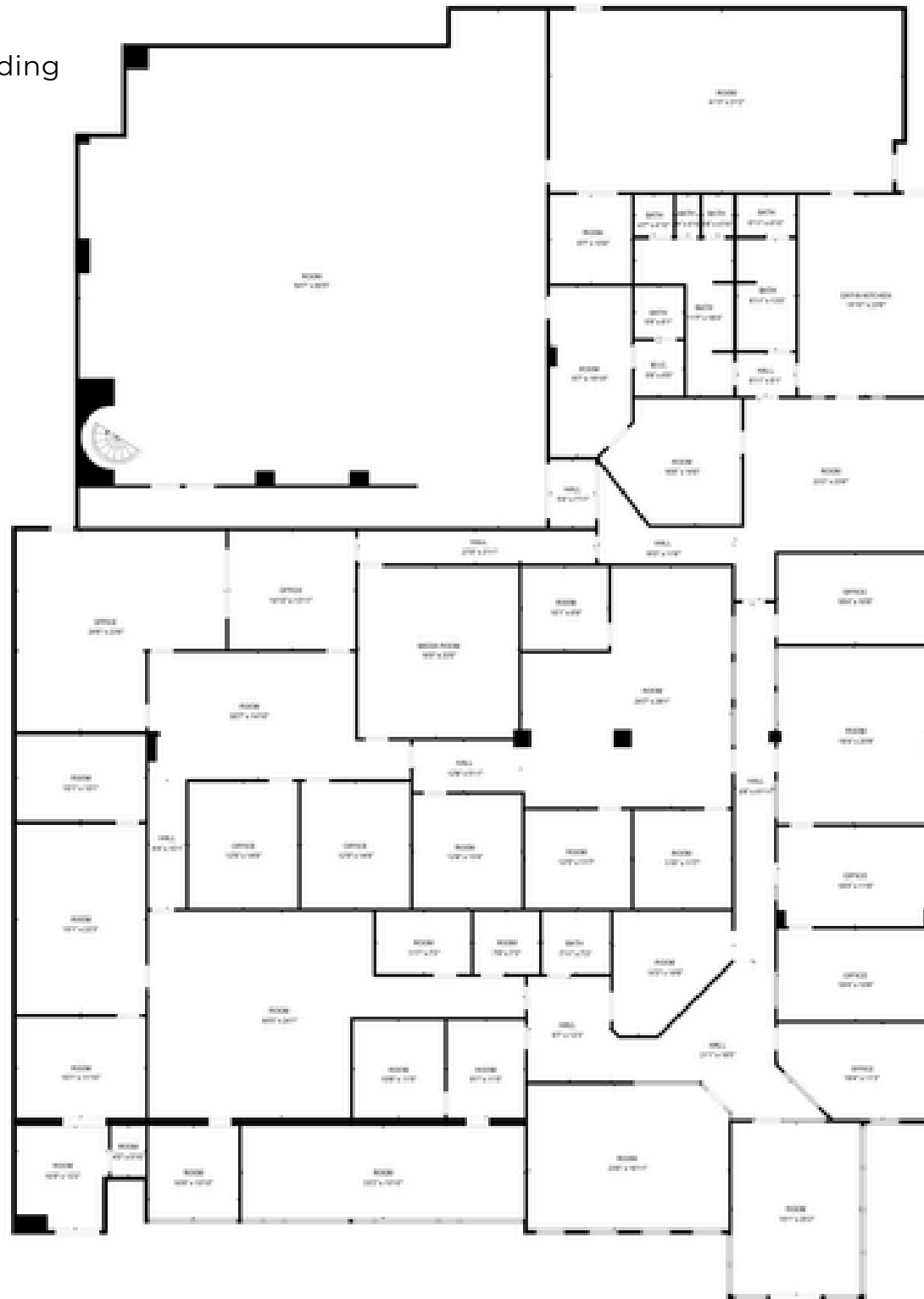
This emerging creative-industrial area has attracted increasing attention from production companies, artisans, and tech-forward businesses due to its affordability, infrastructure, and central location.

The surrounding neighborhood includes a diverse mix of industrial, media, nonprofit, and small business users. Notable nearby businesses include:

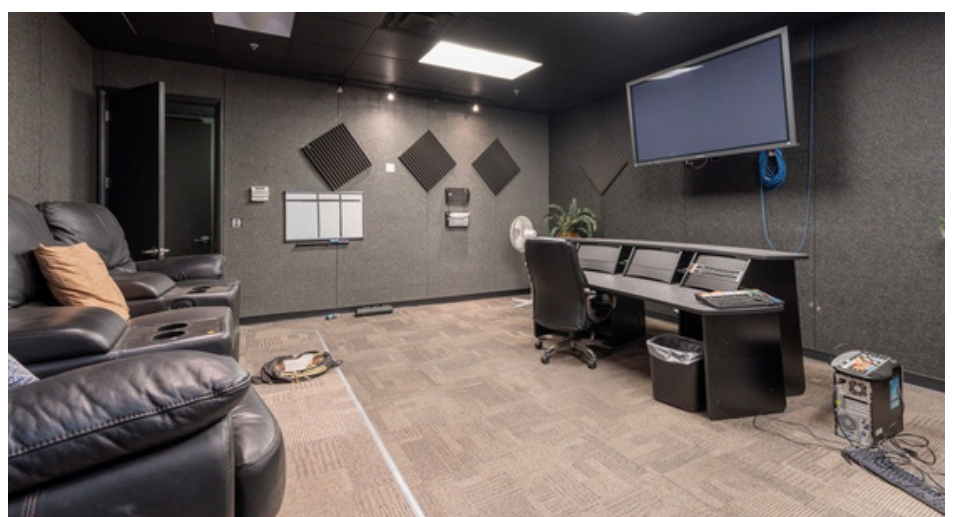

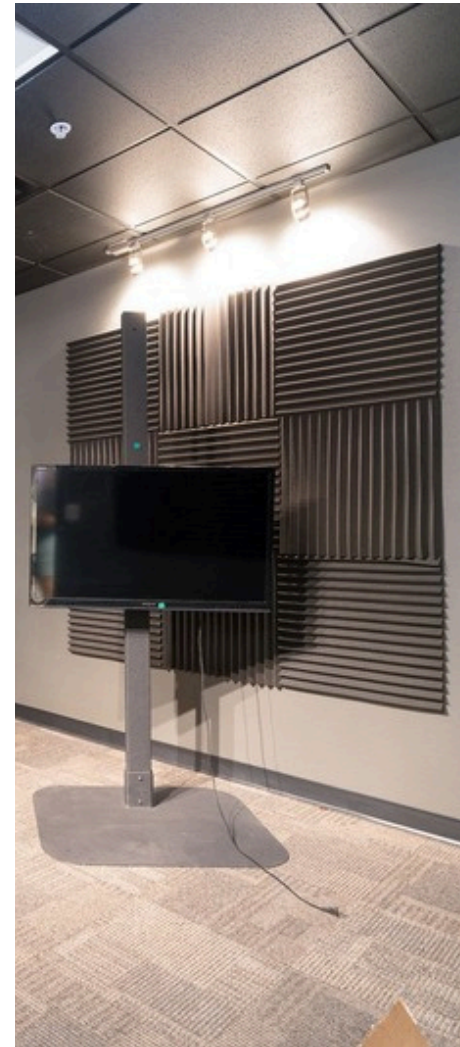
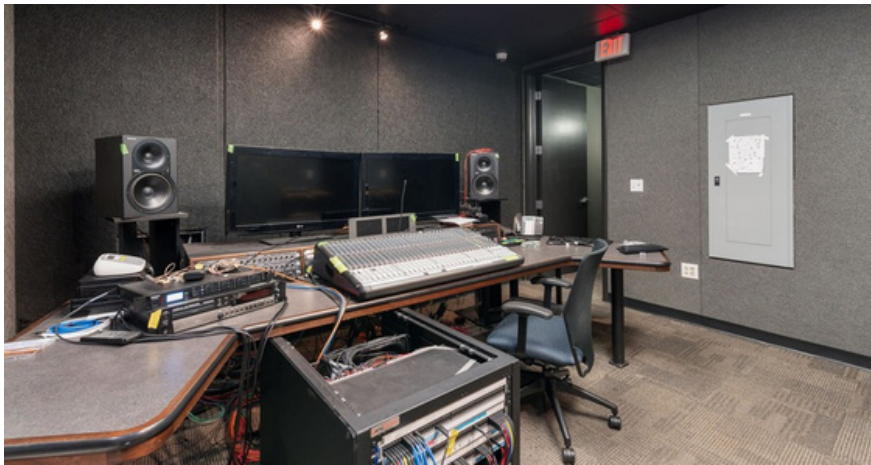
Floor Plan
