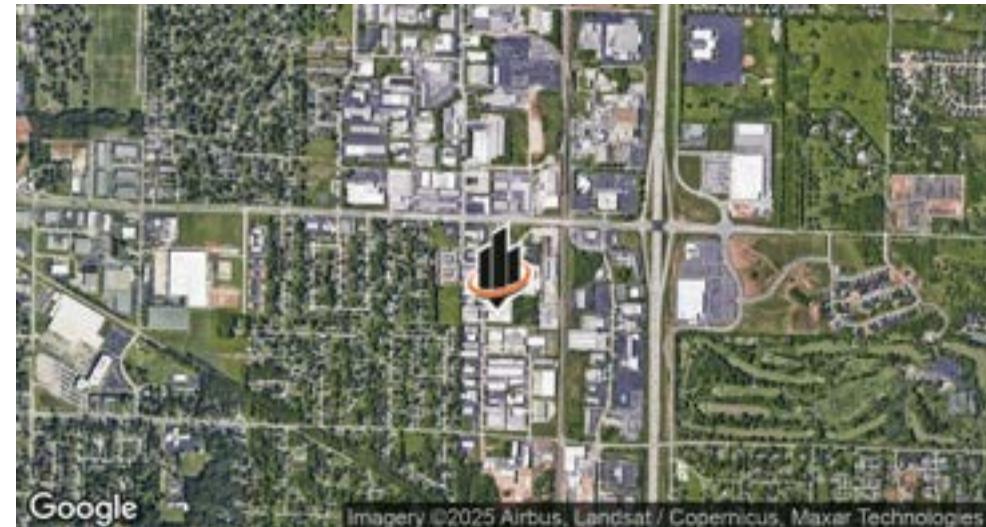

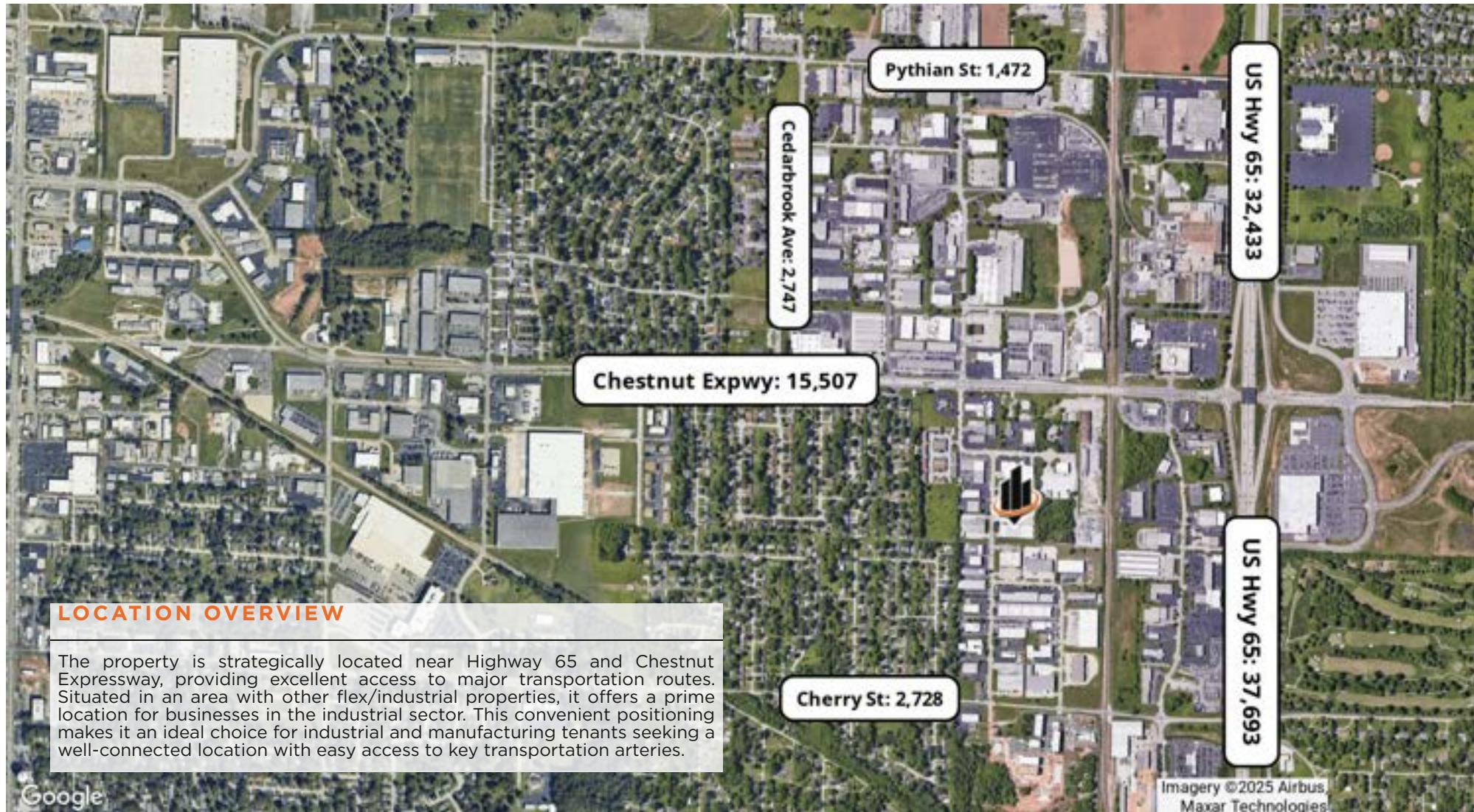

RETAILER MAP



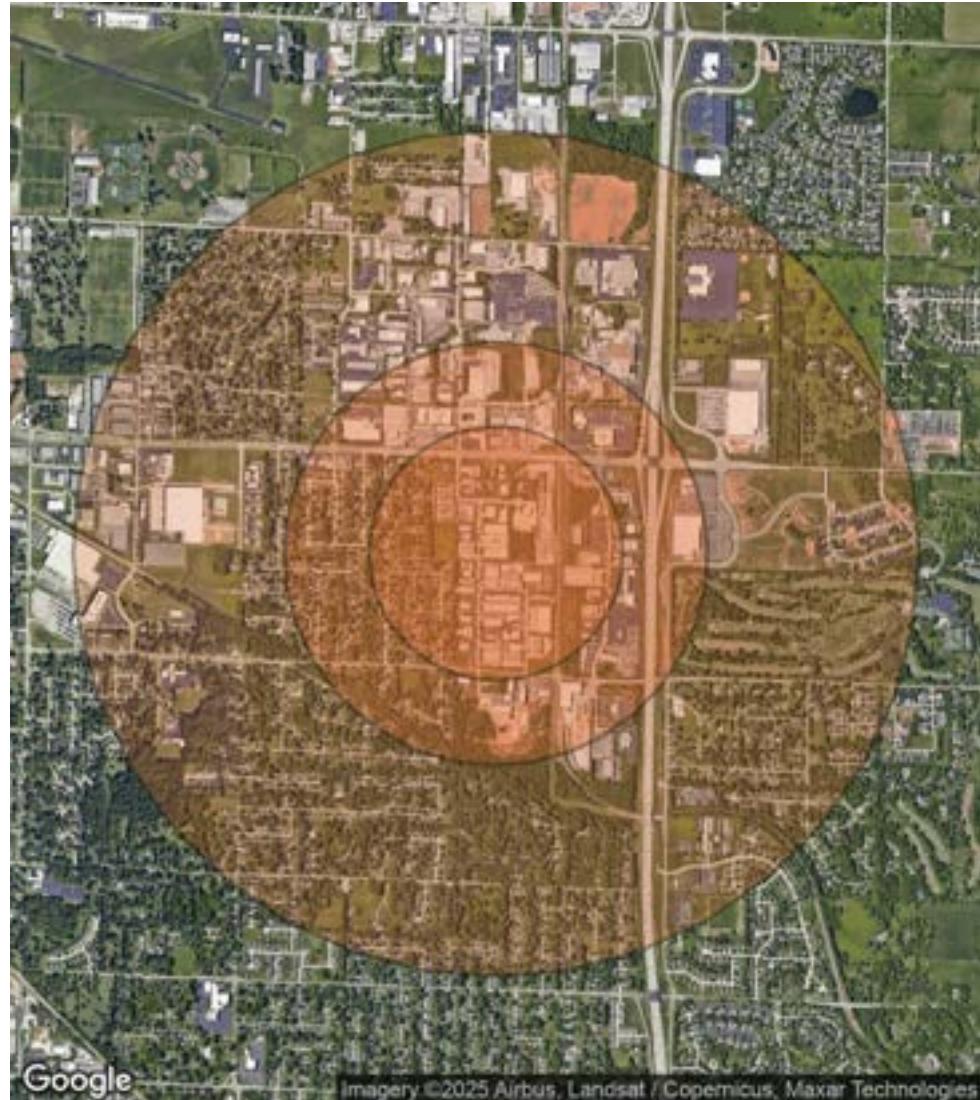
