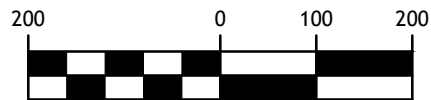


GRAPHIC SCALE

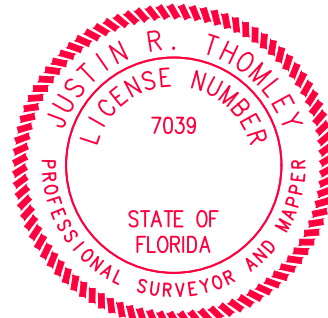
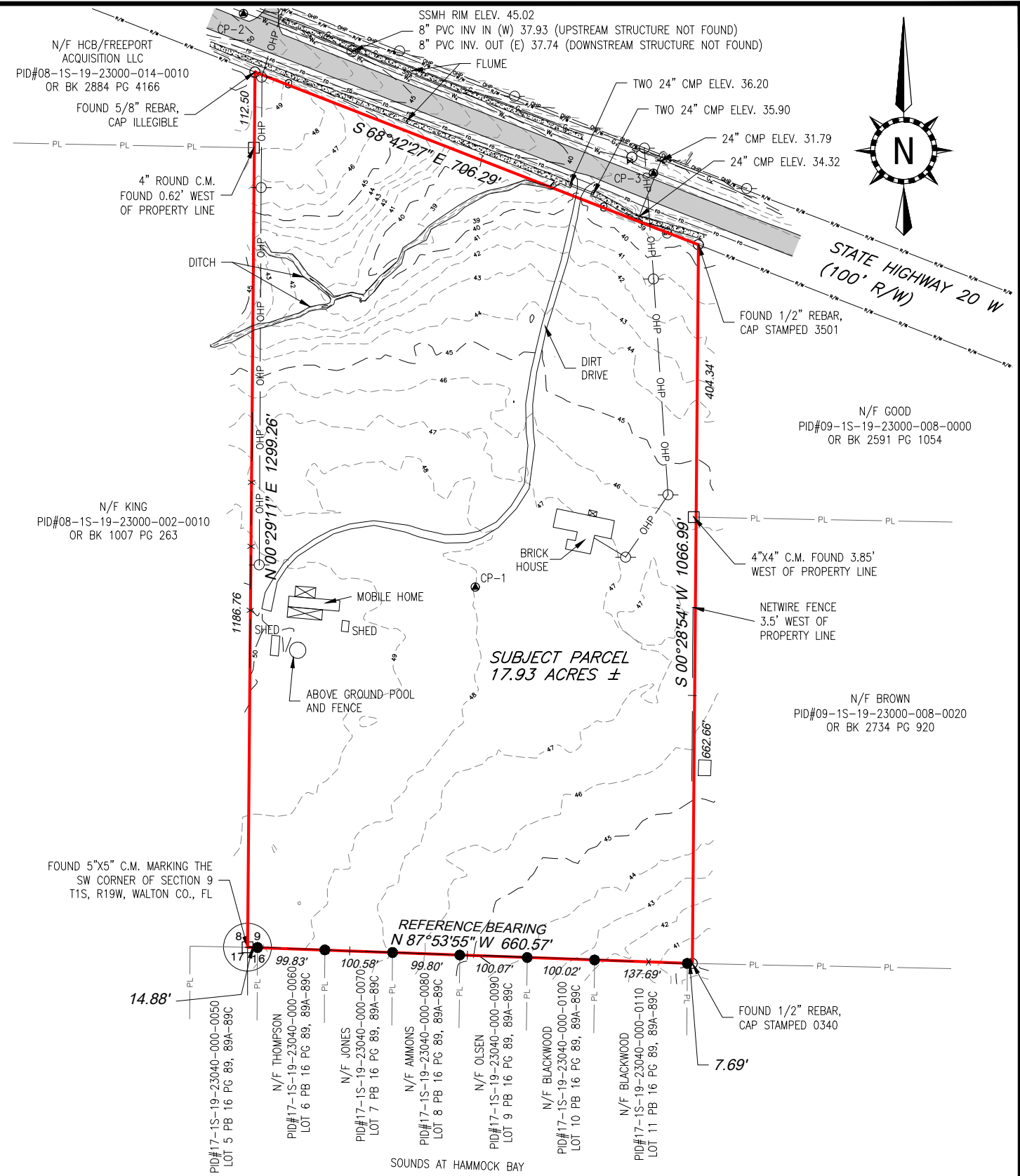
