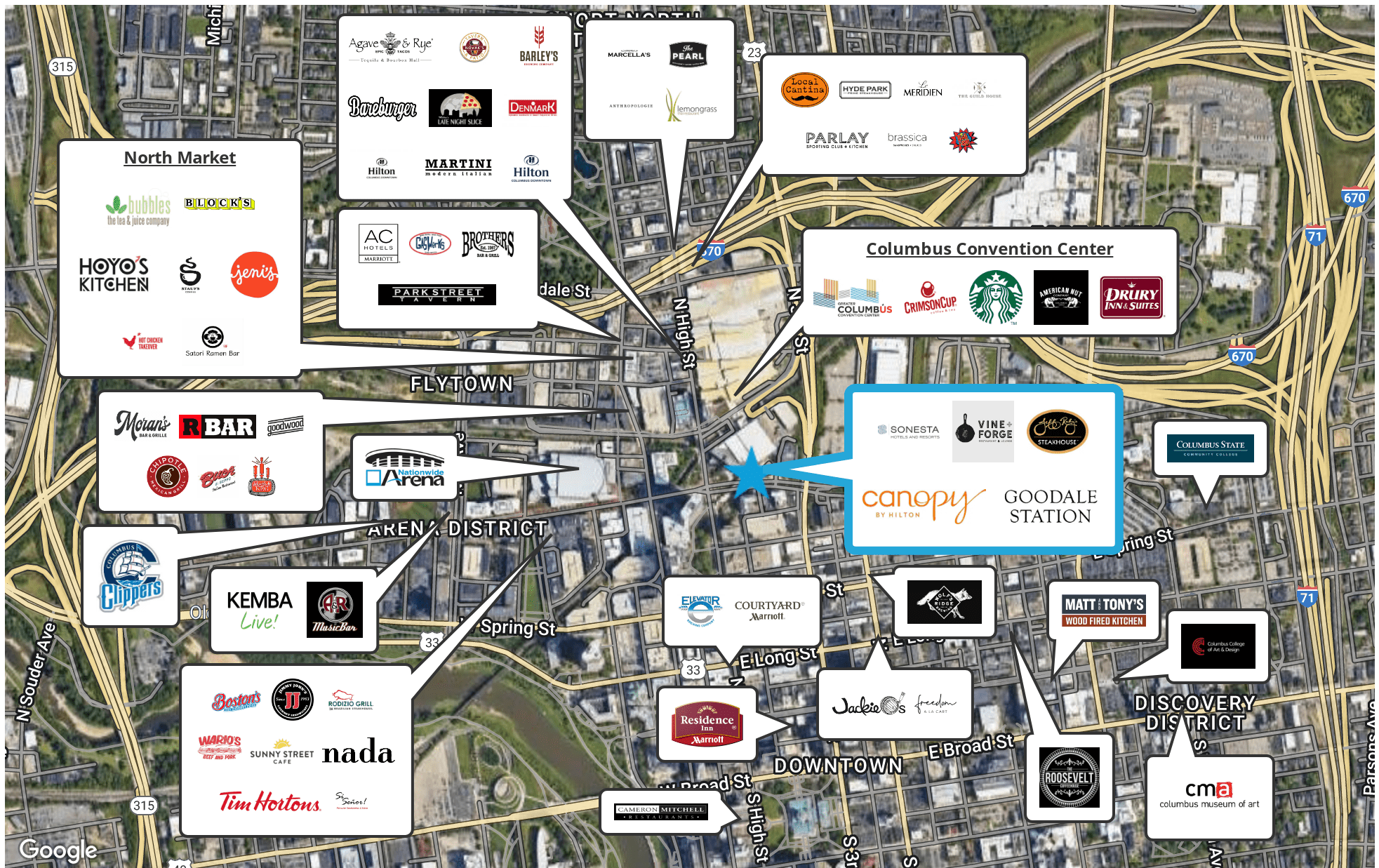

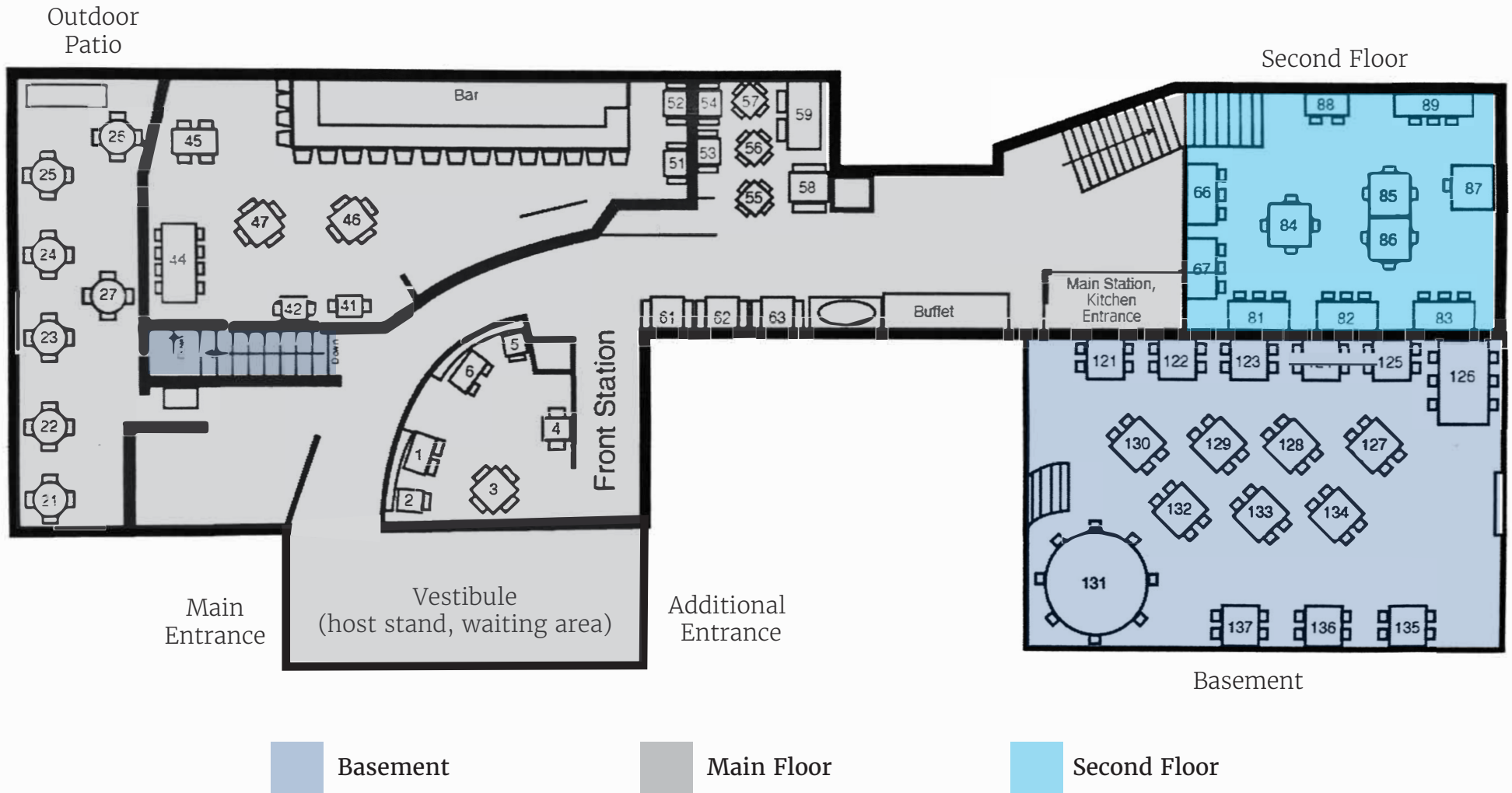

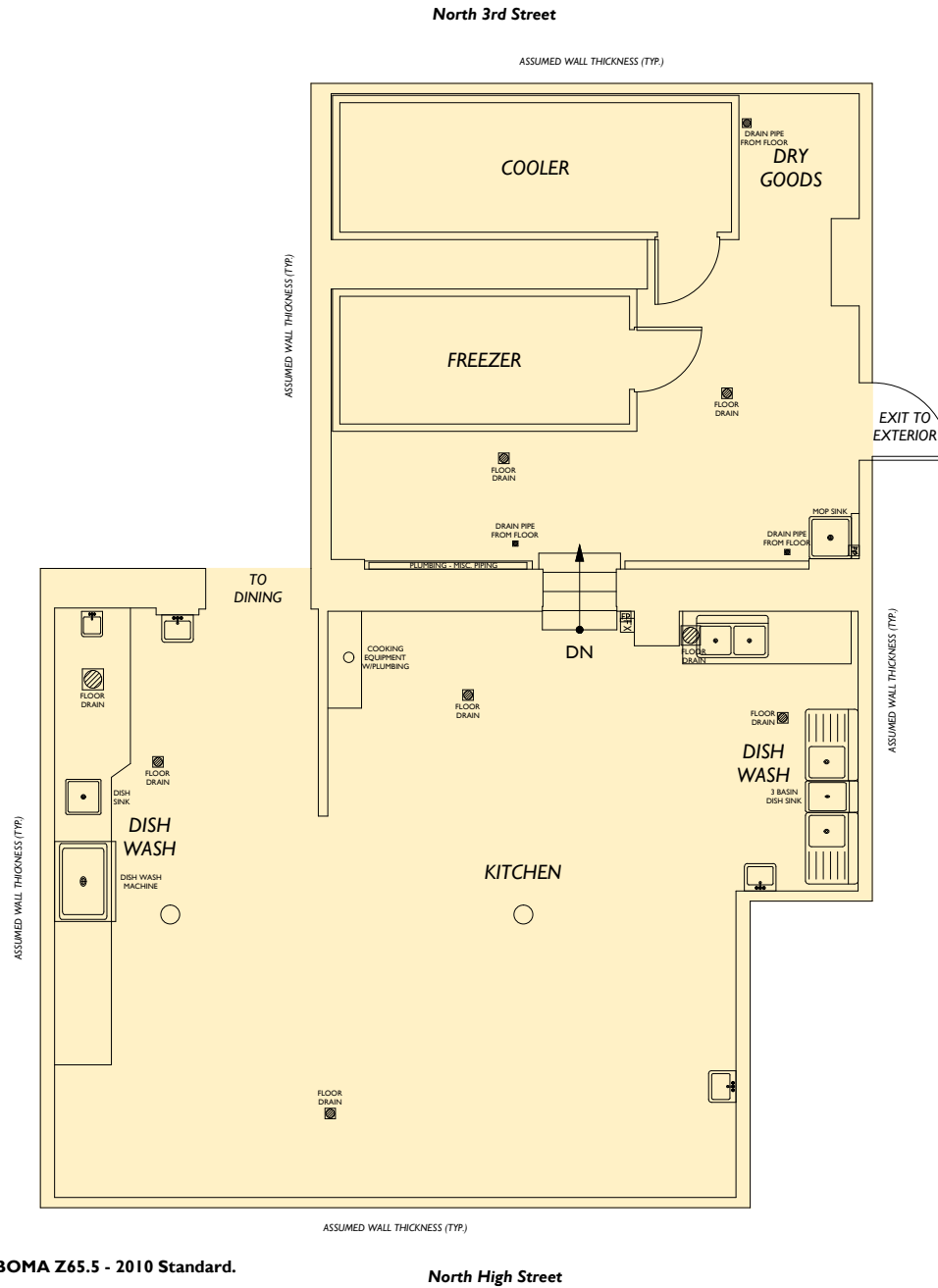


55 E Nationwide Blvd. Floor Plan

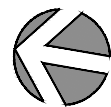
