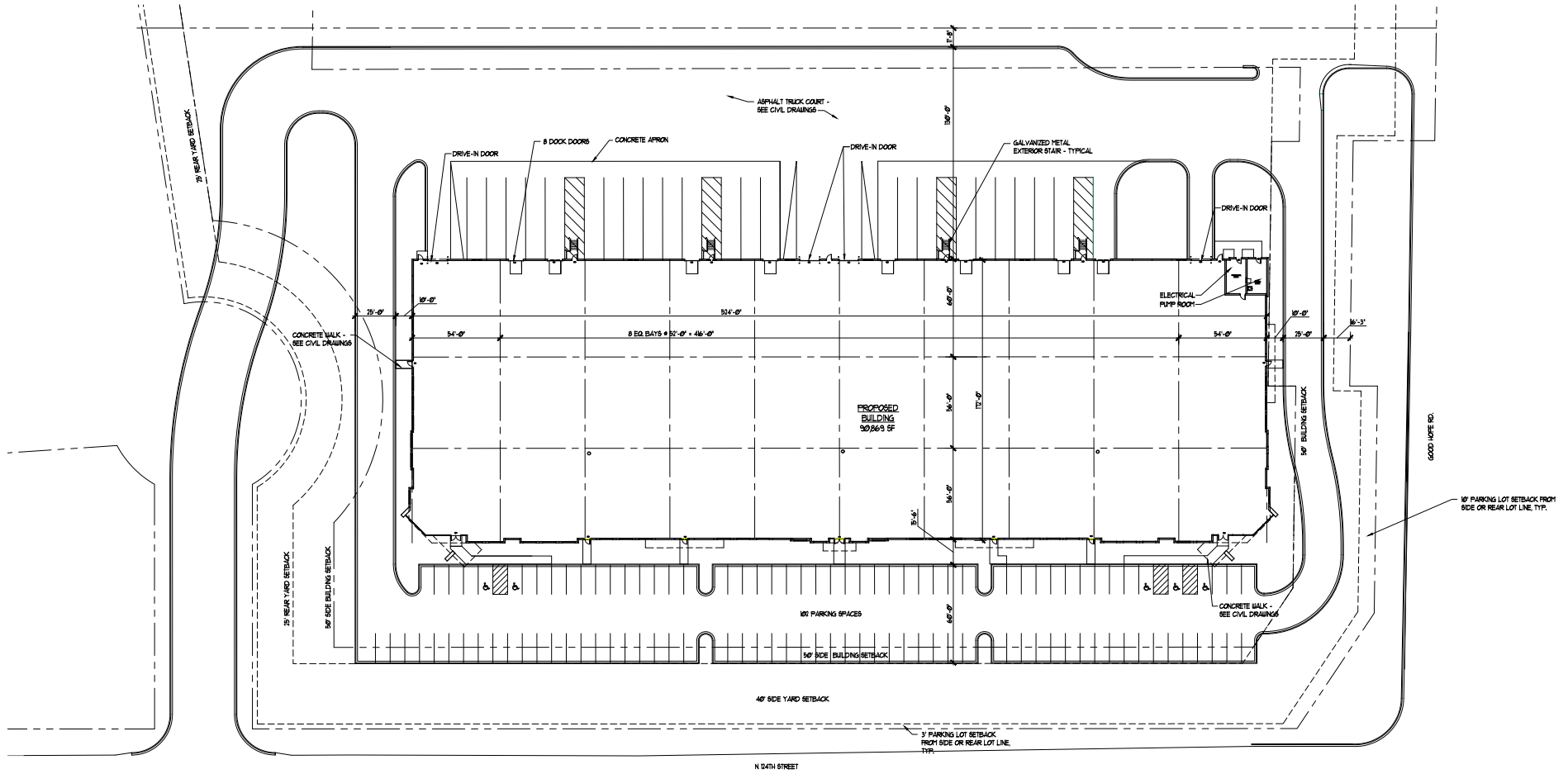

## DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS
