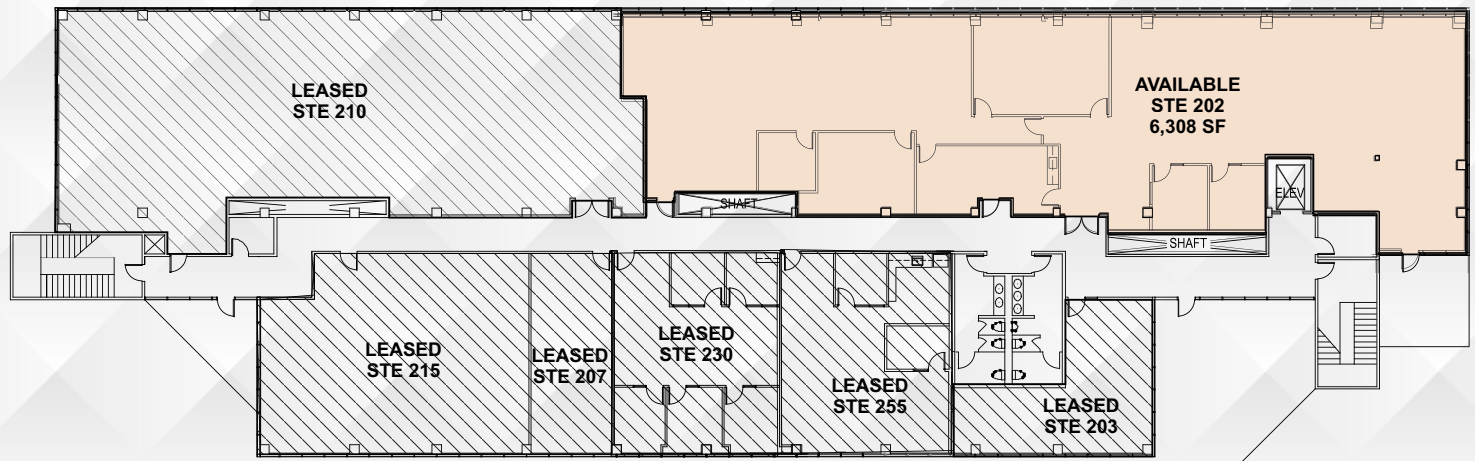
AERIAL MAP

FLOOR PLANS

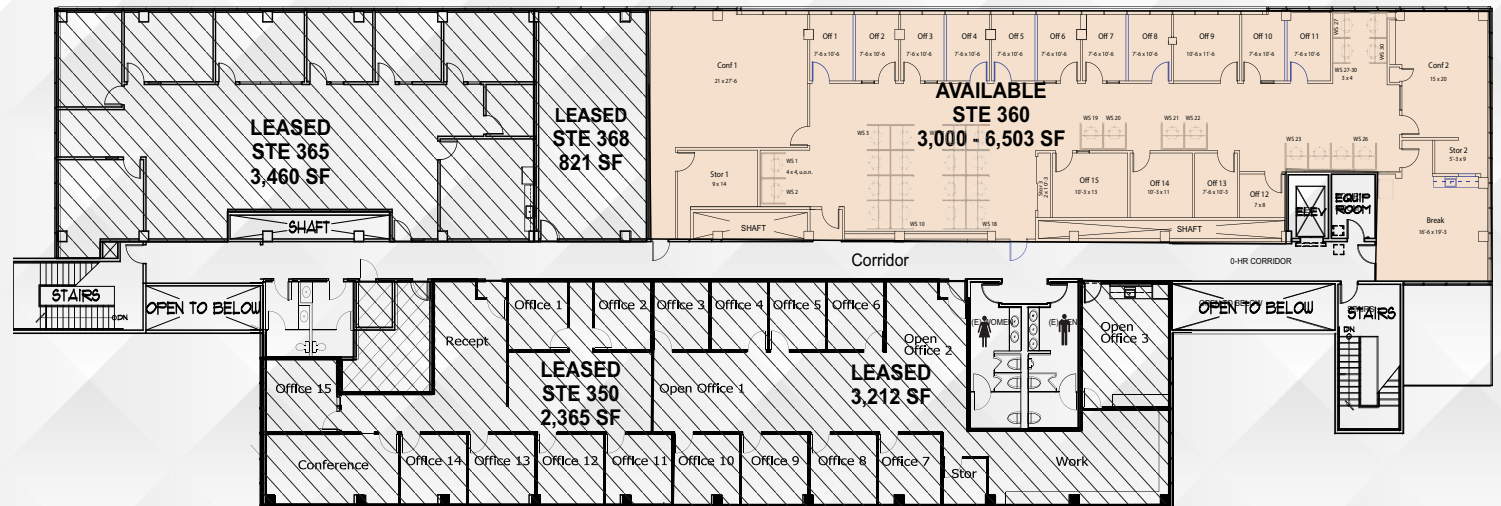


BUILDING 1 | SECOND FLOOR

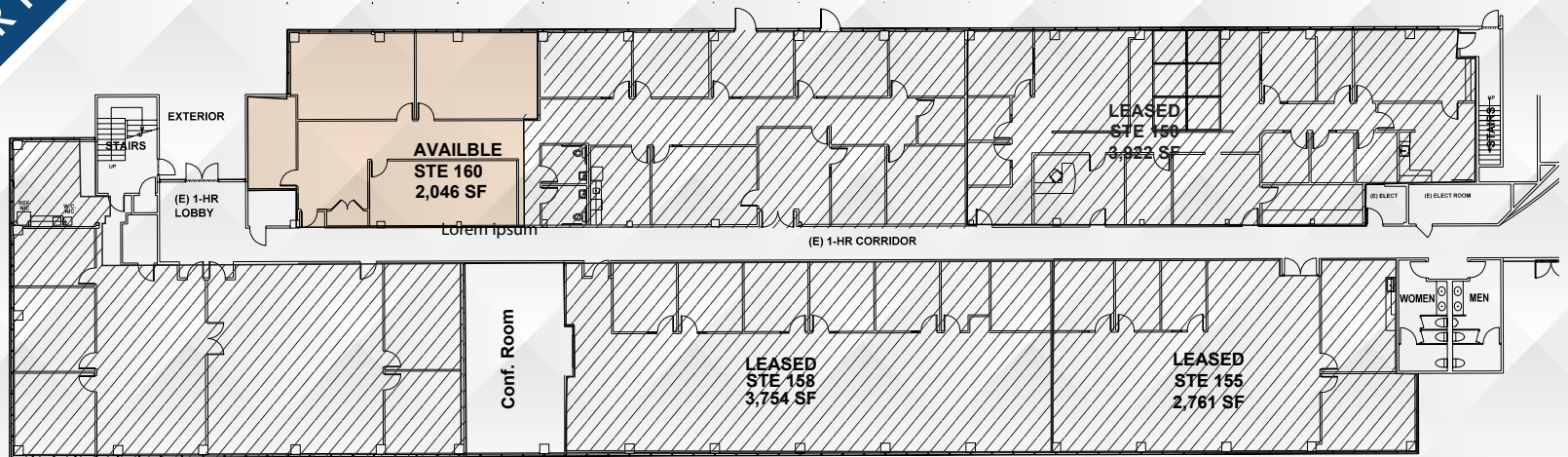


BUILDING 1 | THIRD FLOOR

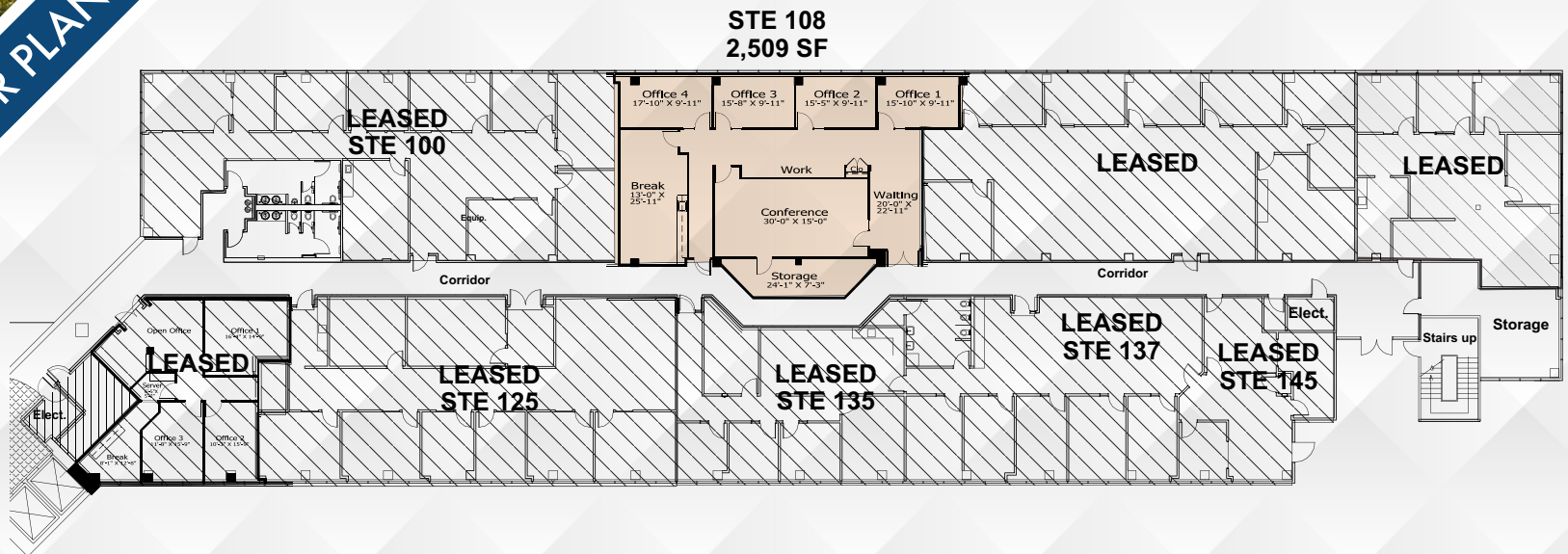


BUILDING 2 | SECOND FLOOR
