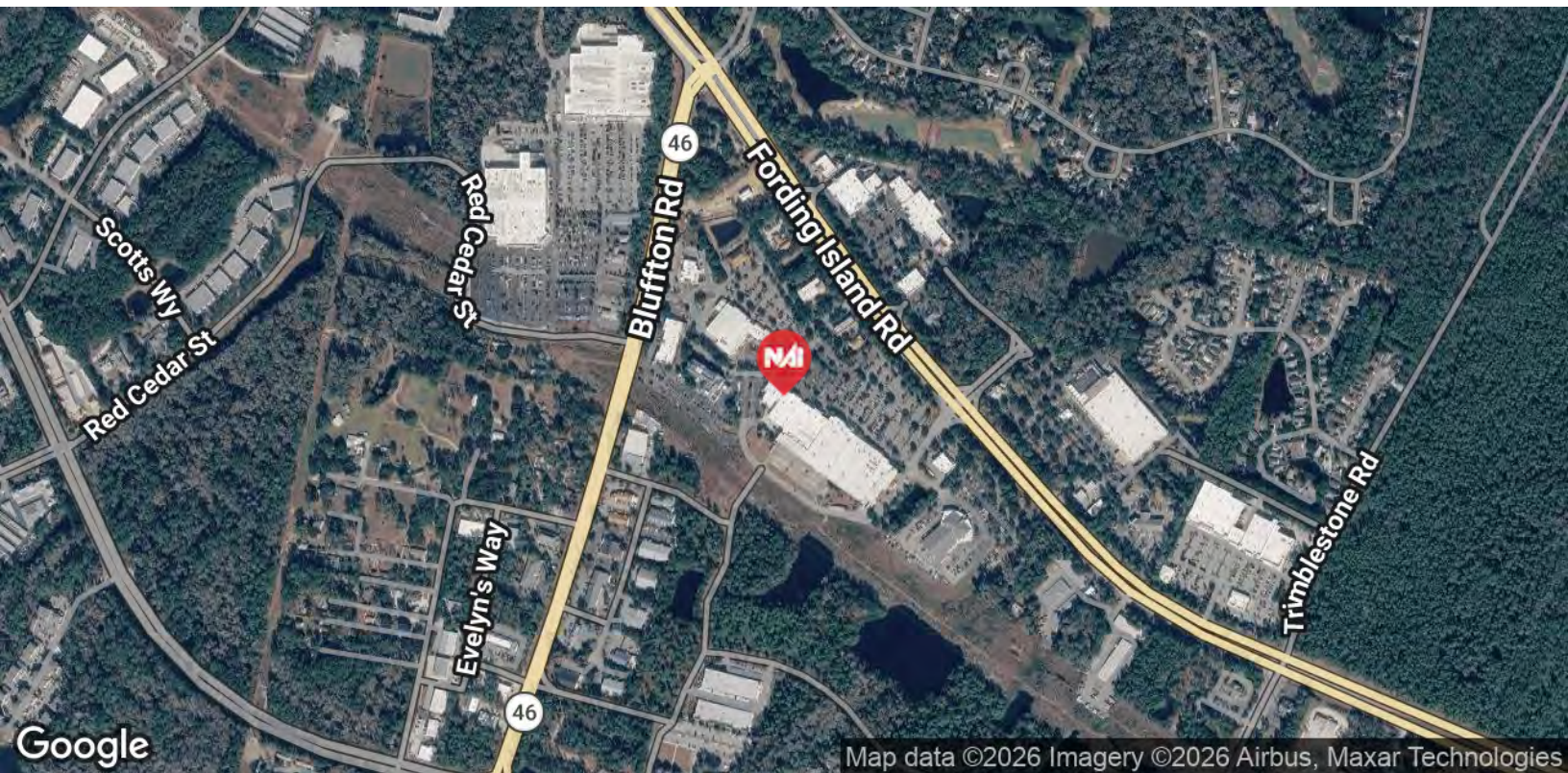
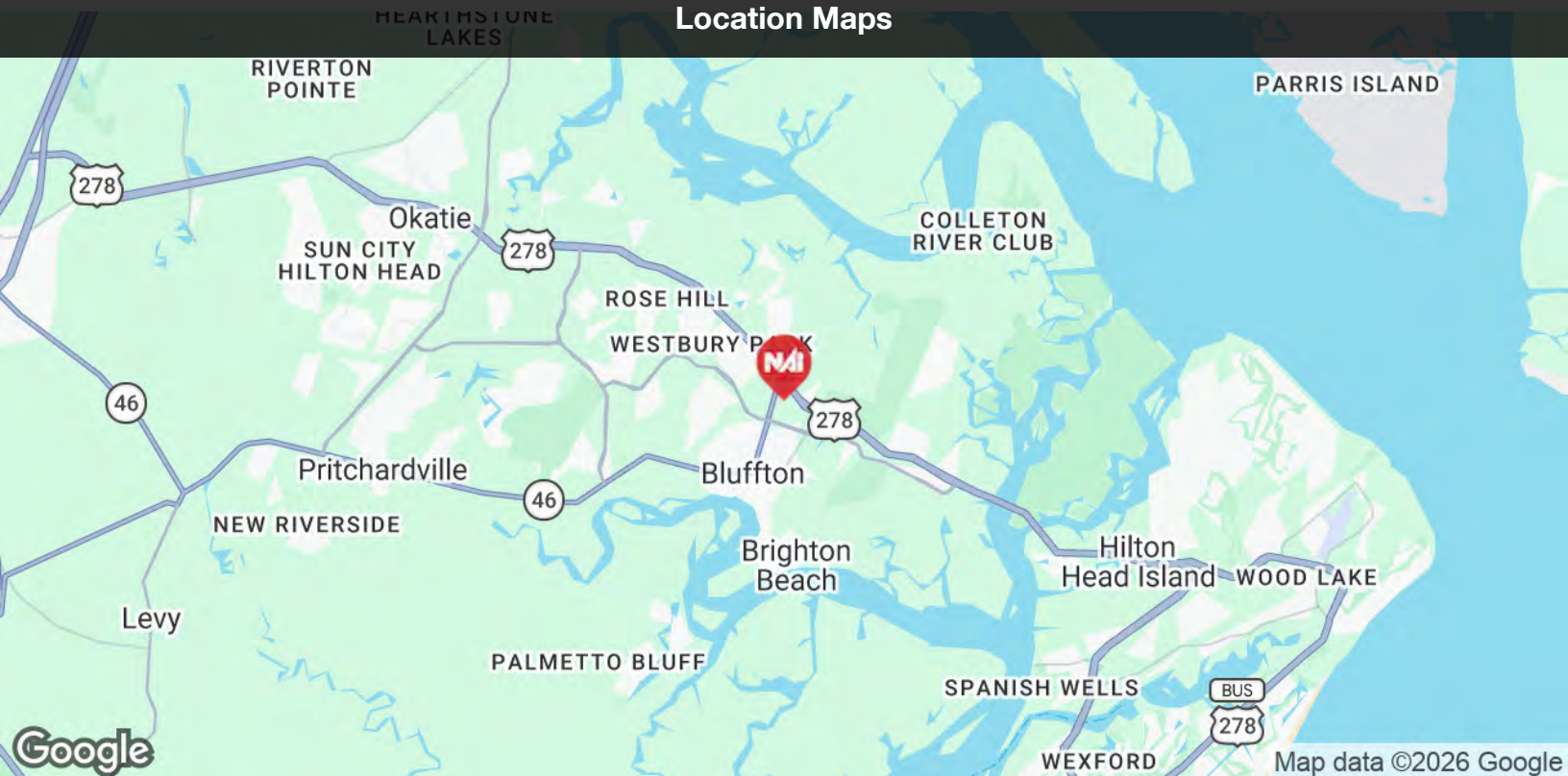

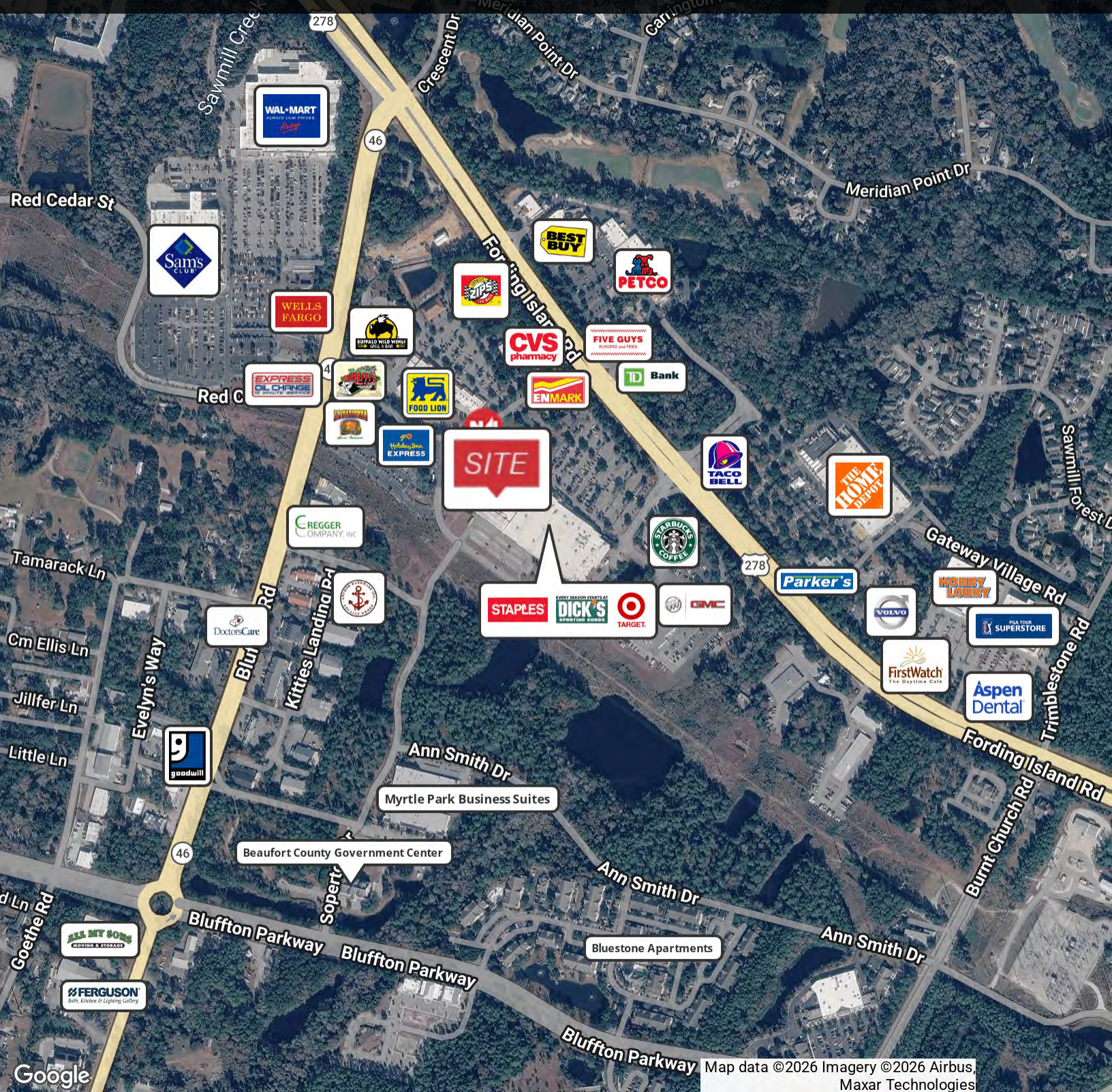
Location Maps

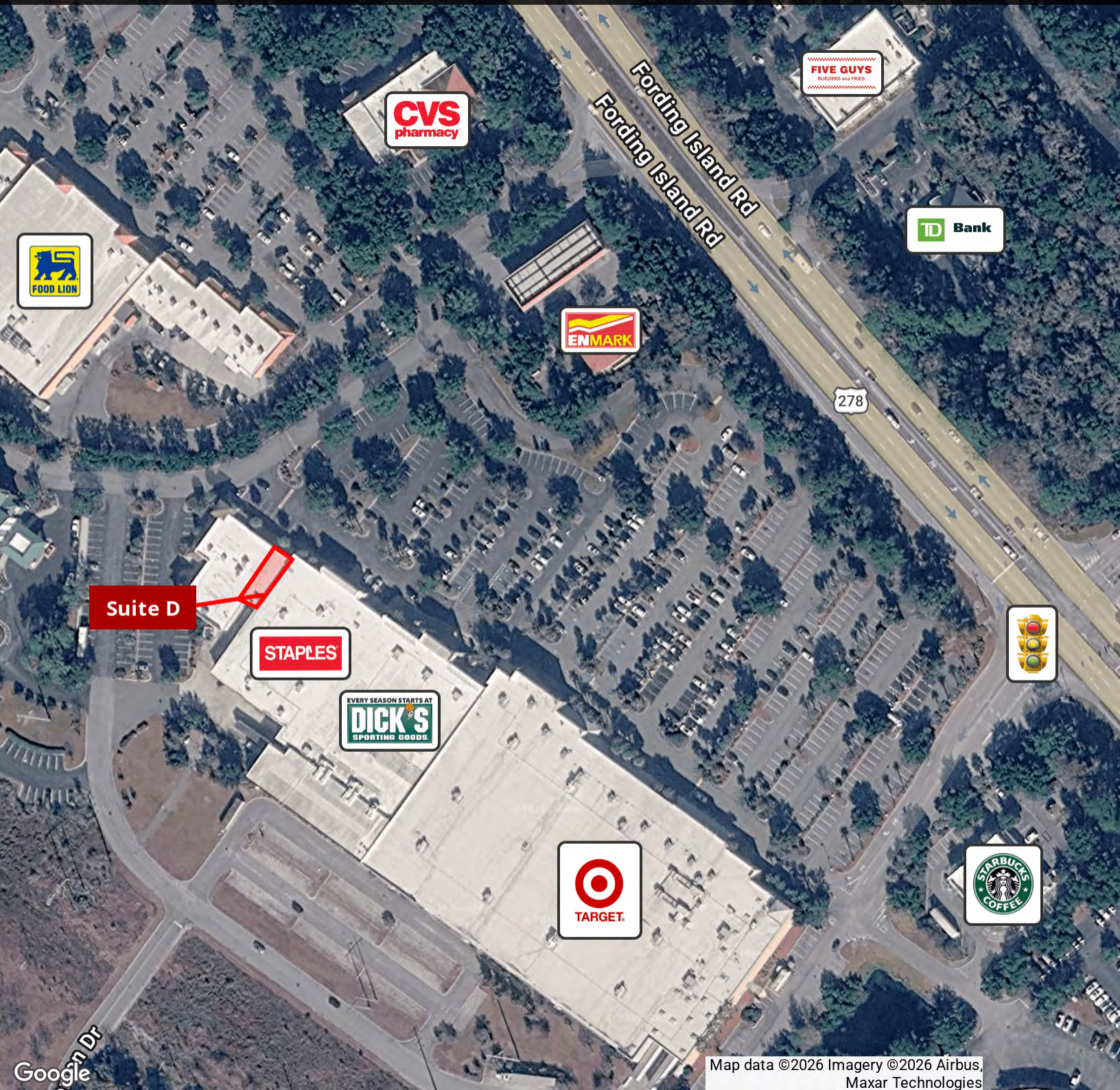
Target Shopping Center Site Plan

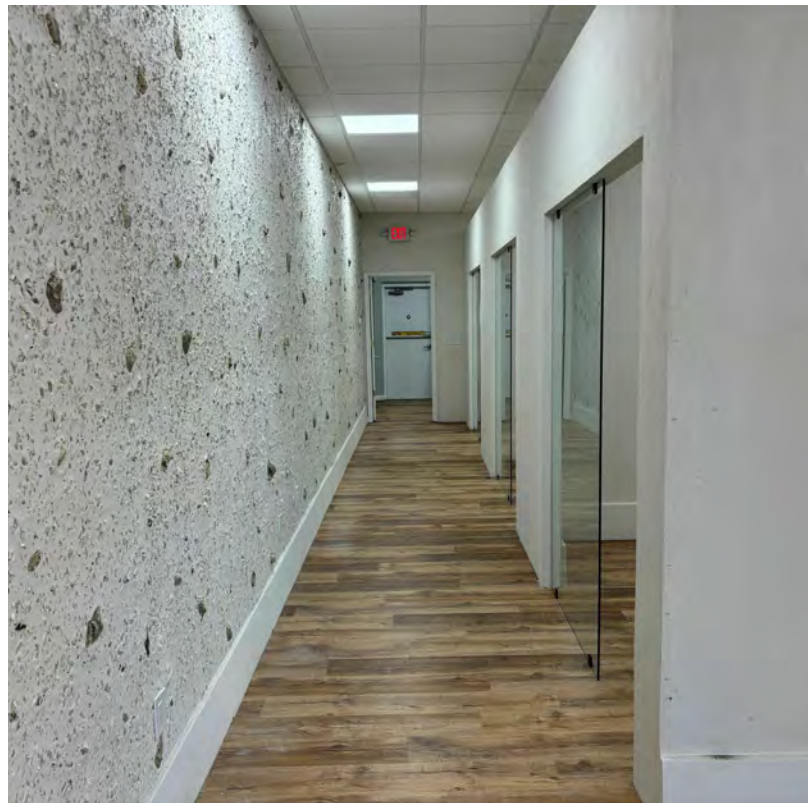
