FOUNDATION

The foundation consists of a reinforced concrete slab-on-grade with integral perimeter footings, interior footings and column pad footings bearing directly on the soil.

PROPERTY OVERVIEW



FACADE

The exterior walls are finished with a combination of brick veneer and metalframed curtain wall system. The curtain wall has horizontal bands of tinted glazed vision panels. The spandrels are finished with horizontal bands of opaque glazing or brick veneer. Building sealants (caulking) are located between dissimilar materials, at joints, and around window and door openings.

MODERNIZATION 2017

• Install LED lamps, including A-type, MR-16, and P38, to replace existing CFL and incandescent lamps throughout entire building

- Occupancy sensors for lighting control
- Two (2) New Roof Top Units (RTUs)
- New controls in remaining Three RTUs

• Replace Vortex Damper with Variable Frequency Drive (VFD). Both technologies control the air volume passing through the RTU, but VFDs adjust the speed of the motor and provide additional energy savings

- Aesthetic Upgrades with Landlord's full control of design and specifications:
- modernize Common Area bathrooms and Common Area flooring

ELEVATORS

There are two new hydraulic passenger elevators installation commenced 4th Quarter 2017. These elevators will be placed in service and installation complete in the first Quarter 2018

HVAC

Five individual electric rooftop package units ranging from 27-60 tons. Several of these units have been replaced over the past few years.
