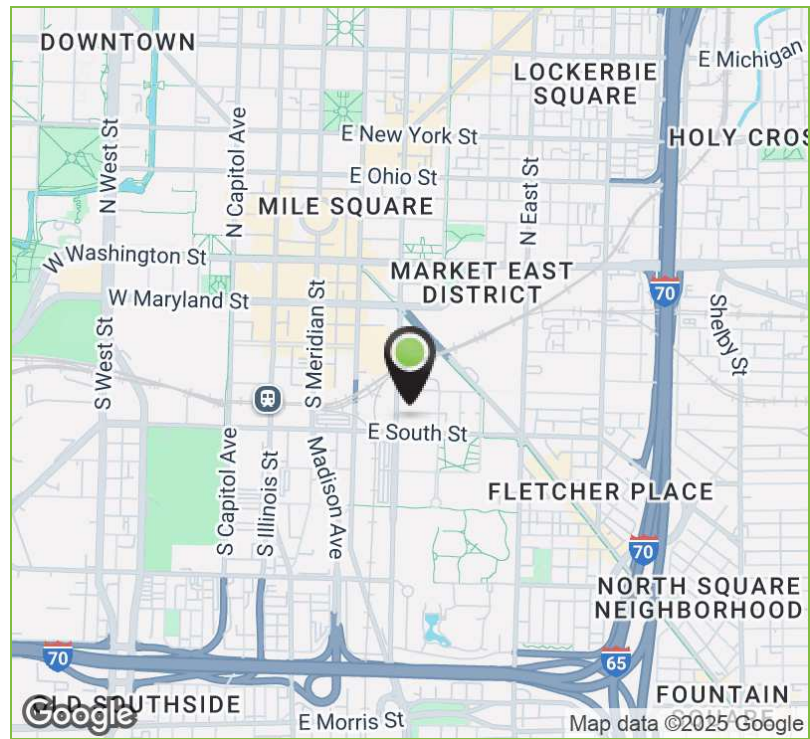

## PROPERTY DESCRIPTION

The site is designed to connect surrounding neighborhoods, districts and the various corporate campuses. CityWay recently completed its second phase, CityWay 2.0, adding 5 acres to the mixed-use development. Now CityWay has an additional 29,000 SF of retail, 5,400 SF of amenity space, 10,000 SF of office space and 450 additional apartments.

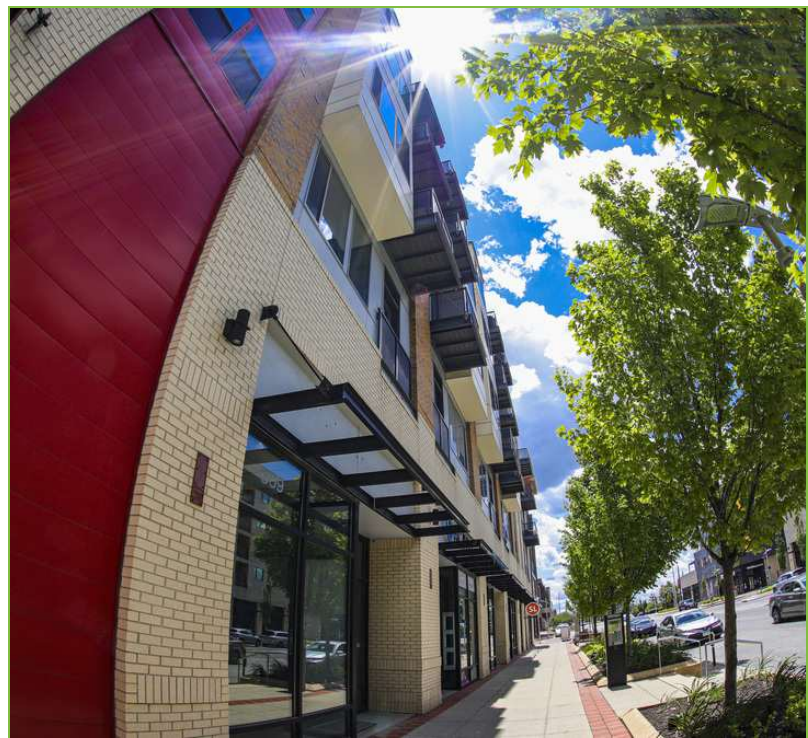
