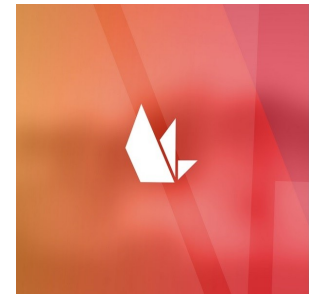

The existing improvements consist of a one-story, masonry retail shopping center, comprised of approximately 46,894 sqft of gross leasable area and is situated on a 6.301 acre or 274,461 sqft site. The property is located within the town limits of Batesburg-Leesville, in Lexington County, South Carolina, and is on the northern side of West Columbia Avenue, just west of its intersection with Mitchell Street.

The center is comprised of 5 small shop spaces consisting of 11,907 sqft and one anchor space of 35,032 sqft. All of the small shop spaces are leased and occupied. The anchor space is vacant.

The subject property is 25% occupied with the current leases producing gross annual rents around \$100,000.00 annually. Majority of the existing tenants have a long standing operating history of 5+ years at this location.

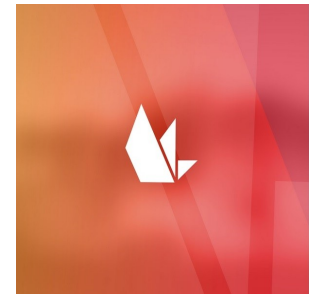

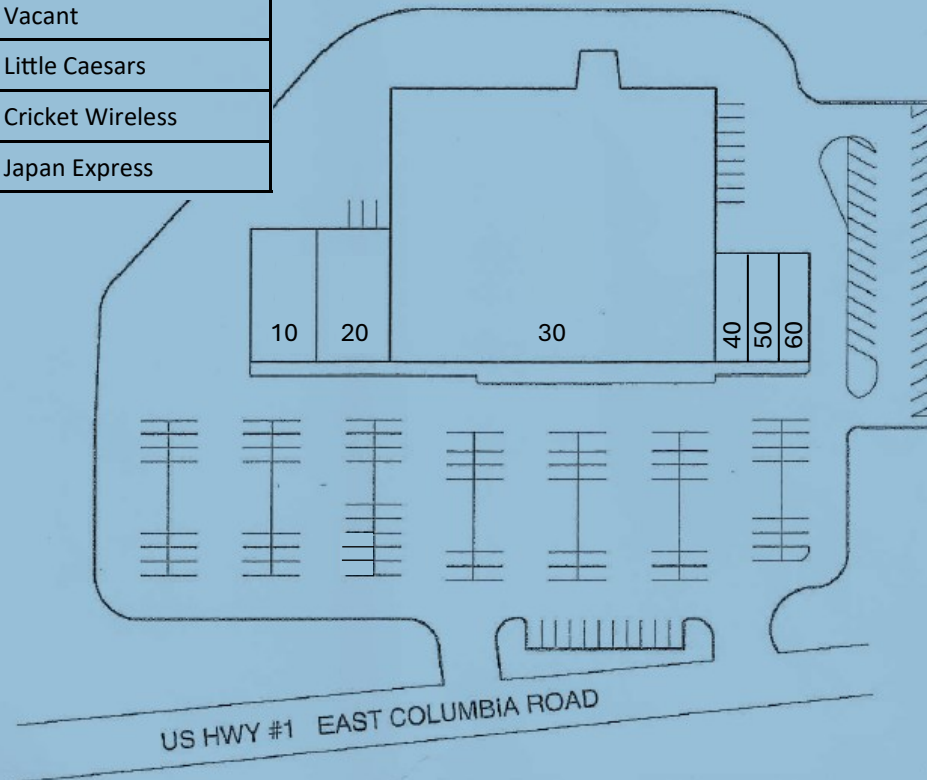

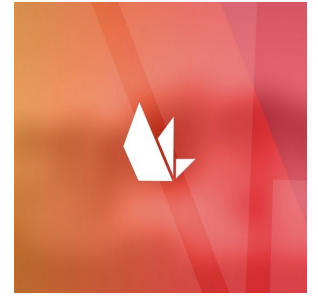
