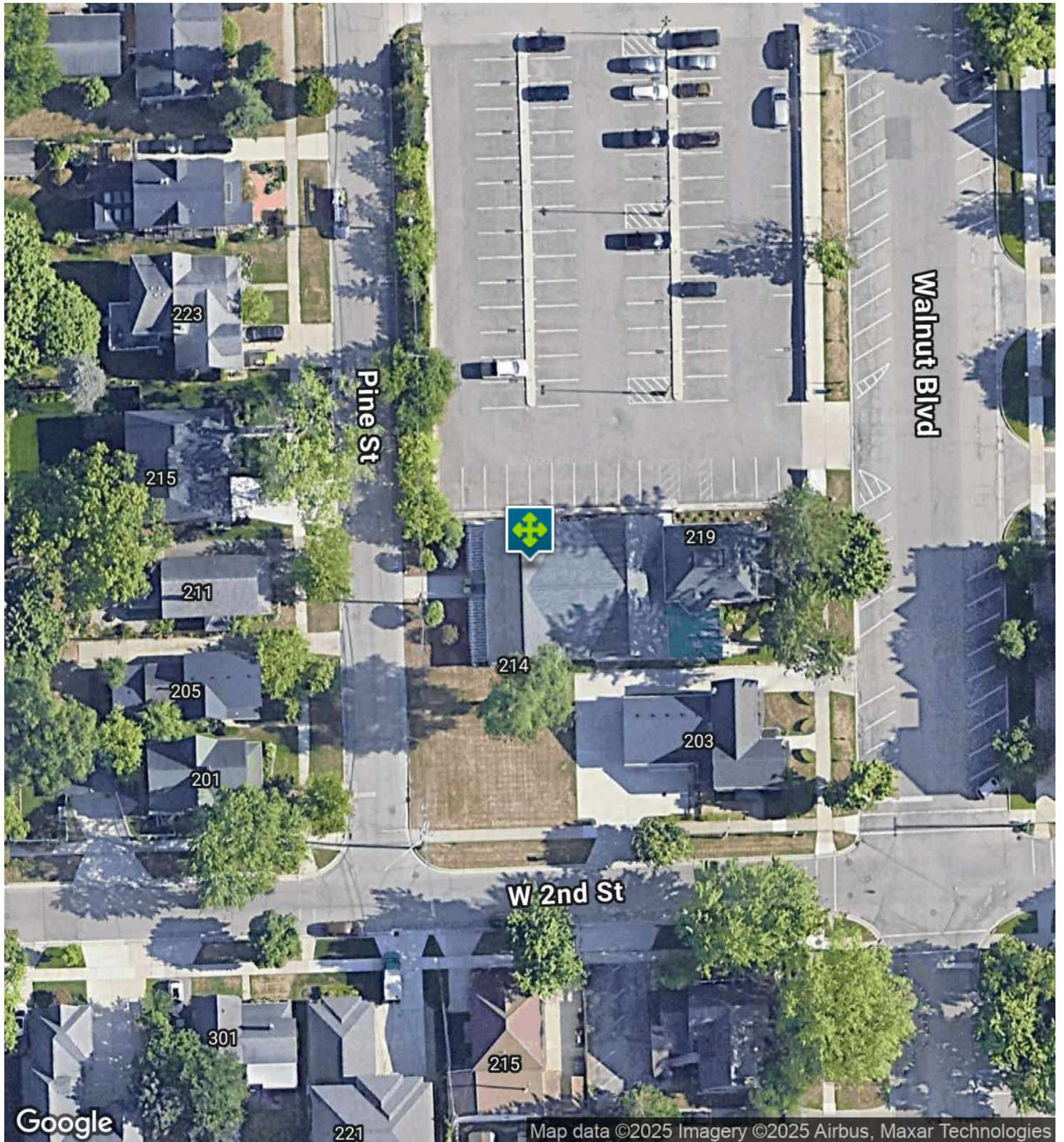

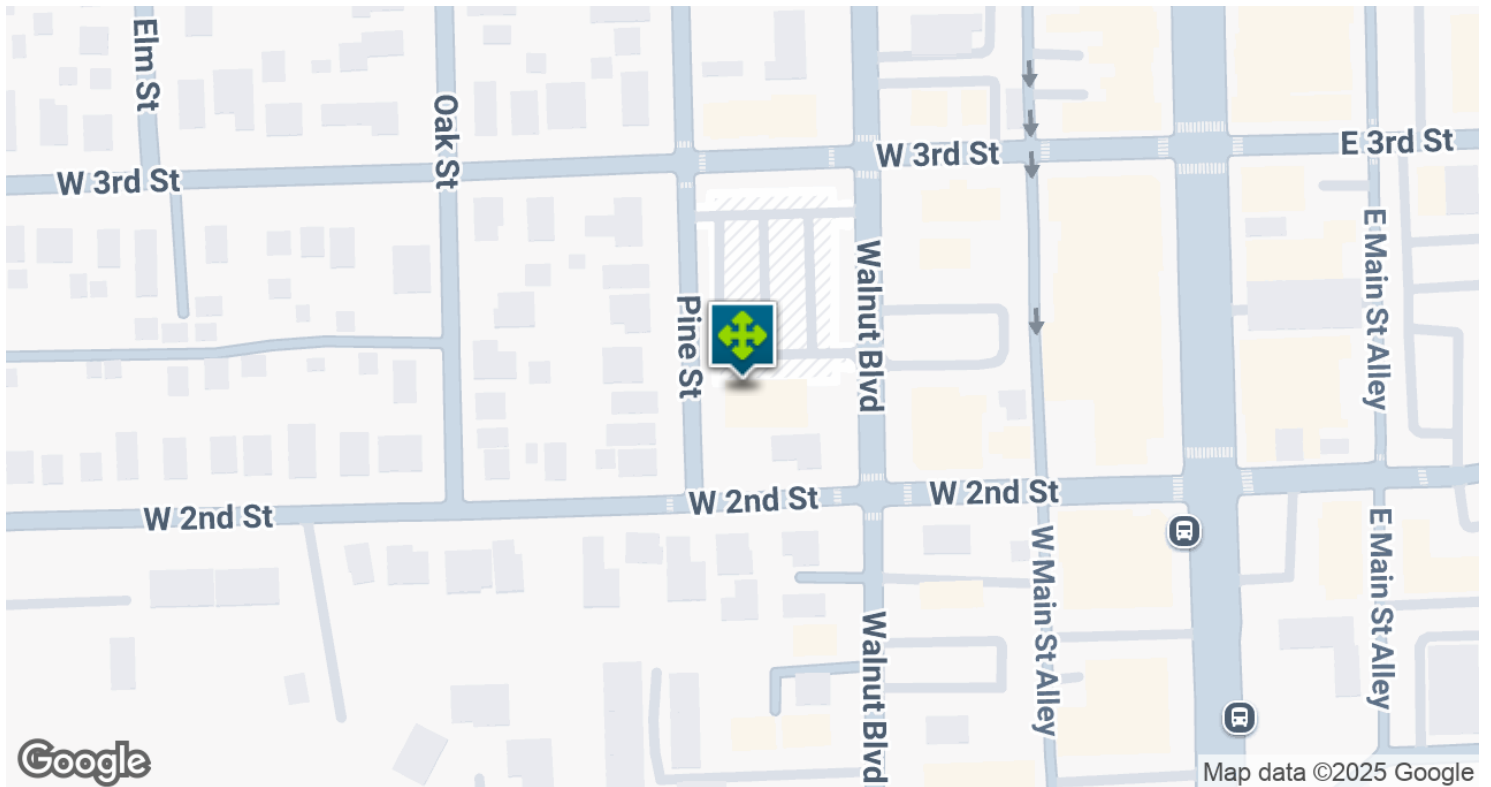

LOCATION MAP



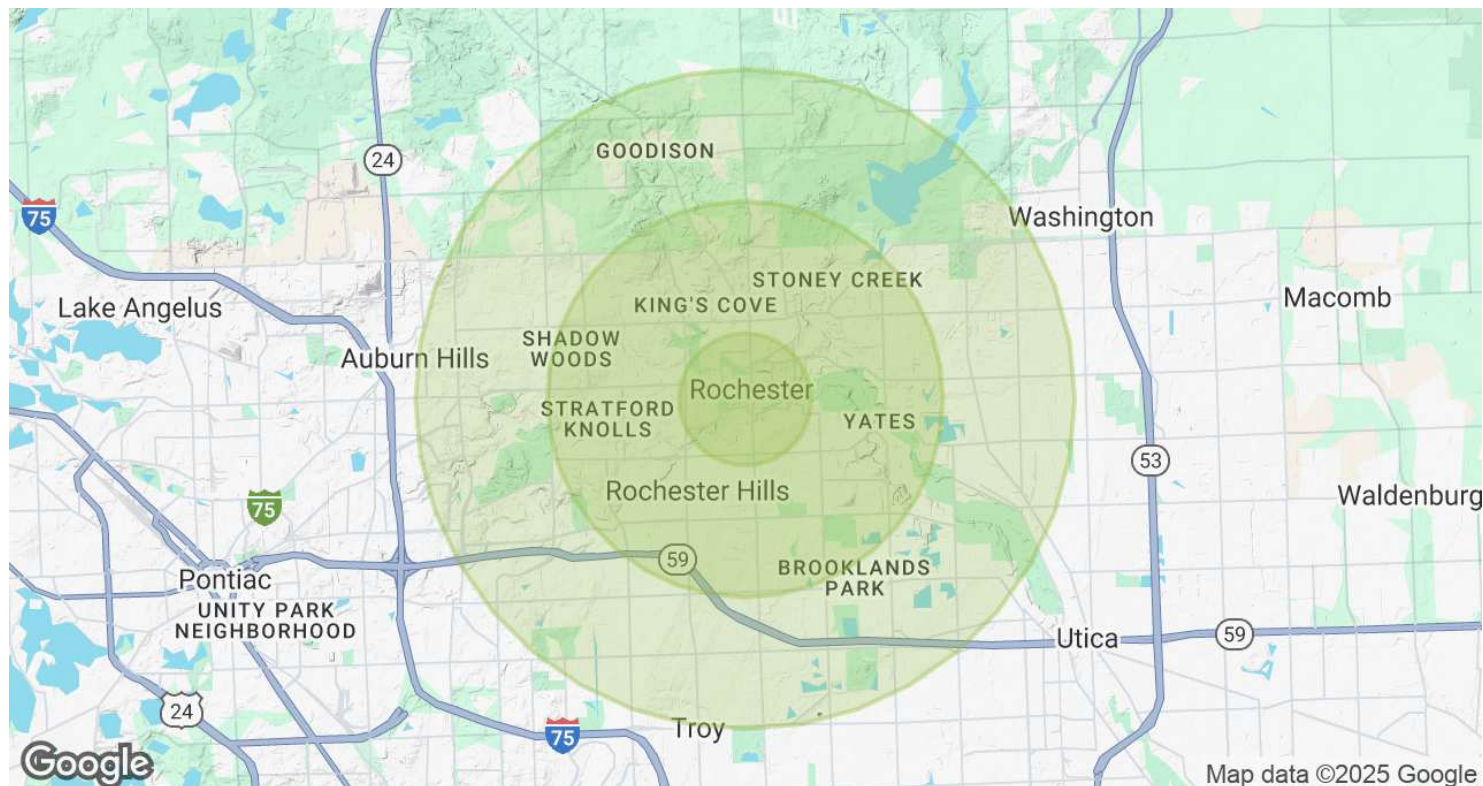
