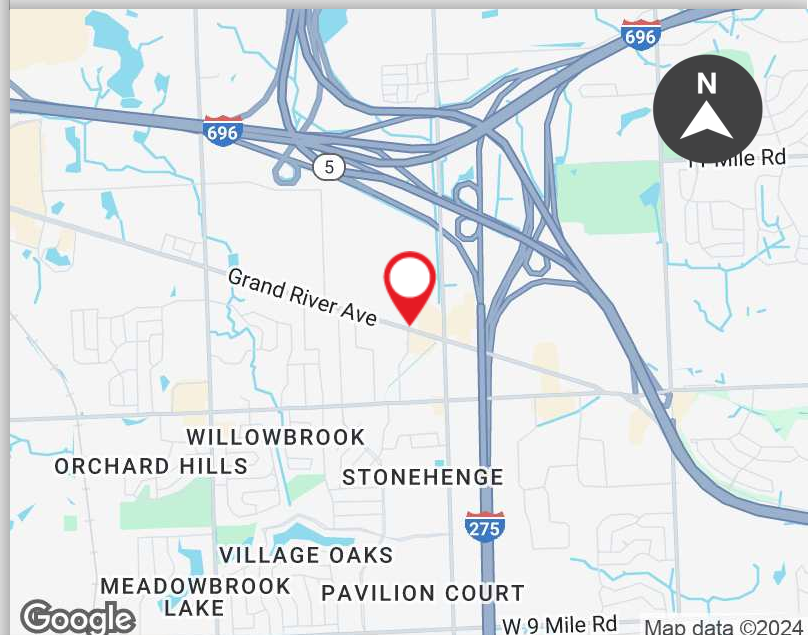

Rent is quoted on a triple-net (NNN) basis excluding building taxes, building insurance and common area maintenance expenses. NNN charges are estimated to be approximately \$4.49 per SF per year and shall be billed to Tenant on a monthly basis. Rental rate is subject to a 3% annual increase. Quoted rent is for "as is" space, subject to length of lease, leasehold improvements, etc. Gas and electric are separately metered and are the responsibility of the tenant.

INCENTIVE PACKAGES

Tenant Promotional Package:

All qualified Tenants who execute leases on or before December 31, 2024 shall receive enhanced Leasehold Improvement packages and rental abatement (outside of the lease term). Incentives are subject to Tenant's financial condition, length of Lease, and defined Leasehold Improvements.

Procuring Broker Promotional Package:

All procuring brokers shall receive a five (5%) percent commission for years 1-5, and 2.5% for years 6 through 10 based upon the aggregate NNN rent to be paid, in full, upon Lease execution for all leases executed on or before December 31, 2024.
