## PROPERTY OVERVIEW

Located in the Opportunity Zone and minutes from Fairchild Air-force Base, Walmart Supercenter, Spokane International Airport, Amazon Distribution Plant, and Interstate 90.

All 71 acres are outside of the restrictive Airport Overlay zone tht rescripts the uses of many nearby land developemnts.

As of today there is 5-7.5 MVA available in this area, in 2 years +/- a new substation will be built and that number will jump to 40-80 MVA.

Spokane Airport has just built a truck/rail loading facility just a mile or two south on Craig Rd.

Another roundabout is planned on the West side of this developemnt along Hwy 2 providing future access to Fairchild Airforce Base. There are also plans for two roads coming to this development from Craig Road from the East.

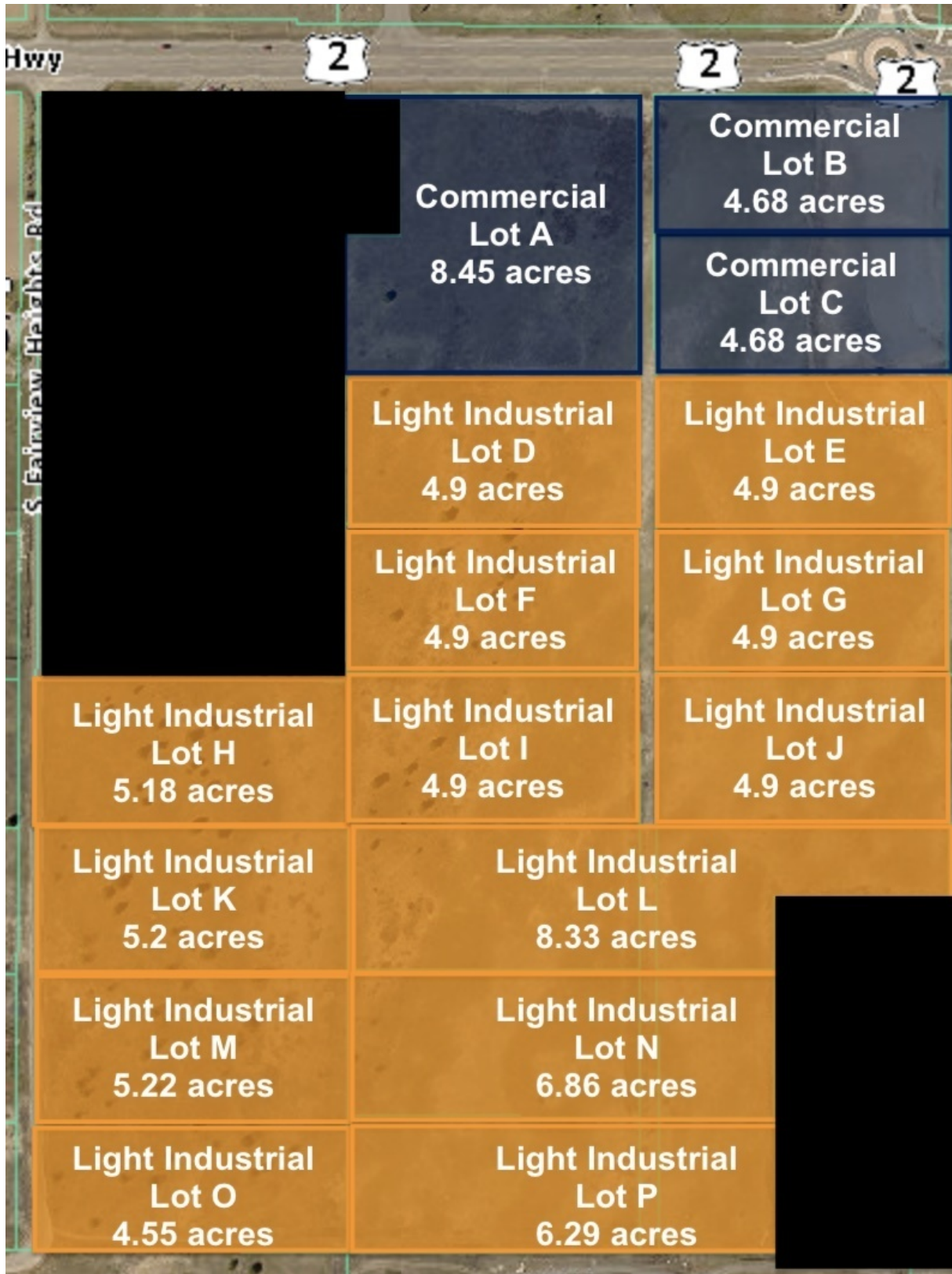
The rough grading already done at this site provides great value for buyers. The Northern portion of the site has had the overlying layer of topsoil stripped and placed in a stockpile. In these areas, the underlying, well graded sand and gravel has been leveled extensively to achieve grades of 1/2 percent, plus or minus. Footing and Pad excavation could commence without the need for additional grading work. The site geological soil classification is medium and coarse sand with gravel and the occurrence of occasional boulders. This soil type will afford the ability to minimize storm water treatment pond area.
