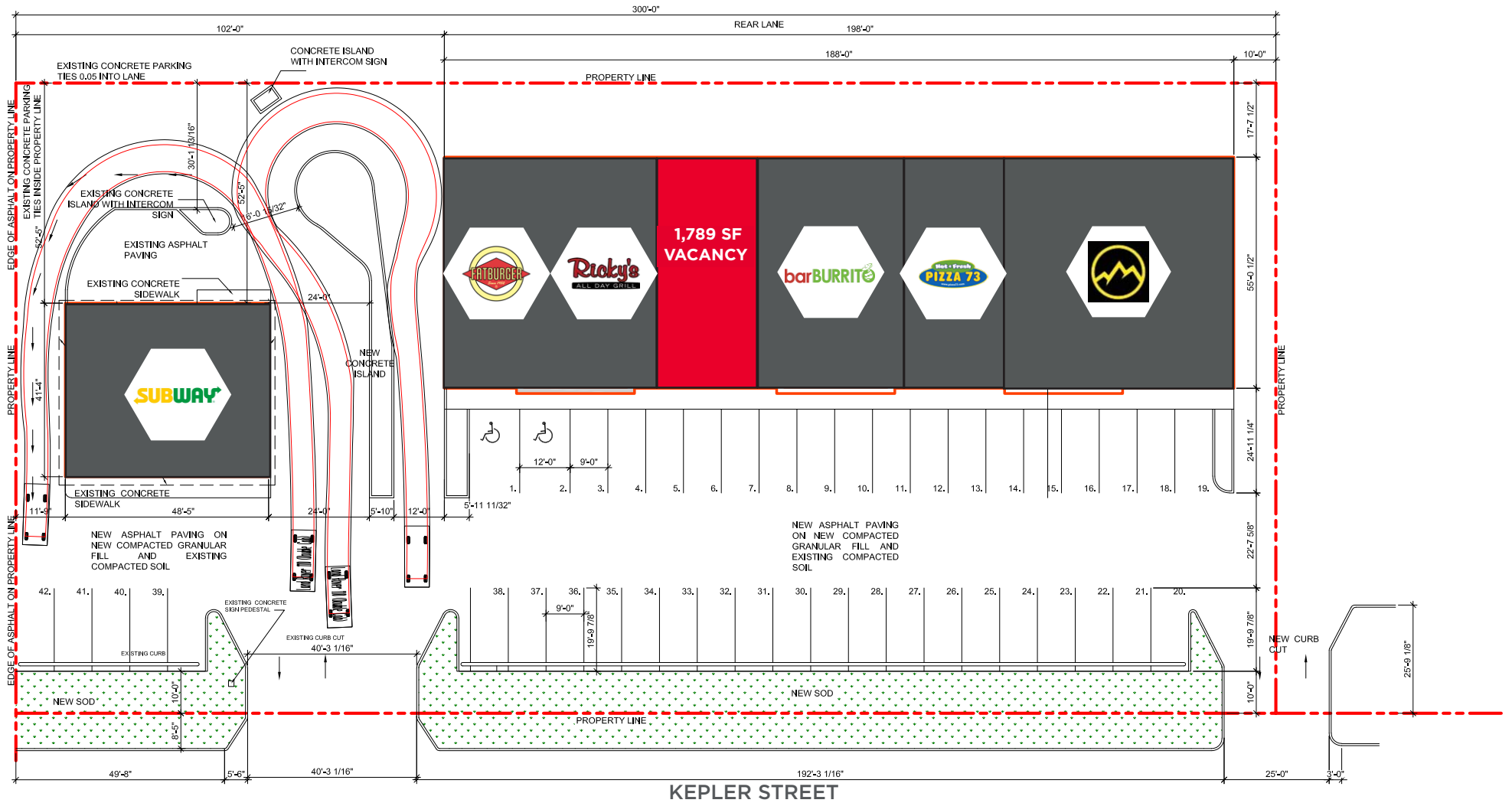

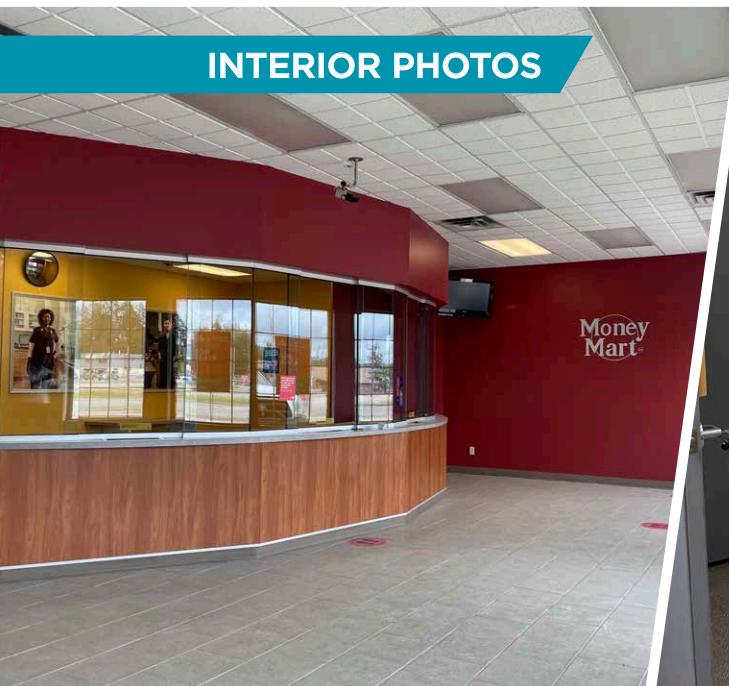
SITE PLAN
