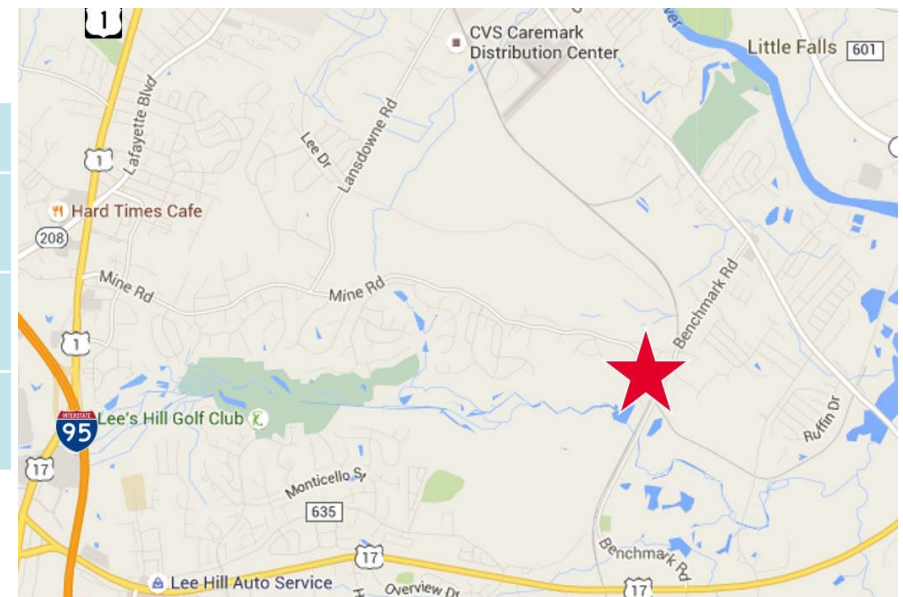

PROPERTY SITE PLAN

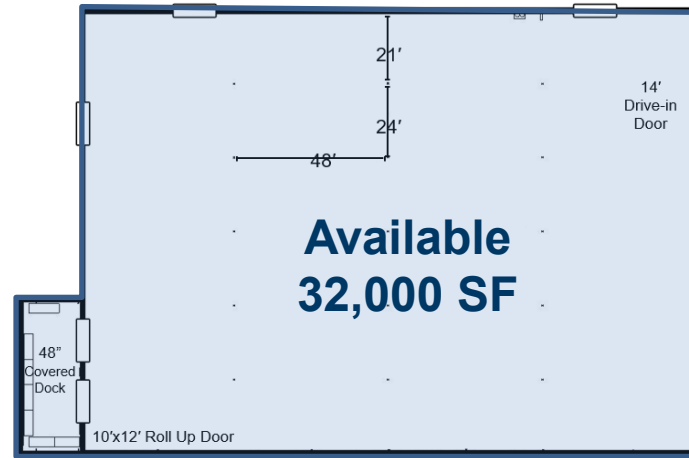

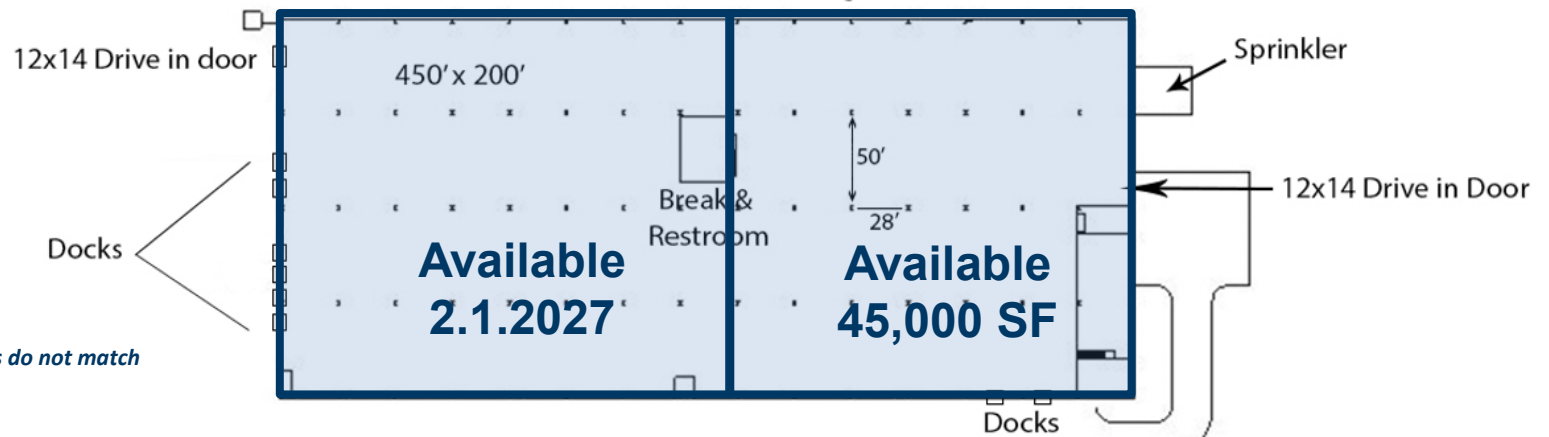
