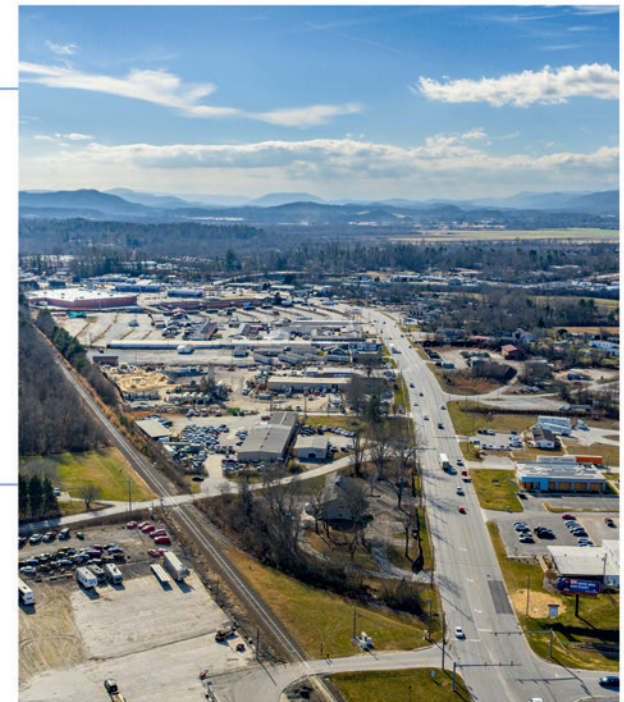

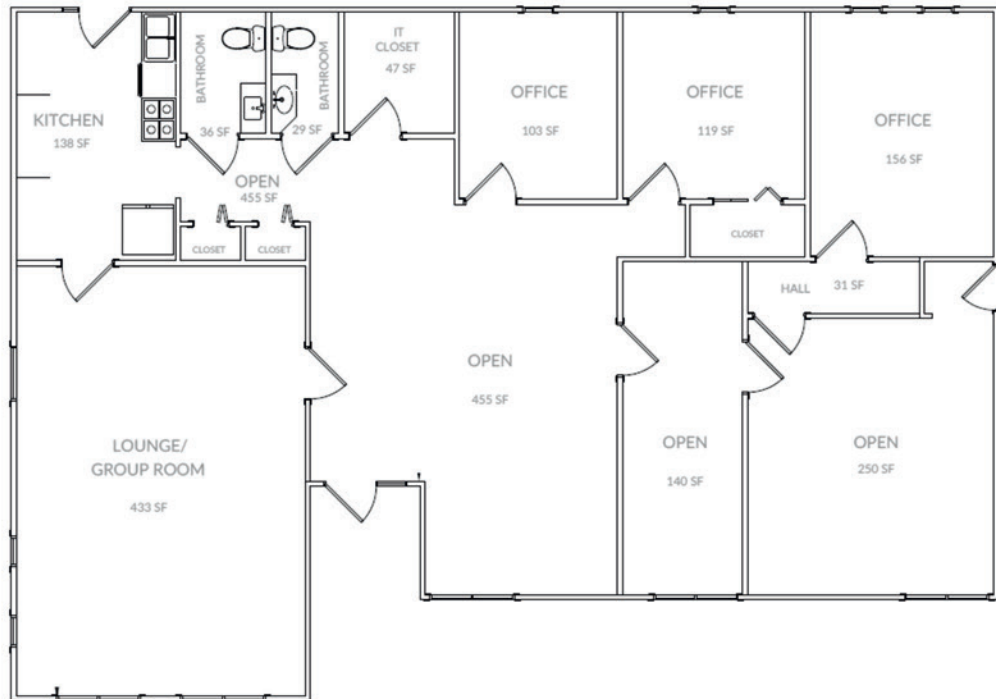




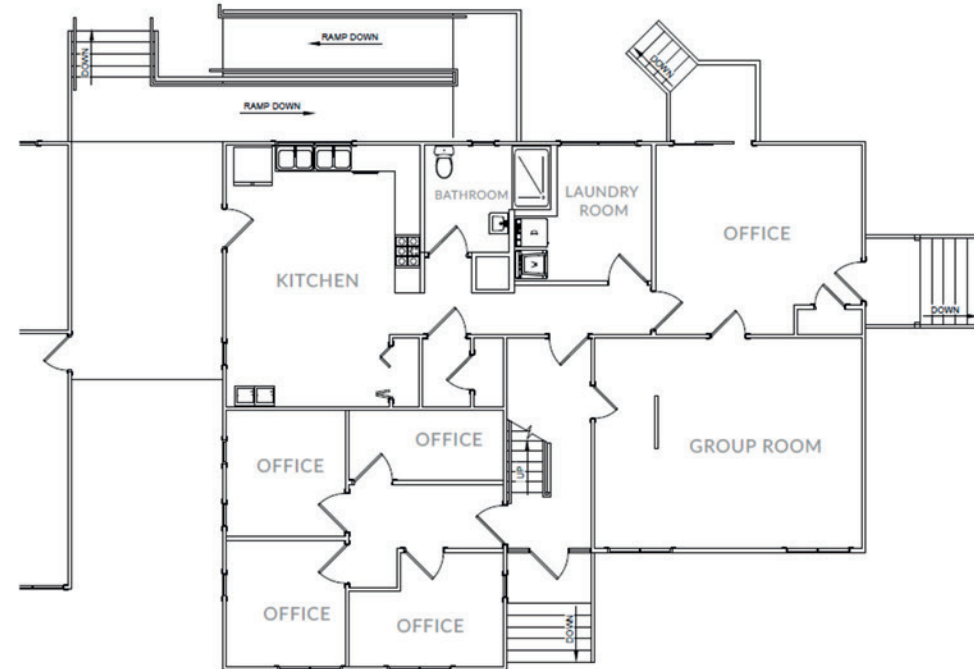

## 1st Floor Left Side



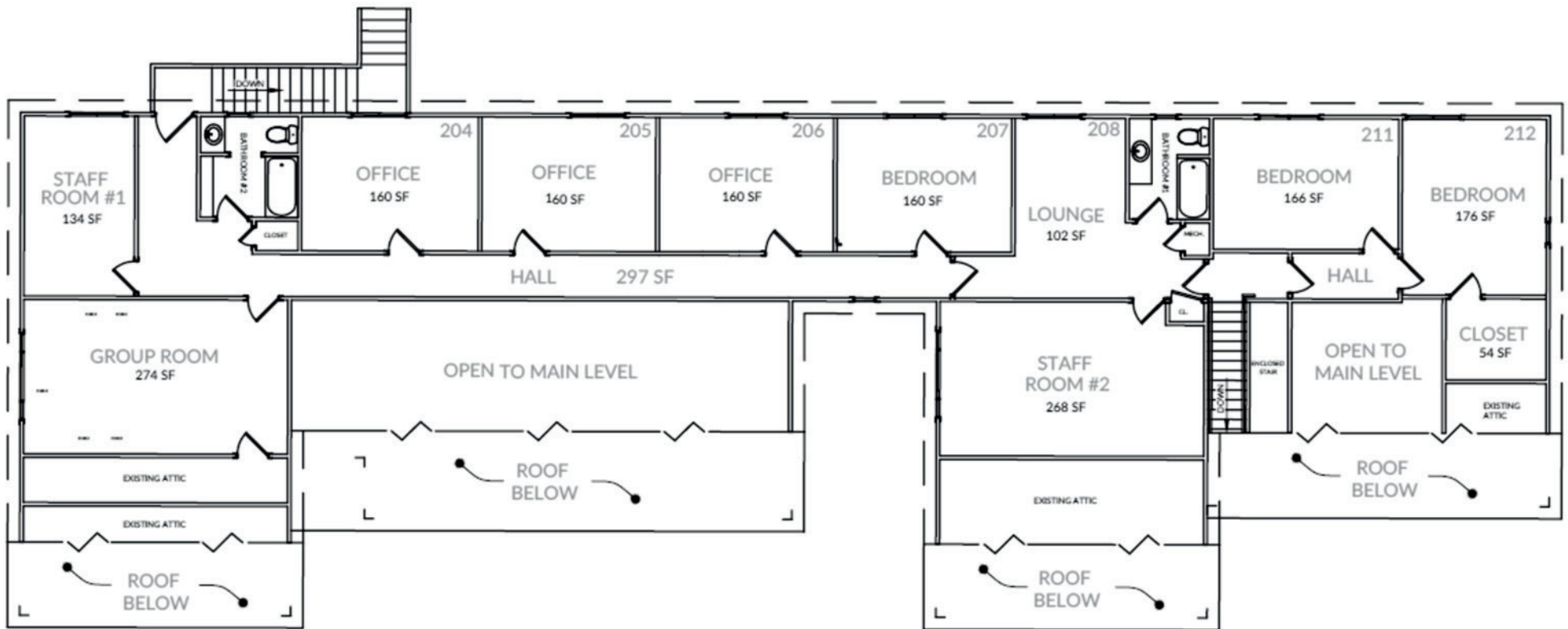
## 1st Floor Right Side

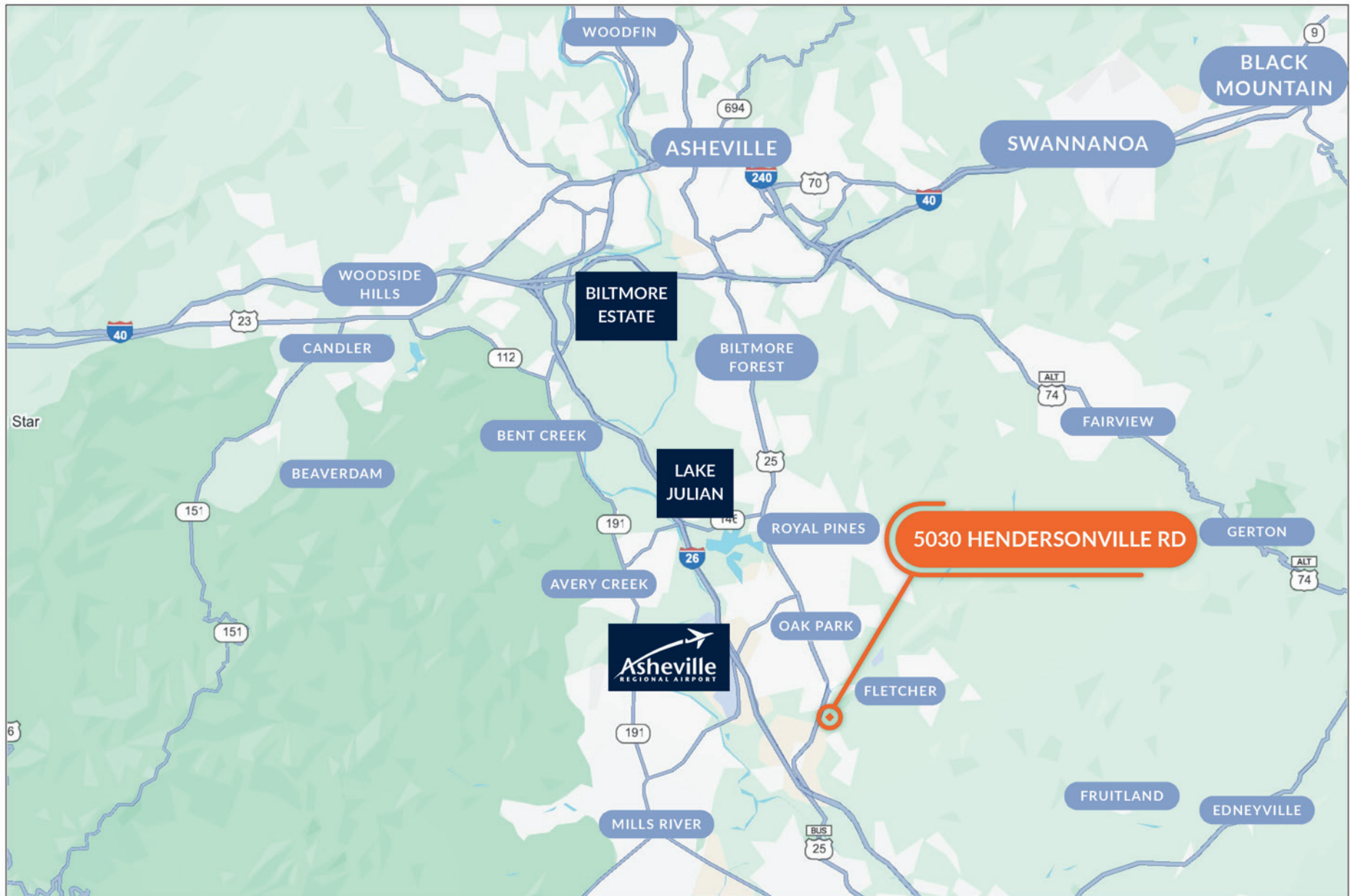
## 2nd Floor
