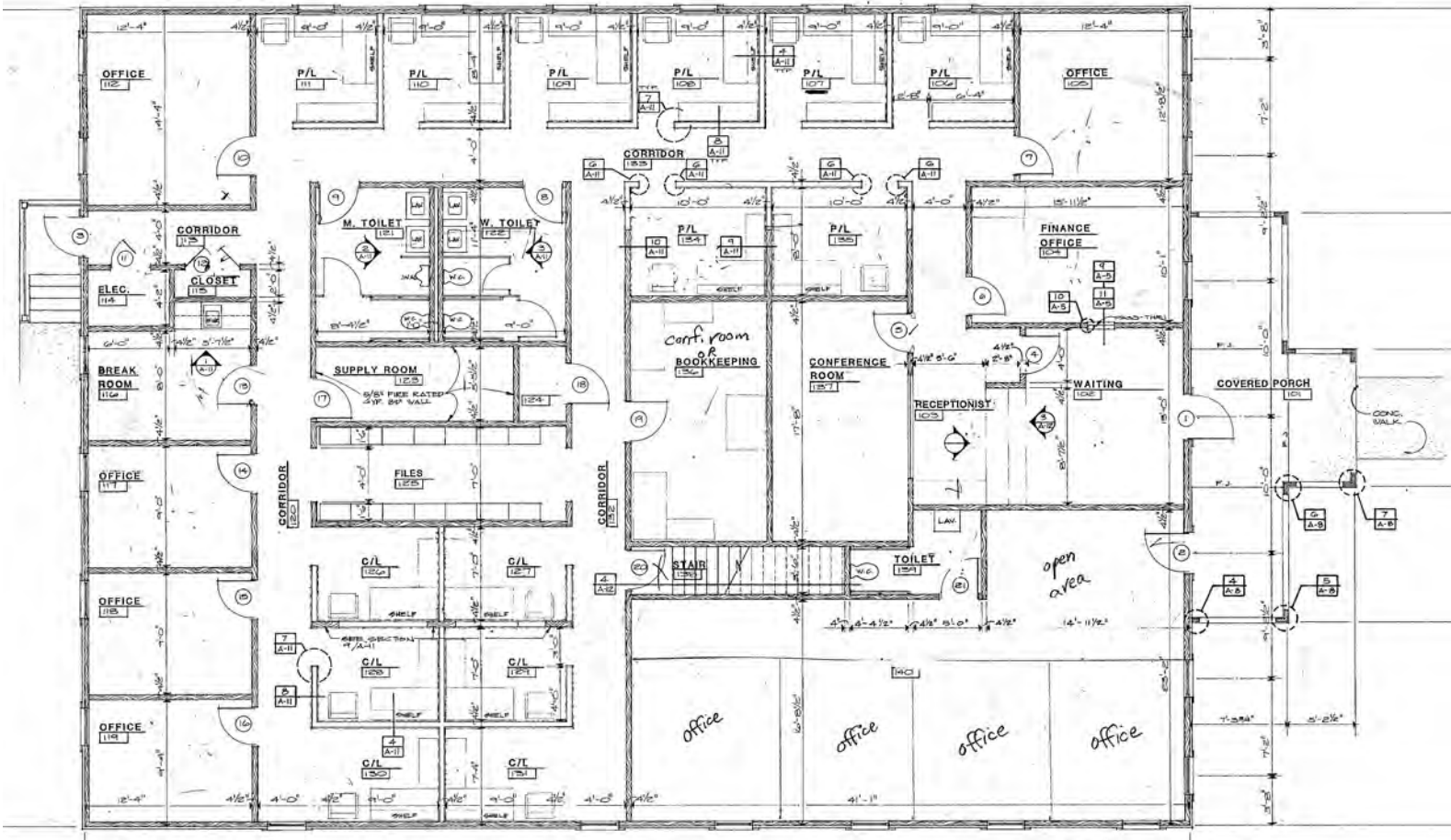

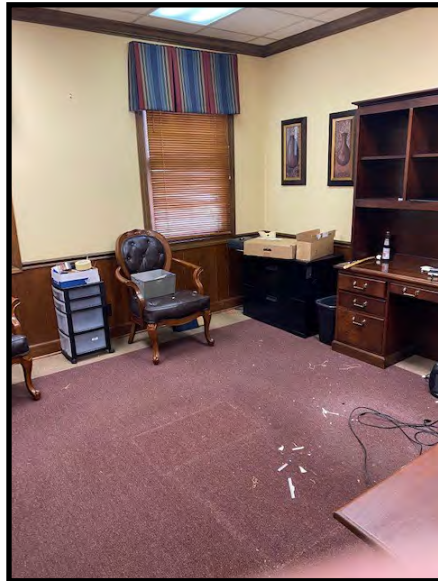

FLOOR PLAN



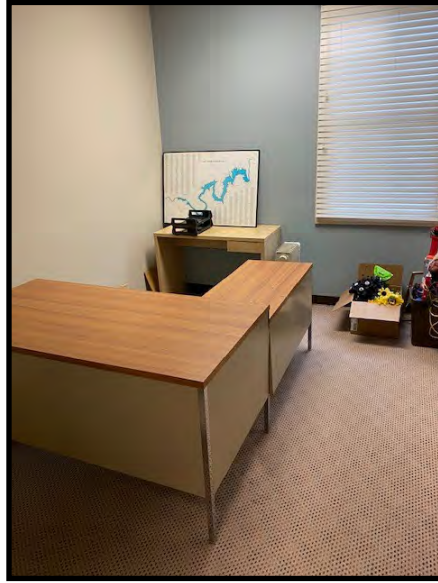

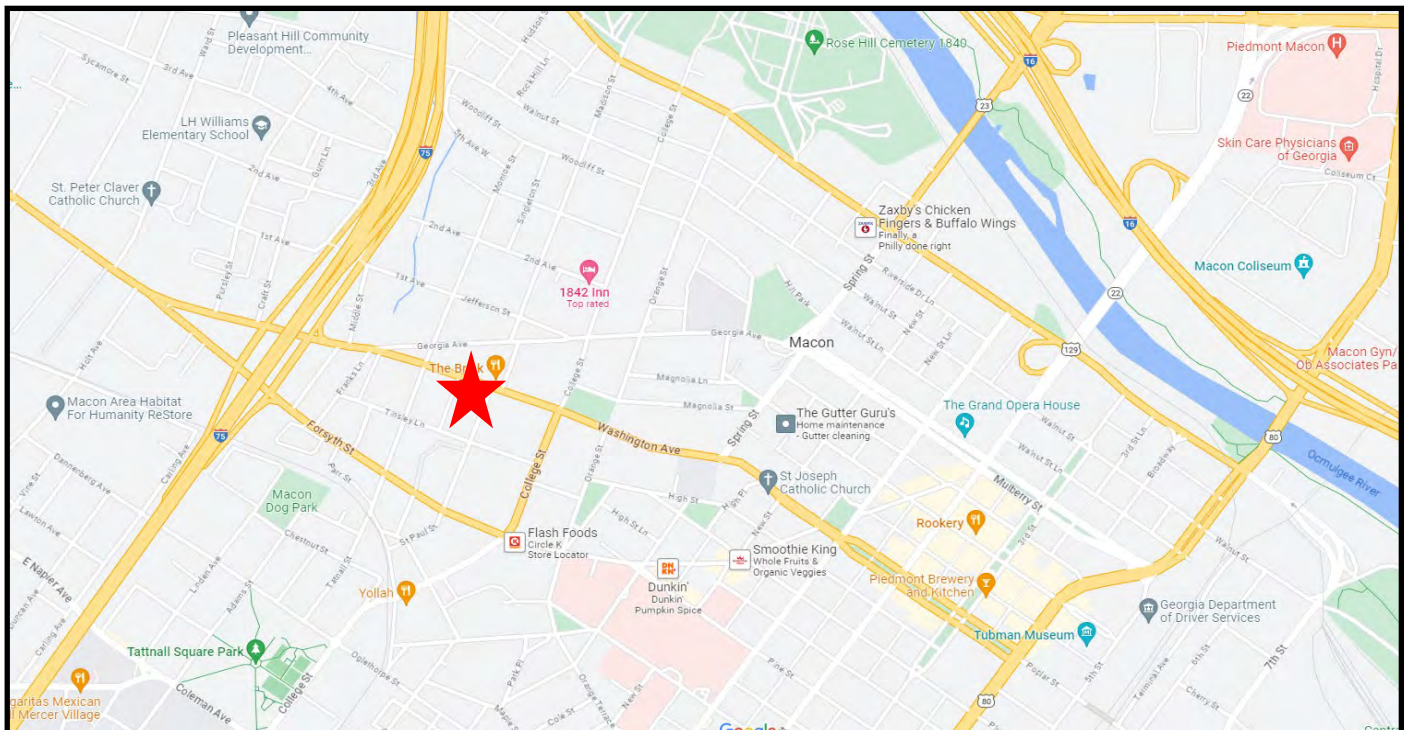
