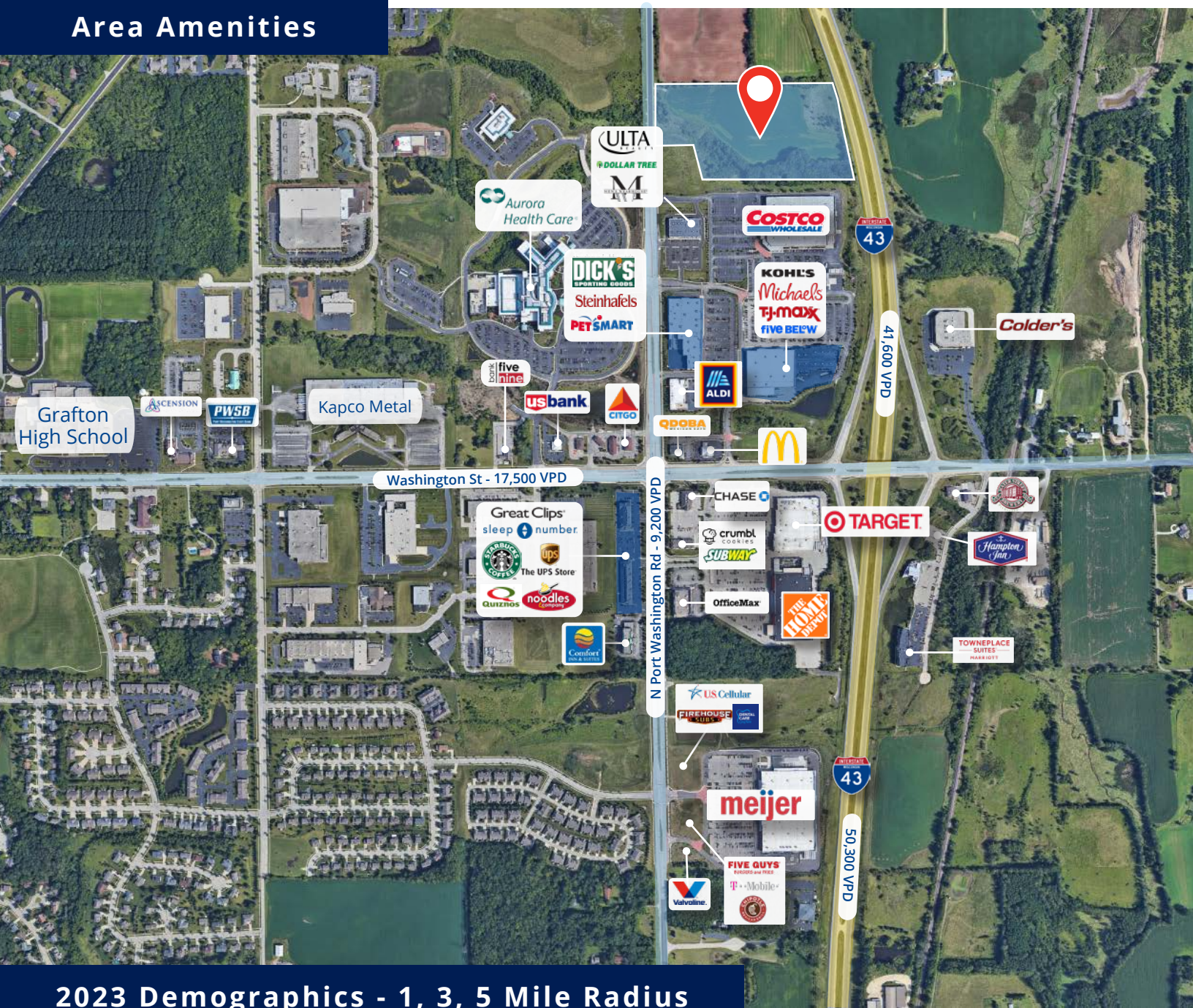

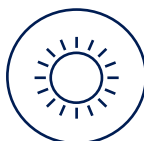


2023 Demographics - 1, 3, 5 Mile Radius

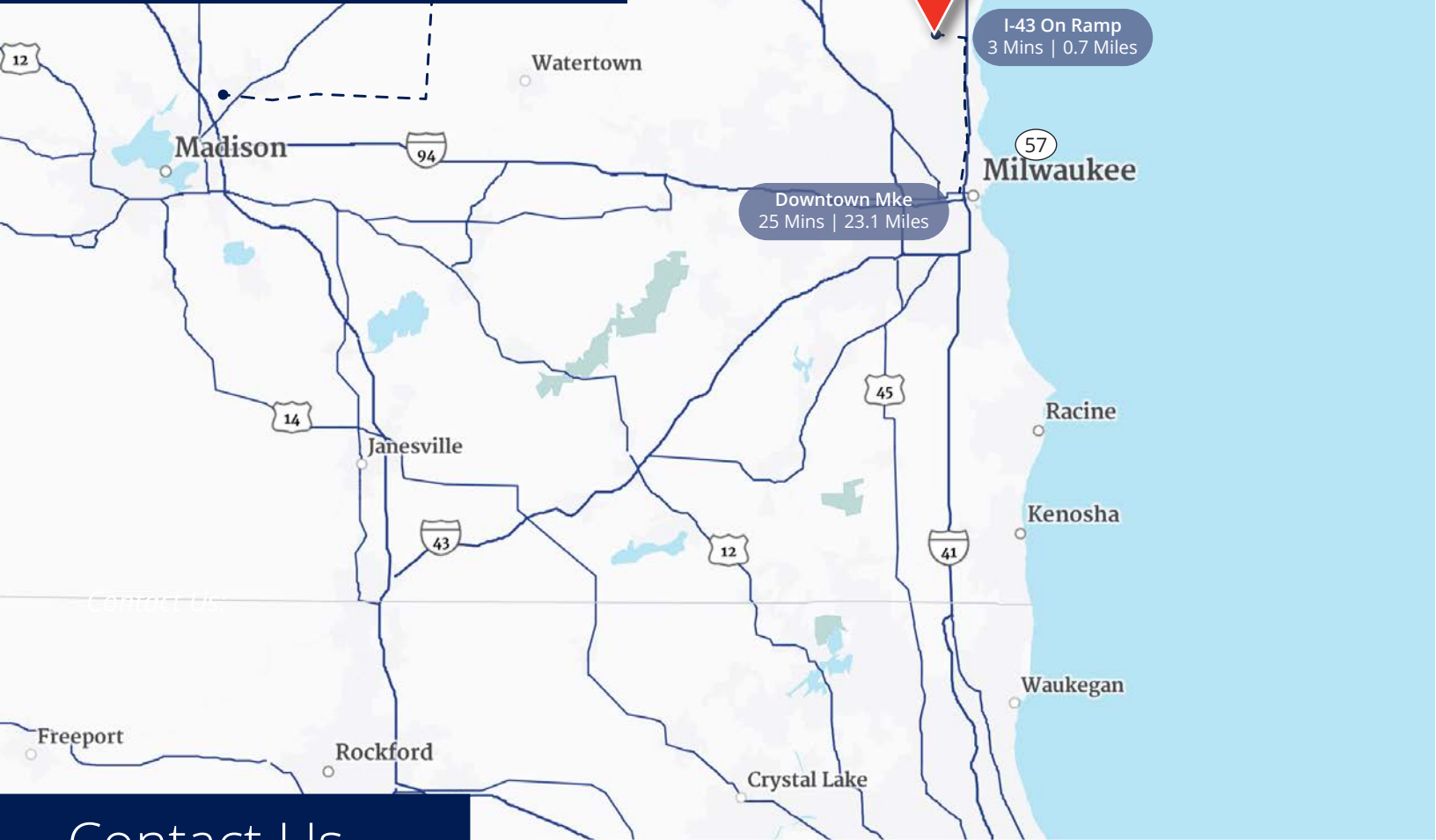
Drive Times from N Port Washington Rd & I-43

State Of Wisconsin | Disclosure to Non-Residential Customers

Prior to negotiating on your behalf the Brokerage firm, or an agent associated with the firm, must provide you the following disclosure statement:

Broker Disclosure to Customers
