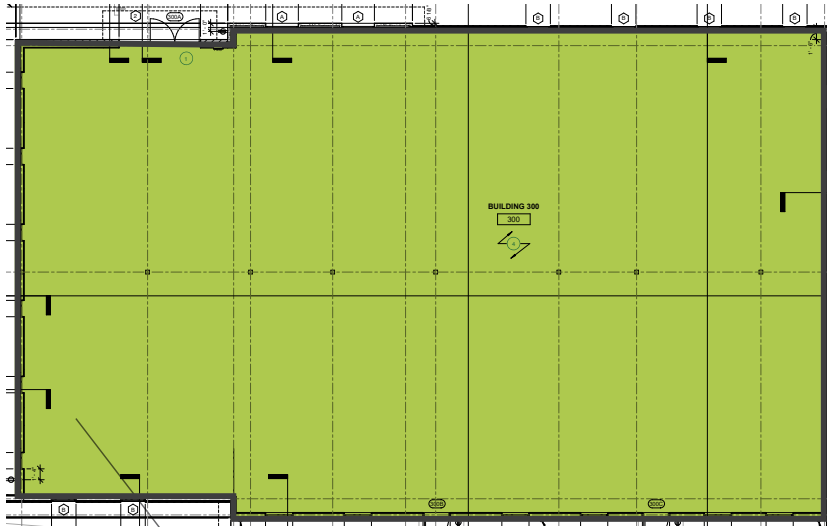

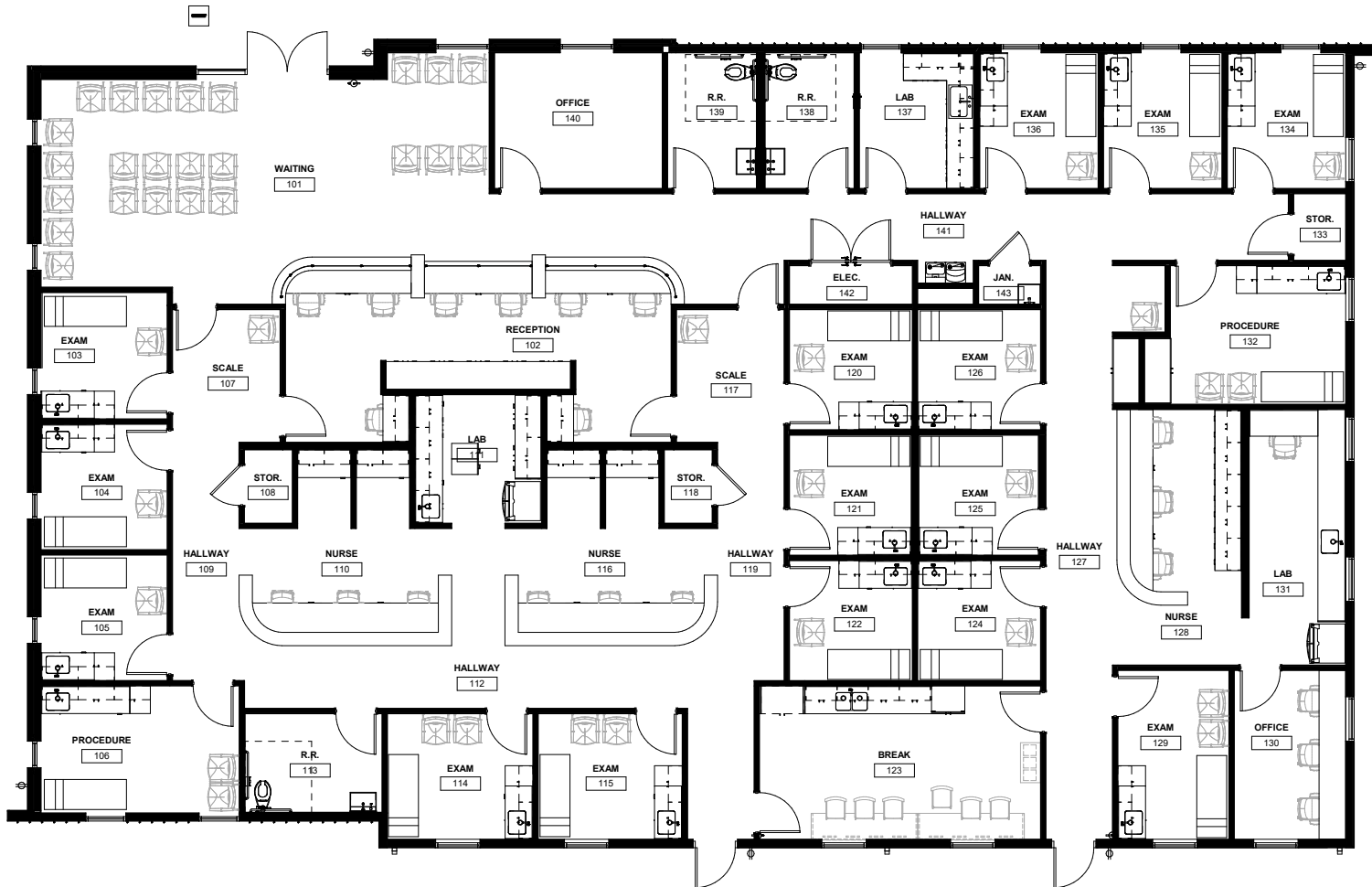

- The roof is a standing seam metal roof with partial waterfall transition to the façade

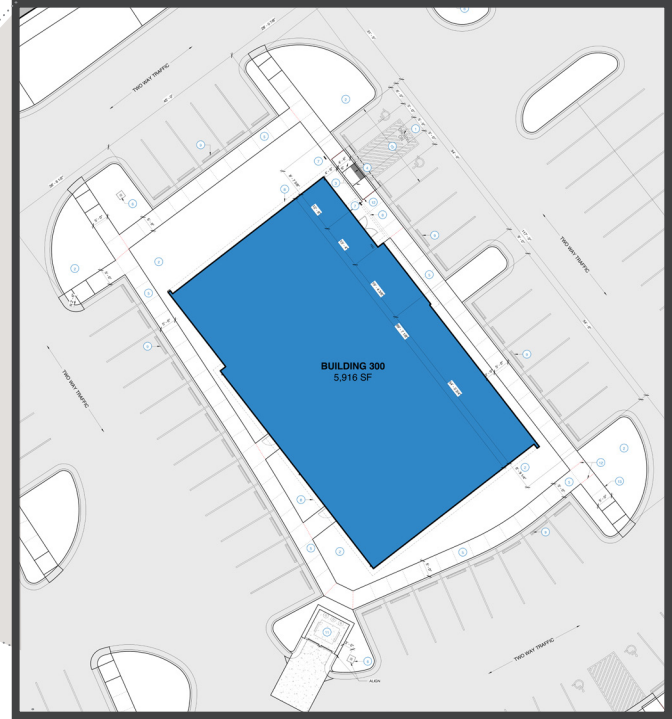




CONCEPTUAL TEST FIT PLAN
