



FIELD NOTE DESCRIPTION OF THE SURVEY OF A 42.15 ACRE TRACT OF LAND OUT OF A 63.22 ACRE TRACT OF LAND OUT OF THE NE/4 OF SECTION 36, BLOCK 39, T-2-S, T&P RR CO SURVEY, MIDLAND COUNTY, TEXAS, SAID 42.15 ACRE TRACT BEING DESCRIBED MORE FULLY BY METES AND BOUNDS AS FOLLOWS:

BEGINNING AT A 1/2" REINF BAR SET AT THE SOUTHWEST CORNER OF THE NORTHEAST/4 OF SAID SECTION 36 FOR THE SOUTHWEST CORNER OF THIS TRACT;

THENCE NORTH 15°09'24" WEST 1045.83 FEET ALONG THE WEST LINE OF SAID NORTHEAST/4 OF SECTION 36 AND ALONG THE WEST LINE OF SAID 63.22 ACRE TRACT TO A 1/2" REINF BAR FOUND FOR THE NORTHWEST CORNER OF SAID 63.22 ACRE TRACT AND THE NORTHWEST CORNER OF THIS TRACT;

THENCE NORTH 74°48'00" EAST 875.81 FEET ALONG THE NORTH LINE OF SAID 63.22 ACRE TRACT TO A 1/2" REINF BAR SET FOR THE MOST NORTHERLY NORTHEAST CORNER OF THIS TRACT, SAME BEING THE NORTHWEST CORNER OF A 21.07 ACRE TRACT;

THENCE SOUTH 15°09'24" EAST 522.73 FEET TO A 1/2" REINF BAR SET FOR AN INTERIOR CORNER OF THIS TRACT AND THE SOUTHWEST CORNER OF SAID 21.07 ACRE TRACT;

THENCE NORTH 74°48'00" EAST 1757.80 FEET TO A 1/2" REINF BAR SET IN THE WEST RIGHT-OF-WAY LINE OF F. M. 715 FOR THE MOST EASTERLY NORTHEAST CORNER OF THIS TRACT AND FOR THE SOUTHEAST CORNER OF SAID 21.07 ACRE TRACT;

THENCE SOUTH 15°32'21" EAST 522.74 FEET ALONG THE WEST RIGHT-OF-WAY LINE OF SAID F. M. 715 AND ALONG THE EAST LINE OF SAID 63.22 ACRE TRACT TO A 1/2" REINF BAR SET FOR THE SOUTHEAST CORNER OF SAID 63.22 ACRE TRACT AND THE SOUTHEAST CORNER OF THIS TRACT;

THENCE SOUTH 74°47'31" WEST 2637.10 FEET ALONG THE SOUTH LINE OF THE NORTHEAST/4 OF SAID SECTION 36 AND ALONG THE SOUTH LINE OF SAID 63.22 ACRE TRACT TO THE PLACE OF BEGINNING.
