



Executive Summary

The property also boasts an excellent location near The Design District, Wynwood, Edgewater, and immediate access to major transportation arteries and public transportation.
















Property Layout

Existing Second Level Floor Plan: 2,151 SF




Existing First Level Floor Plan: 2,786 SF








Context Map
