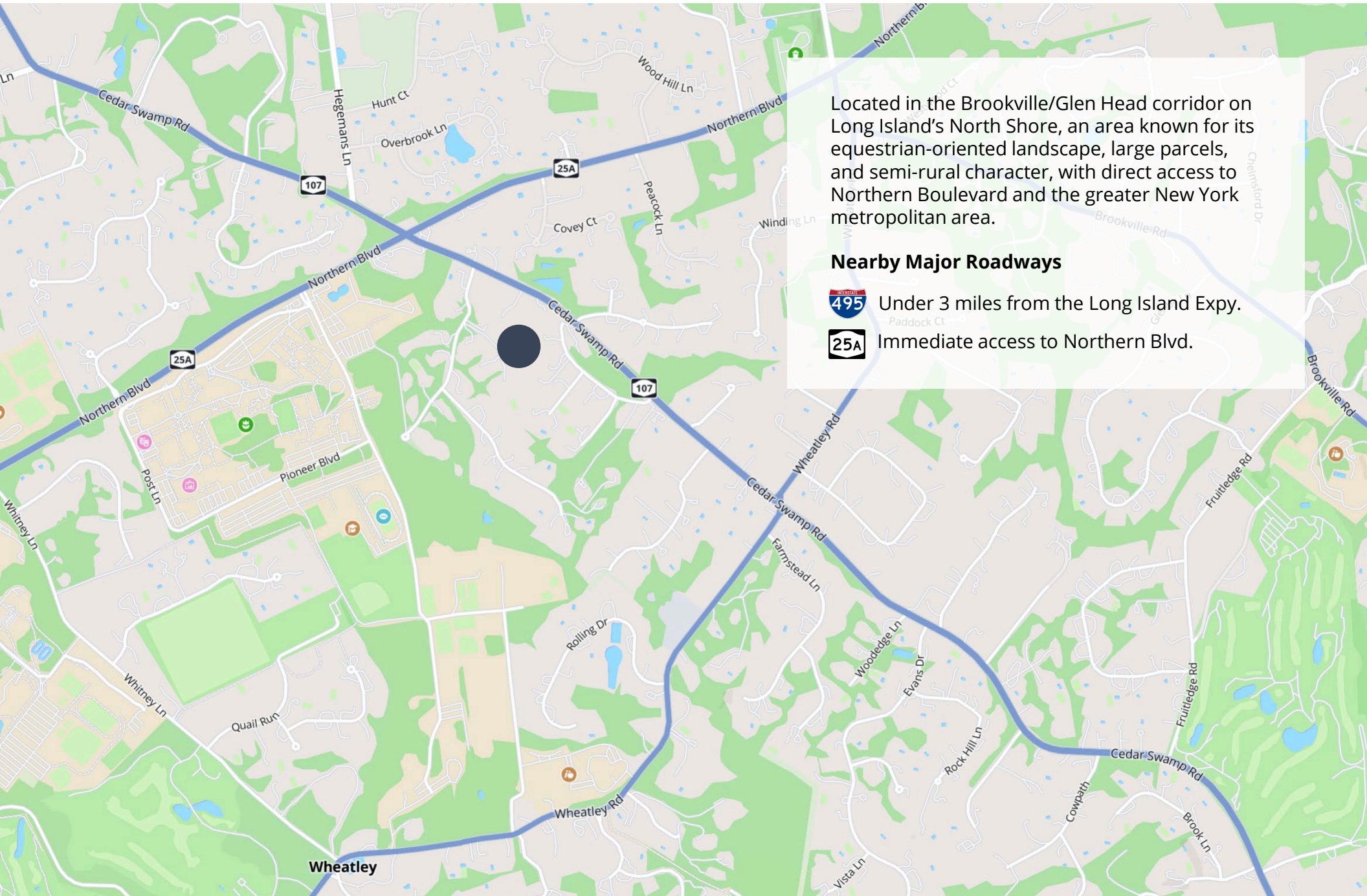
Property Map
