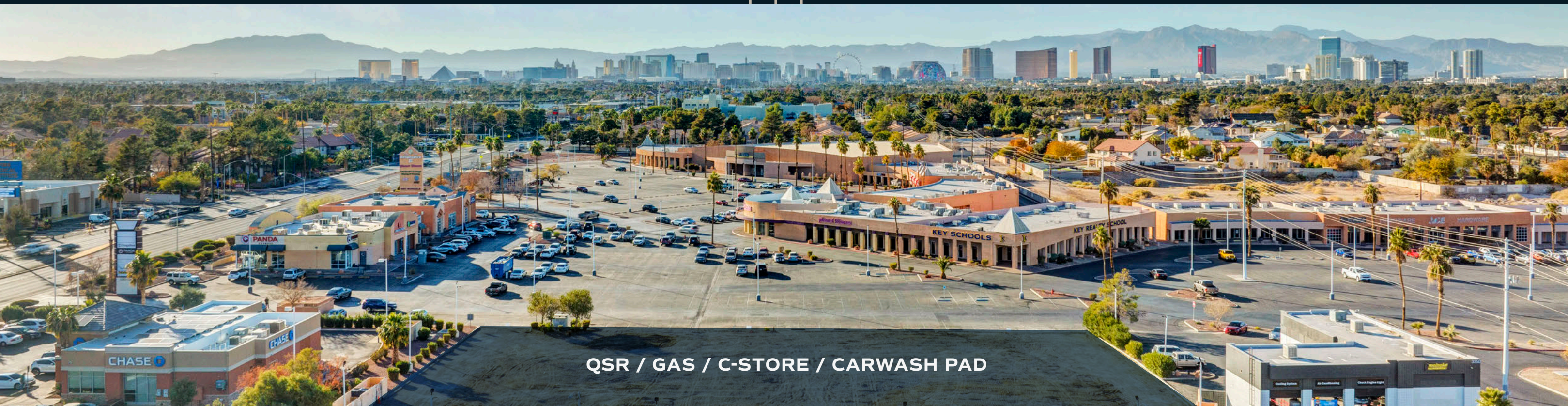

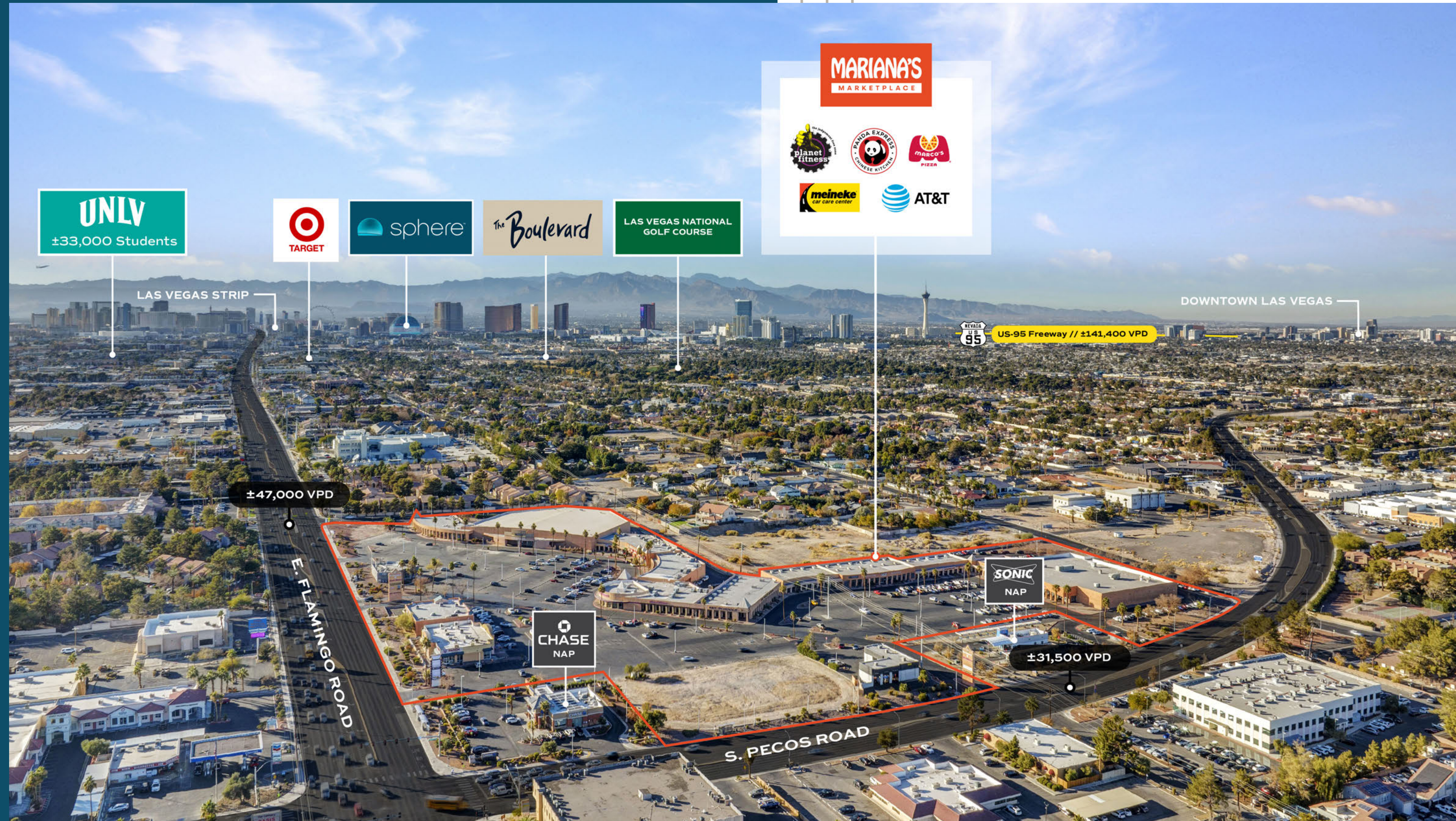
TRADE AREA MAP
