**AREA DESCRIPTION**

The subject property is located just 30 miles north of Peoria, along Illinois Route 91 (South 7th Street), the primary commercial corridor through Wyoming, Illinois. This property benefits from excellent visibility and convenient access for both local residents and regional travelers. Wyoming, a Stark County community of approximately 1,500 residents with a median household income around \$57,000, serves as a retail and service hub for surrounding rural towns within the Peoria regional trade area. The site is surrounded by complementary uses including Casey's General Store, Shell, Dollar General, and local dining and service businesses, drawing consistent daily traffic from commuters and residents alike. Its position along a major route connecting Peoria and north-central Illinois communities provides a stable customer base and support for retail and essential service operations.


