

THE ORTEGA MINE "OLD DOMINION"

- Located on the property itself, the
 Ortega Mine opened for operation in
 1942.
- The ore body spanned approximately 300 feet in length and 8 feet in thickness, set in granite host rock.

• Mined minerals included galena, sphalerite, and silver.

 Production includes 100 tons of ore shipped to Midvale, Utah in 1942 that assayed 0.02 ounces per ton gold, 25.8 ounces per ton silver, 0.3 percent copper, 3.5 percent lead, and 3.1 percent zinc (Tucker and Sampson 1943c).

 Situated within the Los Angeles Ranges of the Pacific Mountain System, contributing to its unique geomorphology. <u>More on the mine here</u>
