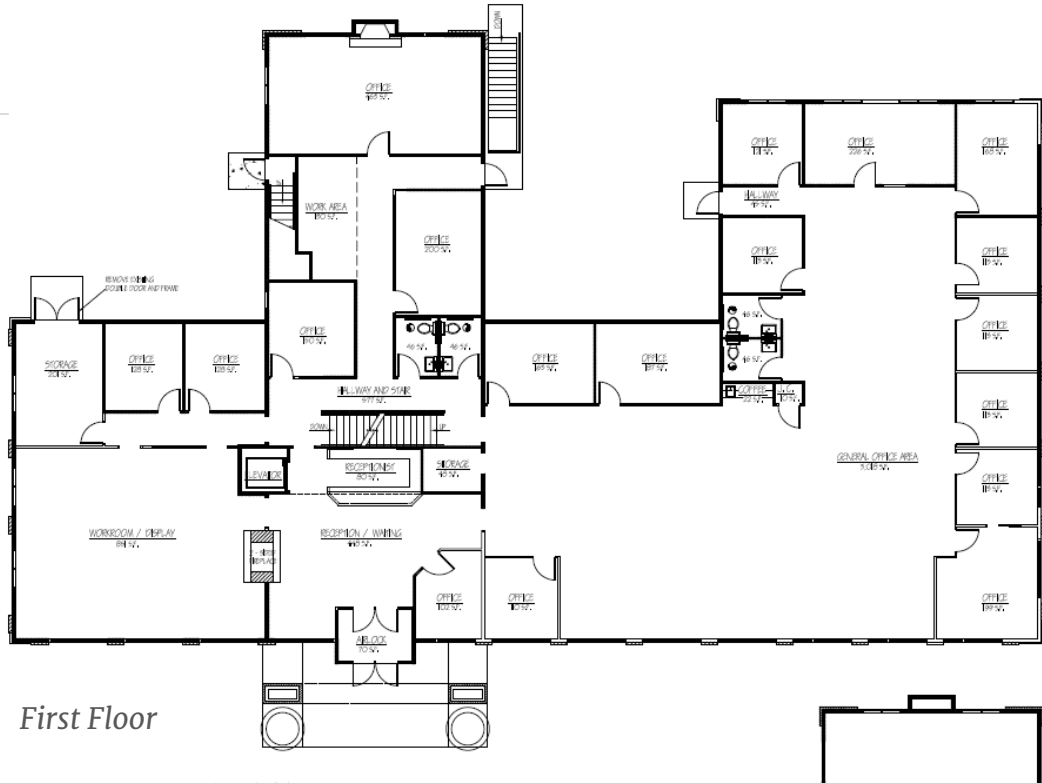

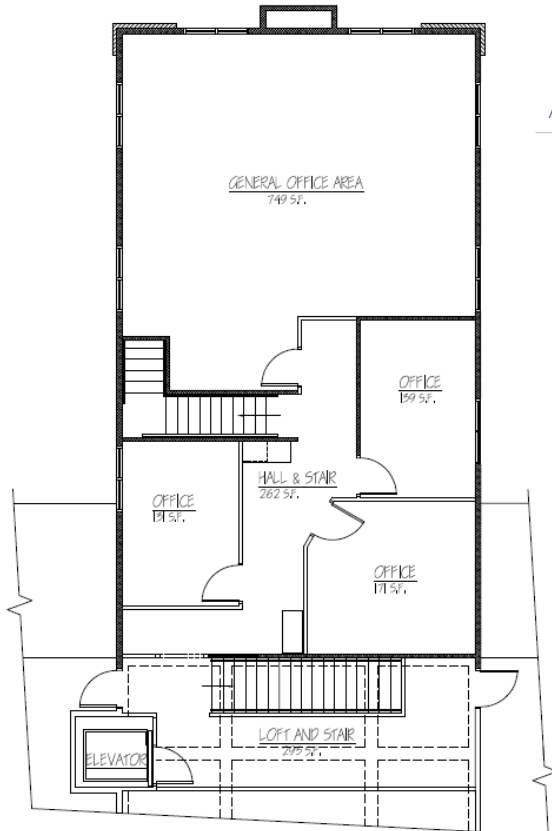
Floor Plans

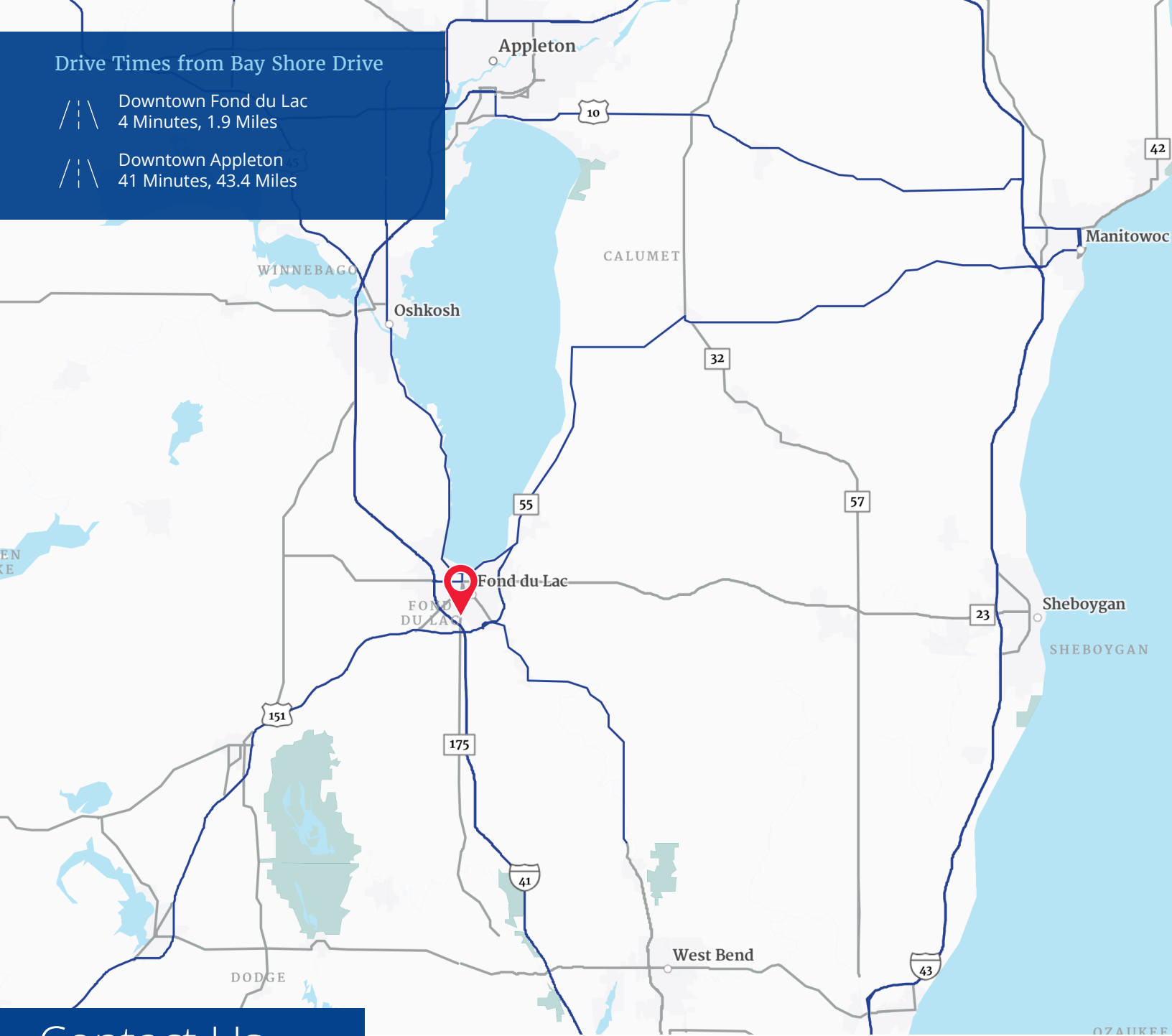
